Communication by the Secretary General of the Parliamentary Assembly at the 1508<sup>th</sup> meeting of the Ministers' Deputies<sup>1</sup> (25 September 2024)

# I. <u>Main developments between the Assembly's June 2024 part-session and the October 2024 part-session</u>

## A. Assembly's response to the Russian Federation's war of aggression against Ukraine

On 2 July, the Secretary General of the Parliamentary Assembly participated in the opening the third high-level dialogue with Ukrainian partners in Strasbourg on the theme "Good democratic governance in Ukraine: achievements, challenges and the way forward in the post-war period". She emphasised the significance of decisions taken during the PACE June 2024 part-session, which confirmed the Assembly's support for Ukraine. She highlighted the Assembly's debate on establishing a special tribunal to address the crime of aggression and violations of international law by the Russian Federation; the discussion on tightening sanctions against Russia and closing loopholes for evading them; and the condemnation of Russia's efforts to erase Ukrainian cultural identity. The SGPA further drew attention to the creation of a new parliamentary network on the situation of the children of Ukraine. The President of the PACE and the First Vice-Chairman of the Verkhovna Rada Oleksandr Korniyenko met the day before. The ongoing co-operation established between the Verkhovna Rada of Ukraine and the Council of Europe was positively assessed, including the notable results achieved in the framework of the projects "Strengthening relations and co-operation between the Ukrainian Parliament and the Parliamentary Assembly" and "Supporting democratic post-war elections in Ukraine". The President stressed the Assembly's commitment to ensuring that the Verkhovna Rada fully exercises its constitutional powers and parliamentary scrutiny to preserve and ensure the good functioning of democratic institutions, the rule of law, and the protection of human rights.

On 1 August, the President of PACE made a <u>statement</u> on the release of Vladimir Kara-Murza and other political prisoners: "It is with great joy that I welcome, on behalf of the Assembly, the liberation of our friend Vladimir Kara-Murza as well as the other political prisoners who have reached safety today, after being detained unlawfully for expressing their opposition to the Russian Federation's war of aggression against Ukraine, and for their actions in support of democracy, human rights and the rule of law in the Russian Federation. [...] While sharing the relief of the families of the political prisoners who have been freed today, the Assembly continues to stand in solidarity with the families of the political prisoners who remain unlawfully detained in the Russian Federation and Belarus. The Assembly will continue to support, through concrete actions, Russian democratic forces who share the Council of Europe's values and who demand the end of the aggression against Ukraine and a democratic future for Russia."

On 4 September, PACE President Theodoros Rousopoulos has reacted in a <u>statement</u> to recent missile strikes in Ukraine, and again urged the speedy creation of a special tribunal to try Russia's political and military leadership for the crime of aggression. Referring to the Ministers of Justice of the Council of Europe members States meeting on the next day in Vilnius to discuss the issue of accountability for international crimes committed in Ukraine, the President strongly urged them "to step up efforts aimed at the creation of a special tribunal for the crime of aggression, to hold to account the leadership of the Russian Federation for what has been rightly called the 'crime of crimes': starting a war, which brings unspeakable suffering and misery to soldiers and civilians alike. The Parliamentary Assembly of the Council of Europe has been crystal clear on this subject. A special tribunal, created by an agreement between the Council of Europe and Ukraine and supported by an enlarged partial agreement open to non-member states and other international organisations, is now the best and most feasible option, in terms of legal basis and political legitimacy, for trying Russia's political and military leadership for the crime of aggression." He hoped for the Vilnius Conference to give a strong impetus to the Committee of Ministers to move quickly on setting up the necessary legal framework for this key body.

#### B. Follow-up to the Reykjavik Summit

On 4 July, the President of PACE spoke at the opening of the High-Level Conference on the European Social Charter in Vilnius. He stated that defending social rights required a significant leap at both national and European levels, "and more solidarity and collective effort", in order to preserve social peace and democratic stability across the continent. He further stressed the importance of completing ratification of the Turin Protocol. The conference, organised under the auspices of the Presidency of Lithuania to the Committee of Ministers, in the framework of the follow-up to the Fourth Summit of the Council of Europe, brought together Ministers and senior officials competent in the field of social rights and social policy, representatives of Council of Europe entities, as well as representatives from the European Commission, the Fundamental Rights Agency, the ILO, the UN, and from civil society.

PACE President <u>welcomed</u> on 5 September the opening for signature of the new Council of Europe Framework Convention on Artificial Intelligence and Human Rights, Democracy and the Rule of Law, which he hailed as "a major step forward" and a springboard for ongoing discussion about the ramifications of AI in all our lives. "We must be ready to use this powerful and exciting technology for the good of society, in full awareness of the possible risks, and maintaining always human control over what humans have created," the President said, recalling that AI had been one of the priority areas for his Presidency.

  - Requests for debates under urgent procedure: took note of the requests tabled by the leaders of the political groups to hold debates on:
    - Deteriorating situation of human rights, Rule of Law and democracy in Azerbaijan;
    - Missing persons due to the war of aggression of the Russian Federation against Ukraine: prisoners of war and civilians in captivity;
  - o Draft agenda: updated the draft agenda of the part-session (Appendix 1);
- References and transmissions to committees: approved the references and transmissions as set out in Appendix 2, subject to ratification by the Assembly through the Progress report;

#### – Election observation:

- o Republic of Moldova: Presidential election and Constitutional Referendum (20 October 2024): approved the updated list of members of the ad hoc committee to observe these elections (Appendix 3);
- Georgia: Parliamentary elections (26 October 2024): approved the updated list of members of the ad hoc committee to observe these elections (Appendix 4);
- Bulgaria: Early parliamentary elections (27 October 2024): decided to observe these elections and to set up an ad hoc committee composed of 20 members (SOC: 6; EPP/CD: 6; EC/DA:4; ALDE:3; UEL: 1) as well as the co-rapporteurs of the monitoring committee; given the very short timeframe since the last early parliamentary elections of 9 June 2024, decided to maintain the same list of members and the same Chairperson of the ad hoc committee, Mr Oleksii Goncharenko (Ukraine, EC/DA), while filling the previously vacant seats (Appendix 5);
- o Uzbekistan: Parliamentary elections (27 October 2024): decided not to observe these elections;
- Modalities of participation of a representative delegation of Belarusian democratic forces in the work of the Assembly: heard a presentation by the Director of Committees Democracy and Rule of Law, Sonia Sirtori; took note of the memorandum prepared by the Secretary General of the Assembly and approved the proposals for the implementation of paragraph 12.3 of Resolution 2530 (2024), subject to ratification by the Assembly through the Progress report (Appendix 6);
- Follow-up to the Reykjavík Summit: heard a presentation by the Director of Committees Human Dignity and Sustainable Development, Louise Barton, and took note of the information provided;
- Meetings of the Standing Committee and the Bureau in 2025: approved the proposals contained in the memorandum prepared by the Secretariat (Appendix 7);
- Václav Havel Human Rights Prize: took note of the shortlist made by the Selection Panel at its meeting in Prague on 27 August 2024, consisting of (in alphabetical order): Akif Gurbanov (Azerbaijan), María Corina Machado (Venezuela) and Babutsa Pataraia (Georgia);

Meeting in Prague, on 27 August 2024, the selection panel of the Václav Havel Human Rights Prize, which rewards outstanding civil society action in defence of human rights in Europe and beyond, <u>announced</u> the shortlist for the 2024 Award. In alphabetical order:

The overall winner of the 2024 Prize is due to be announced at the opening of PACE's Autumn plenary session in Strasbourg on 30 September.

## Appendix 6 - Modalities of participation of a representative delegation of Belarusian democratic forces in the work of the Assembly

#### Proposals for the implementation of paragraph 12.3 of Resolution 2530 (2024)

With a view to implementing paragraph 12.3 of Resolution 2530 (2024) on *A democratic future for Belarus*, it is proposed that the Bureau decide to invite the Belarusian democratic forces to designate a delegation to participate in the work of the Assembly and its bodies, according to the modalities and conditions set out below:

- the delegation of the Belarusian democratic forces shall be composed of 3 representatives and 3 substitutes to be designated by the Coordination Council amongst its members;
- the delegation shall be composed to ensure a fair representation of the political parties, groups or factions within the Coordination Council<sup>2</sup> and to include at least the same percentage of the under-represented sex as is present in the Coordination Council;
- the Coordination Council shall transmit to the President of the Assembly no less than one week before the
  opening of the session the list of the members of its delegation, appointed for the duration of the entire session.
  The list should be submitted to the Bureau for approval and subject to ratification by the Assembly through
  the Progress report;
- as a transitional measure for 2024, following elections held in May 2024, the Coordination Council shall transmit the list of members of its delegation to the President of the Assembly no less than one week before the opening of the first part-session of the Assembly following the Bureau decision as ratified by the Assembly through its Progress report;
- following future elections to the Coordination Council, appointments to the Assembly shall be made within six months of the election. The existing delegation shall expire at the opening of the first sitting of the Assembly or meeting of the Standing Committee following the appointment of the new delegation by the Coordination Council or following the expiry of the six months' period after the election date;
- members of the delegation shall have the right to participate in the work of committees (including sub-committees and ad hoc sub-committees) and networks during part-sessions, with the exception of the Committee on the Honouring of Obligations and Commitments by Member States of the Council of Europe (Monitoring Committee), the Committee on Rules of Procedure, Immunities and Institutional Affairs, and the Committee on the Election of Judges to the European Court of Human Rights;
- members of the delegation participating in the above-mentioned meetings may speak if authorised by the chairperson. They shall not have the right to vote;
- secretaries of the delegation may attend the meetings of committees of the Assembly, except those of the Monitoring Committee, the Committee on Rules of Procedure, Immunities and Institutional Affairs, and the Committee on the Election of Judges to the European Court of Human Rights;
- members of the delegation of Belarusian democratic forces may participate in the work of political groups according to the conditions established by the groups;
- the Bureau shall take stock of the implementation of this decision in one year time, or before should it be considered necessary. This may include modalities for the presence of the representative delegation of Belarusian democratic forces in the Assembly chamber.
