Long-term effects of the Covid-19 Pandemic on Equality, Racism and Intolerance

Tuesday, 29 September 2020, 11.30 – 12.30

This exchange of views focuses on the long-term effects of the pandemic on equality, racism and intolerance.

The Covid-19 pandemic has immediately had many adverse effects on the different groups which are of concern to ECRI and national Equality Bodies. ECRI, Equinet and national Equality Bodies have all contributed in various ways to deal with this immediate impact of the pandemic and to protect vulnerable people during the lockdown phase.

Experts foresee that the pandemic will unfortunately also have long-term effects on different groups and in various fields. The unfolding economic crisis will for example have a negative impact on the employment among vulnerable groups. Shrinking public budgets and prolonged social distancing could hinder them to access public services. Children from vulnerable groups could continue to face challenges in accessing school due to a lack of digital devices and Wifi, if distance learning is to be put in place again or continued.
