THE 4<sup>TH</sup> DIMENSION CONCERNS LEARNERS' WELL-BEING, WHICH IS ESSENTIAL FOR THEIR HOLISTIC DEVELOPMENT, ACADEMIC SUCCESS AND LONG-TERM PERSPECTIVE

#### Renewing the Democratic & Civic Mission of Education

Europe faces significant challenges that threaten its **DEMOCRATIC CULTURE** including democratic backsliding, discrimination, radicalisation and intolerance.

The recent crises on the European continent have exacerbated some of the existing shortcomings of education systems.

To respond to these challenges, education must, among other things, revitalise its civic mission by preparing all citizens to become active participants in a democratic society.



### PILLAR 1 AIMS TO

#### Democracy and Citizenship Education

Put democracy at the heart of education systems by enhancing citizenship education, fostering democratic and intercultural competences, and encouraging dialogue and cooperation based on shared democratic values across Europe.

#### Learner Rights & Engagement

Support initiatives that enable learners' democratic participation in formal and nonformal settings, safeguarding students' rights, including equitable access to education, privacy, and freedom of expression, thereby fostering active citizenship and critical thinking.

#### Inclusive and Sustainable Education

Prioritise areas like **Vocational Education and Training** (VET) and sustainable development, ensuring education promotes inclusivity, sustainable practices, and **effective partnerships across all levels**.

#### Educational Integrity and Competence Development

**Enhance educators' skills** in promoting participation, inclusion, and sustainable development through ethical, transparent, and plurilingual approaches, while upholding **academic freedom** and integrity within educational institutions.



Enhancing the Social Responsibility & Responsiveness of Education

### The active role of the learner as a **SOCIAL ACTOR** helps to make education policies, curricula and methodologies more inclusive.

Enhancing the **social responsibility and responsiveness of education** can be achieved by ensuring that educational institutions are not only responsive to the changing needs of society, but also resilient in times of crisis.

Embracing **participatory governance of** education, resilience and responsiveness to future emergencies and inclusion should be essential throughout the education system and at all levels of education.

Increased participation of vulnerable and disadvantaged learners in education (especially higher education) and the successful completion of their education promotes social cohesion and strengthens democratic societies where the principles of human rights and the rule of law prevail.

The provision of **inclusive**, **lifelong and highquality language learning** supports not only educational and professional success, but also personal development and self-esteem, which in turn contribute to a democratic, socially cohesive and peaceful Europe.

The Council of Europe's Education Strategy supports academic mobility, the fair recognition of academic qualifications and **the digitalisation of student data and qualifications**.



Empowering learners as active social contributors transforms education into a more inclusive, responsive, and resilient system, fostering a democratic, cohesive, and peaceful Europe.

### PILLAR 2 AIN/IS TO

Inclusion Equity Diversity

A

Enhance the social dimension of education by promoting inclusion, equity, and diversity across all education levels. Implement whole-school policies that value diversity, support marginalised learners, and facilitate language learning. **Develop curricula that foster** learner autonomy and place emphasis on confidence building, intercultural competences, and scientific inquiry skills.

#### 2 **Ethics**

Integrity

Ensure equal access to education for all learners, emphasising ethics, transparency, and integrity as foundational to quality education and its assurance. Build a **culture** of trust and accountability among education stakeholders, while providing academic and psychological support to learners, especially during emergencies and crises.



#### Transparency

#### Internationalisation Global Engagement

Support teacher training for inclusive education, enhancing their ability to **work with diverse** student populations. Strengthen language support for vulnerable groups, including migrants and refugees, and promote the internationalisation of schools and higher education institutions, focusing on diversity, equity, and inclusion, reinforcing the **European Higher Education** Area's (EHEA) principles.



#### Advancing Education through a Human Rights-based Digital Transformation

To harness the potential of digital technology, it is imperative that the digital transformation of education be guided by a human rights-based approach, which is essential for creating inclusive, equitable, and empowering learning environments. Digital transformation, largely supported by Artificial Intelligence (AI), has dramatically changed the educational landscape in recent years by the **integration of digital technologies and practices** to enhance teaching and learning processes, widen access to educational resources, promote digital literacy, and foster innovative approaches that improve educational outcomes and prepare learners for the digital age.

The strategy aims at supports the member States in reforms related to rethinking pedagogical approaches, redesigning learning environments, **developing digital literacy among educators and students**, and ensuring participatory governance of education systems.

### PILLAR 3 AIV/IS TO

#### **Digital Literacy & Access**

Strengthen digital citizenship education as an ongoing journey to navigate digital advancements. Ensure all learners have **equal access to digital tools and technologies** in educational settings and are equipped with relevant digital skills. Emphasize the importance of **digital citizenship education**, **democracy**, and the rule of law, fostering learners' autonomy and holistic development.

#### **Responsible Innovation & Tech Ethics**

Promote ongoing **professional development for educators** to integrate emerging digital technologies, including AI, responsibly in teaching. Encourage the **development and use of digital educational resources through European cooperation**, enhancing transparency, and accountability in education systems to prevent fraud and uphold quality standards.



#### **Partnerships & Standards**

Foster partnerships between educational institutions, the private tech sector, and civil society that adhere to national and international standards. These collaborations should aim to **innovate** while ensuring equitable **quality education**, leveraging digital technologies to benefit all learners.
