Considered a highly effective investigative technique, providing **"invaluable information that illuminates the secretive nature of criminal activities, especially organised crime,"** and is viewed as a **"paramount (instrument) in collecting evidence which can be presented at the judicial stage."** However, it is rarely employed as a "stand-alone" technique (*EC study, Part III, p. 234-5, 245*).

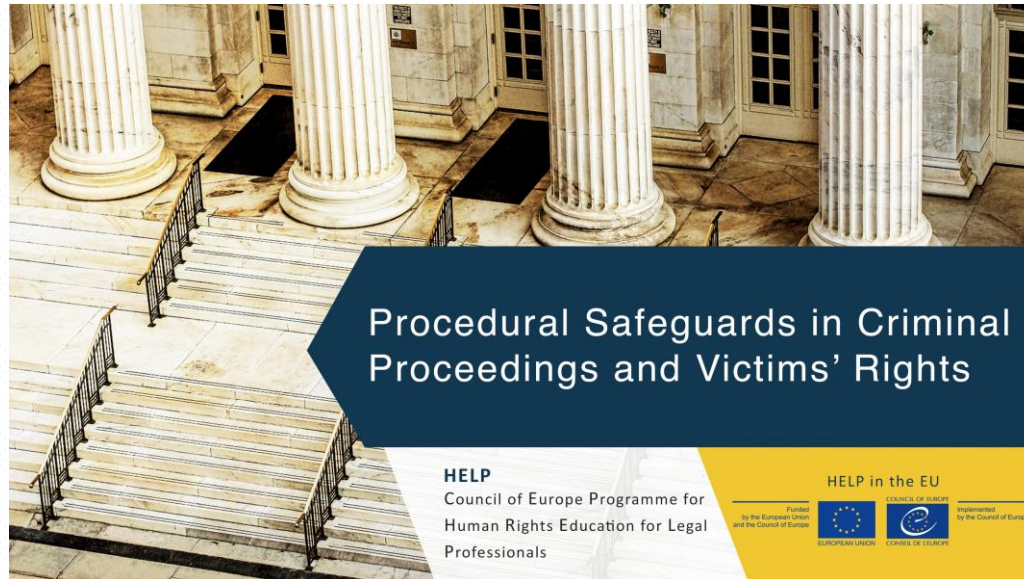
