OPENING OF THE CONFERENCE



Mr Benedikt BOGASON

President of the Supreme Court of Iceland

Mr. BOGASON took up appointment as a Supreme Court judge on 1st October 2012 and was elected President of the Court on 1st September 2020. Prior to his appointment he served as a District Court judge from 2001 and as chief judge of the District Court of Western Iceland from 2003. Before that, he served as Director General in the Ministry of Justice.

He has a Cand. Jur. degree in Law from the University of Iceland. As well as sitting on the Supreme Court he also holds the position of Professor of Law at the University.

Furthermore, he has written books and articles especially on the general principles of Icelandic law of obligations.



Ms Marialena TSIRLI

Registrar of the European Court of Human Rights

Born on 20 October 1967 in Thessaloniki, Greece.

Ms Marialena TSIRLI studied law at the National and Kapodistrian University of Athens in 1989.

She continued with a Master's degree in law at Robert Schuman University of Strasbourg in 1991 and a Doctorate in Law in 1994. She was a legal officer at the Secretariat of the former European Commission of Human Rights between 1994 and 1998.

Ms TSIRLI joined the European Court of Human Rights as a legal officer in 1998 and became Head of Division four years later. She became Deputy Section Registrar in 2010 and got promoted to Section Registrar from 2016 to 2019.

Deputy Registrar of the European Court of Human Rights from 1 July 2019 to 30 November 2020, she is now Registrar of the European Court of Human Rights since 1st December 2020.



Mr Christophe POIREL

Director of Human Rights, Directorate General Human Rights and Rule of Law (DGI), Council of Europe

"Director of Human Rights" of the Council of Europe since July 2018. Mr Christophe POIREL is responsible for the departments in charge of supervising the execution of judgments of the European Court of Human Rights, social rights and the implementation of the European Social Charter, intergovernmental co-operation in the fields of human rights and Bioethics as well as Council of Europe's activities concerning the independence and functioning of judicial systems.

He previously served as Deputy Secretary of the Committee of Ministers of the Council of Europe between 2010 and 2018, with particular responsibility for political and human rights issues, having held various positions in the human rights field since 1989.

NATIONAL IMPLEMENTATION OF THE ECHR PRIOR TO, AND INDEPENDENTLY OF THE PROCESSING OF CASES BY THE COURT



Dr Hans-Jörg BEHRENS

Chairperson of the Drafting Group on issues relating to judges of the European Court of Human Rights (DH-SYSC-JC); Head of Unit IVC1 (Human Rights), Government Agent before the European Court of Human Rights, Federal Ministry of Justice, Germany

Mr Hans-Joerg BEHRENS was born on 22 October 1962, in Braunschweig, Germany.

He is married and father of 2 children.

He studied law in Marburg and Göttingen and passed his first State examination in 1987.

With a LL.M. obtained in 1989 at King's College London and a legal doctorate (Dr. iur.) obtained in 1991at Göttingen, Mr BEHRENS passed his second State examination in 1991.

He entered the Federal Ministry of Justice in August 1991 and got seconded to Lord Chancellor's Department in London in 1994 for 6 months.

Member of German Team for the creation of the International Criminal Court, including Rome Conference (Member of Drafting Committee) between 1996 and 1999, he has seconded to the German Parliament from 1999 to 2001.

Head of Cabinet and Parliament Liaison Office, Federal Ministry of Justice from 2001 to 2005, he became afterwards the Deputy Commissioner for Human Rights and Co-Agent before the ECHR in 2005 and then Head of Human Rights Office and Agent before the ECHR in 2010.

He has been representing Germany in several Council of Europe bodies for the past years:

Mr Stefano PIEDIMONTE BODINI

Head of the Private Office of the President, European Court of Human Rights

Former student of the ENA (Promotion Valmy), graduated in law in France (University of Strasbourg) and in the United States (Columbia University), Stefano Piedimonte Bodini spent 14 years in the Registry of the Court, where he held various positions: legal officer in the Research Division; Head of Press Unit; head of a division responsible for processing requests; Head of the Research Division, Deputy Jurisconsult of the Court. At the same time, he represented the Registry of the Court, as an expert on terrorism issues, during training activities organised in particular by the anti-terrorism branch of UNODC and the HELP program of the Council of Europe. Europe. From June 2017 to April 2018, while maintaining his role as Head of the Research Division of the Registry of the Court, he was seconded as Legal Adviser to the Independent Investigation Group into allegations of corruption within the Parliamentary Assembly of the Council of Europe (IBAC-GIAC). Furthermore, he served for almost five years in the Secretariat of the European Social Charter (2000-2005) and two years in the Program and Budget Department of the Council of Europe (2010-2012) as Head of Division. Outside the Council of Europe, Stefano Piedimonte Bodini has worked in an American business law firm in Paris and as managing director of an investment fund in New York. Mr Liparit DRMEYAN


Head of the Office of the Representative of Armenia on International Legal Matters

Ms Sandrine ZIENTARA-LOGEAY


President of Chamber, Director of the Documentation, Studies and Reports Department, Court of Cassation of France

NATIONAL IMPLEMENTATION OF THE ECHR AFTER THE COURT'S JUDGMENTS



Dr Alain CHABLAIS

Chairperson of the Committee of experts on the system of the European Convention on Human Rights (DH-SYSC); Federal Department of Justice and Police FDJP, Federal Office of Justice FOJ, Agent of the Swiss Government before the European Court of Human Rights

Alain CHABLAIS, born in 1969, obtained his PhD in Law at the Law Faculty of the University of Fribourg (Switzerland) in 1996. Since 2018, he works as an Agent for the Swiss Government before the European Court of Human Rights. As such, he is supervising the enforcement of the judgements in Swiss cases. From 2013 to 2018, he has been active in the Directorate for International Public Law, within the Federal Department of Foreign Affairs. In 2008, he has been elected as a judge of the Federal Administrative Court which he has left in 2012. Prior to that, he worked for over 10 years at the Secretary General of the Council of Europe in Strasbourg, in the Legal Affairs and Human Rights Directorate.

Head of the Department for the Execution of Judgments of the European Court of Human Rights, DGI, Council of Europe


Clare Ovey studied Law at Newnhan College, Cambridge and qualified as a solicitor. After spells in private practice and at the Law Commission of England and Wales, she started working in the Registry of the European Court of Human Rights in August 1995. In 2015 she moved to the Committee of Ministers Secretariat, with a primary responsibility for the CM's quarterly human rights meetings at which it supervises the implementation of the Court's judgments by respondent States. In 2018, she started working in the Department for the Execution of the Judgments of the Court and has been the Head of Department since July 2020. She has been the co-author of a leading textbook on the Convention system since 2000.

Ms Štefica STAZNIK

Government Agent of Croatia before the European Court of Human Rights

Mrs Štefica Stažnik is a lawyer (Bar Exam in 1992) and a diplomat. Former representative of the Republic of Croatia before the European Court of Human Rights since 2004, she became the First Director of the Judicial Academy of the Republic of Croatia (2004-2008) and served as diplomat in Australia, in the USA, New York – United Nations (1996-2004).

Prior to this, she was a Deputy State Attorney from 1993 to 1996. She is now President of the Croatia's Expert Council for the Execution of Judgements and Decisions of the European Court of Human Rights since 2012.



She is also a member of the Steering Committee of the CoE Project: "Promotion of rule of law and fundamental rights through high quality on-line trainings", currently being implemented in Croatia.

Besides, she is also a lecturer at various seminars, scientific discussions related to international law, especially EU law, on various topics related to human rights issues within the UN, the OSCE and the CoE framework, as well as on the national agenda (at the Judicial Academy, Police Academy, State School for Public Administration, Law Faculties in Zagreb, Rijeka, Split) and is the author of articles and textbooks on various human rights issues and co-author of the textbook: "ECtHR case law on guardianship and deprivation of legal capacity".



Ms Kateřina RADOVÁ

Senior Ministerial Counsellor at the Office of the Government Agent of the Czech Republic before the European Court of Human Rights

Kateřina RADOVÁ is a senior legal officer at the Government Agent's Office in the Czech Republic which she joined in 2018.

Apart from litigation before the Court, she focuses on the execution of judgments. Besides others, she oversees the execution of the Grand Chamber D.H. and other cases regarding the discrimination of Roma pupils, within which she has helped to set up a special working body consisting of Government officials as well as the members of civil society.

She is the creator and organizer of an international conference on national implementation of the Court's case-law and human rights obligations in general that will take place in November 2023 and aims to introduce to the national audience the different actors in the implementation process, their different roles and challenges they face.
