## WORK PLAN PROPOSAL AND WORKING METHODS 2025-2026

#### Last update 17 April 2025

#### Summary and issues for consideration

This document was prepared and updated by the ENF-VAE secretariat.

The ENF-VAE is invited to examine and approve the revised work plan at its next meeting.

- The main tasks and deliverables of the Committee of experts on the prevention of violence (ENF-VAE), which is a subordinate body of the Steering Committee for the Rights of the Child (CDENF), are set out in its terms of reference (2024-2027), as adopted by the Committee of Ministers.
- 2. Under its terms of Reference, the ENF-VAE is expected to hold 2 meetings of two days each year. In accordance with Article 14 (d) of Appendix 1 to Resolution CM/Res(2021)3 on intergovernmental committees and subordinate bodies, their terms of reference and working methods, time- and cost-efficiency shall be a guiding principle for committee work, and the committee shall prioritise best possible use of digital technologies including for meetings and written consultations.
- 3. In line with Article 14 (c) of Appendix 1 to Resolution CM/Res(2021)3, the ENF-VAE will be supported by consultants, who will provide necessary background research and support in the drafting process, as appropriate.
- 4. This workplan will be regularly updated by the Secretariat in line with the terms of Reference and any relevant decision taken by the Committee of Ministers, as well as the progress of the work and any other relevant decisions and developments.

For the years 2024-2027, the ENF-VAE is instructed to complete the following deliverables, within the indicated deadlines:

- **Deliverable 1**: Feasibility study on age-appropriate comprehensive sexuality education to strengthen responses for inter alia preventing and combatting violence against children, including sexual violence and harmful or risky behaviour (31/12/2024) **completed**
- Deliverable 2: Implementation review report on Recommendation CM/Rec(2009)10 on Council
  of Europe policy guidelines on integrated national strategies for the protection of children from
  violence (31/12/2024) completed
- **Deliverable 3**: Draft non-binding instrument on age-appropriate comprehensive sexuality education to strengthen responses for inter alia preventing and combatting violence against children (31/12/2026)
- **Deliverable 4:** Guidance on the prevention of sexual violence and harmful or risky behaviour by children (31/12/2027)
