### **Agenda item 1: Opening of the meeting**

1. The fourth meeting of the Committee of experts on the prevention of violence (ENF-VAE, hereafter the Committee) was opened by the ENF-VAE Chair, Mária VARGOVA (Slovakia), who welcomed all participants.
2. The Committee was then greeted by Anne KAYSER, Secretary to the Committee, who thanked colleagues for their support in the preparation of the meeting and looked forward to the work ahead.

### **Agenda item 2: Adoption of the agenda and order of business**

3. The Committee adopted the agenda as it appears in Appendix I.

### **Agenda item 3: Statement by the Chair and the Secretariat**

4. The Committee took note of the information provided by the Secretariat on the state of implementation of the Strategy for the Rights of the Child (2022-2027, including relevant action of the Steering Committee for the Rights of the Child ([CDENF](#)).
5. It also took note of the information provided by the Secretariat on the state of implementation of its [Terms of Reference](#) as well as its [revised workplan](#).

### **Agenda item 4: Implementation review report on Recommendation CM/Rec(2009)10 on Council of Europe policy guidelines on integrated national strategies for the protection of children from violence**

6. Dr Susanna Greijer, consultant, presented the first draft of the implementation review report of the Recommendation. The Committee took note of the presentation.
7. The Committee examined the draft report in view of providing guidance for its finalisation. It took note of the comments provided by the Observers and Participants. Among others, the following was pointed out:
  - The analysis based on the replies of the member states shows that, in **most of the areas** covered by the policy guidelines on integrated national strategies for the protection of children from violence, the **implementation benchmark set at 80% was exceeded**, which is commended. In some circumstances (such as the existence of a legal framework for protection of children against violence) an achievement of 100% of the member states should be the target.
  - Some of the strengths identified in the report, such as **awareness raising campaigns** carried out in 100% of the responding states, cannot curb weaknesses leading to **underreporting cases of violence**.
  - Issues related to **how** reporting is being done, the need to develop **helplines** and to **empower** children as actors and not passive subjects in reporting cases were raised.
  - Part of the response could also be found in the **methodology and the focus of the campaigns**, as well as in the **adequacy of trainings**, including trauma informed trainings of social workers and at university level.
  - **Safeguarding policies** should be made mandatory wherever children are present, and Council of Europe guidance would be welcomed on this issue.
  - Language towards the need to promote a **full ban against corporal punishment**, both in law and in practice, should be reinforced in the conclusions of the report, and action should be taken to follow-up with the Council of Europe member states that haven't banned corporal punishment.
  - While the analysis shows that 73% of the states enforced laws that include **age-appropriate comprehensive sexuality education** in the school curricula, its importance to prevent

violence against children was underlined and the need to voice clear recommendations for member states to adopt such curricula was underlined.

- **Collection of disaggregated data** and the development of better systems to process systematically organized data, including within the Council of Europe, needs to be strengthened.
8. The Committee instructed the consultant and the Secretariat to revise the draft report in light of the discussion and comments of the Committee and agreed to share the revised draft with the ENF-VAE Committee before sharing it with CDENF in view of its possible adoption during its 10th plenary meeting (Strasbourg 3-5 December 2024).
  9. The Committee also took note the presentation of the report on **Progress and delay in achieving universal prohibition and elimination of corporal punishment in Council of Europe member states** by Sonia Vohito from *End Corporal Punishment* and invited her to regularly update this report. The Committee exchanged on the situation highlighted in the report and on possible actions to support universal prohibition of corporal punishment. Among those actions, the opportunity to update existing awareness-raising materials or for the CDENF to consider holding an exchange or tour de table on the issue were suggested. To this end, the Committee agreed to share the report with the CDENF.

## **Agenda item 5: Age-appropriate comprehensive sexuality education to strengthen responses for - inter alia - preventing and combating violence, including risky or harmful sexual behaviour by children**

### **5.1 Guidance Note on Safeguarding children from the risks of accessing online pornographic content**

10. The Committee took note of the presentation made by Maree Crabbe, consultant to the ENF-VAE, of the progress on drafting a Guidance note on Safeguarding children from the risks of accessing online pornographic content.
11. The Committee welcomed CDENF's decision to address this important topic. It expressed satisfaction on the structure and content of the preliminary version of the draft Guidance Note, to be shared with the CDENF for discussion during its 10th plenary meeting (Strasbourg 3-5 December 2024).
12. The Committee also agreed to take the elements of this Guidance Note into account when drafting the Recommendation on Age-appropriate comprehensive sexuality education and working on the Guidance on Harmful sexual behaviour.

### **5.2 Recommendation on Age-appropriate comprehensive sexuality education to strengthen responses for - inter alia - preventing and combating violence, including risky or harmful sexual behaviour by children**

13. The Committee took note of the presentation made by Meghan Campbell, consultant to the ENF-VAE, on the preliminary elements of a draft Recommendation on Age-appropriate comprehensive sexuality education.
14. It held an exchange on the preliminary elements of a draft Recommendation on Age-appropriate comprehensive sexuality education and took note of the comments provided by the Observers and Participants of ENF-VAE;
15. Among others, the following was pointed out:
  - The **title** of the recommendation should take into account the sensitivity of the subject. Several options using different combinations will be considered.
  - The recommendation should include elements about how to wrap up the **messaging around comprehensive sexuality education**.

- Where **sensitive terms** have been previously defined in Council of Europe work, draw from these definitions.
- Spotlight provisions should include **digital safety** and technological issues.
- The language around **gender equality** should be streamlined, being mindful of the sensitivities in different member states.
- Make clear that comprehensive sexuality education is provided in **formal, informal and non-formal contexts** and that all those who provide such education should have adequate training.

16. The Committee instructed the consultant and the Secretariat to pursue the drafting of a Recommendation on age-appropriate comprehensive sexuality education in light of the discussion and comments of the group. If ready, a first draft of the Recommendation could be shared with the ENF-VAE and the CDENF in view of comments prior to the 10th CDENF plenary meeting (Strasbourg, 3-5 December 2024).

### **5.3 Child consultations on comprehensive sexuality education**

17. The Committee took note of the presentation by Elina Stenvall, consultant, on the progress made to carry out child consultations on comprehensive sexuality education.

18. The Committee was informed on the state of play of the child consultations and shared ideas on the different groups of children that can be consulted.

19. During the discussion, among others, the following was pointed out:

- It is useful to seek children's views on **how** they should be taught, by **whom, where, when** and on **what** they want to know about comprehensive sexuality education.
- The consultation should include larger themes such as **digital safety**.
- Children could be given **orientations** or examples to be able to choose between different options on how they should be taught.
- It is essential to give **feedback** to children and acknowledge that their views are taken into account.
- Having a strong **safeguarding** policy is essential: children have to feel that there is a safe environment and need to have access to psychological support in case of need.

20. The Committee invited the secretariat and the consultant to continue its work on the issue.

### **Agenda item 6: Prevention of sexual violence and harmful or risky behaviour by children**

21. The Committee took note of the presentation of the consultant, shared views on the updated study and agreed on its publication.

22. The Committee was invited to reflect on the next steps to prepare a Guidance on the prevention of sexual violence and harmful or risky behaviour by children, which is the last ENF-VAE deliverable due in 2027.

### **Agenda item 7: State of play of the preparation of the mid-term review of the Strategy for the Rights of the Child**

23. The Committee took note of the presentation of the secretariat on the advancement of the organisation of the mid-term review and shared views on how to feed-in the session regarding prevention of violence against children.

### **Agenda item 8: Update on key developments and other events by members, participants and observers**

24. The Committee took note of the update of key activities related to its mandate as shared by its members:

- Finland has started to reflect on highly contentious divorce cases, particularly to protect children from violence. A study on the matter will be published next year. Furthermore, the national strategy on violence against children – a rather ambitious action plan – will come to an end in 2025 but a new eight-years plan is currently in preparation. This will include a further implementation of the Lanzarote Convention and Barnahus projects.
- In Austria, new elections are coming at the end of September 2024, making it difficult to discuss future projects on children's rights. However, a [campaign](#) for the protection of children in all forms was launched, featuring images of children created by AI (April 2024). The children involved in the campaign provided feedback, and it was well received.
- In Iceland, a new law focuses on the "integration" of services in the best interest of the child's well-being. The aim is to anticipate and reduce the number of child protection cases and it is currently in its third year of implementation. In addition, cooperation after divorce is being promoted through online courses for parents undergoing divorce proceedings, with very positive results.
- In Hungary, development regarding children's rights have been updated. Moreover, the Red Cross has produced a report, highlighting the importance of Barnahus. Stage 5 of Barnahus is currently being implemented, and the government is planning to open a 6th center.
- In Slovakia, all funds for human rights NGOs have been frozen, but there are some positive developments. For example, minimum quality standards for helplines have been established, with funding provided to call centers that meet these standards. As well, safer internet centers are being created through the INHOPE network, and Barnahus centers are being developed alongside architectural studies. A national methodology for child adoption is also in the approval process. Additionally, a major campaign is being prepared in collaboration with Bratislava Design University and a popular Slovak NGO to protect children from grooming and cyber violence, providing support for parents.
- Missing Children Europe updated on a conference focusing on online child sexual abuse and manipulation (namely CESAGRAM). This conference will be organized on December 9-10, 2024, with invitations to be sent through the secretariat of the Committee.
- The Lanzarote Committee updated the group on child consultations that were carried out by the Committee in the last monitoring round on [protecting children from sexual exploitation and sexual abuse facilitated by ICTs](#), and that could be linked to the work of ENF-VAE. Moreover, the Lanzarote Committee will share an invitation for a side event on emerging technologies, with the private companies involved, during its Plenary (5-8 November 2024) in Vienna.

#### **Agenda item 9: Any other business**

25. No further issue was raised.

#### **Agenda item 10: Date and place of next meetings**

26. The Committee took note that the next meeting of ENF-VAE would be held, in person, in Strasbourg on 27-28 May 2025.
