Agenda item 1: Opening of the meeting

1. This ad hoc meeting of the Committee of experts on the prevention of violence (ENF-VAE, hereafter the Committee) was opened by the ENF-VAE Chair, Mária Vargova (Slovakia), who welcomed all participants and noted that the focus of the meeting is to agree on a version of the draft Recommendation on “*age-appropriate comprehensive sexuality education to strengthen responses for inter alia preventing and combatting violence against children*”, for the purpose of circulation to the Steering Committee for the Rights of the Child (CDEF) and other selected stakeholders for written consultation.
2. The Committee took note of the update that a call for nominations had been made to fill the position in ENF-VAE that is currently vacant, and the CDEF Bureau would advise the CDEF on the appointment.
3. The Committee was then greeted by Anne Kayser, Secretary to the Committee, who thanked colleagues for their support in the preparation of the meeting and looked forward to the work ahead.
4. The Committee took note of the information provided by the Secretariat on the new online shared space, which aims to facilitate the sharing of and collaboration on documents in a secure online space. The draft Recommendation was uploaded on this shared space allowing members, participants and observers of the ENF-VAE to comment on the draft ahead of the meeting.

Agenda item 2: Adoption of the agenda and order of business

5. The Committee adopted the agenda as it appears in Appendix I.

Agenda item 3: Statement of the Chair and the Secretariat

6. The Committee took note of the information provided by the Secretariat on the Council of Europe activities under the Strategic Objective 1 of the Strategy for the Rights of the Child (2022-2027), in particular the organisation of the mid-term review conference on 3-4 April 2025.
7. It also took note of the information provided by the Secretariat on the progress made in the implementation of its [Terms of Reference](#) and [workplan](#). The Secretariat recalled the work carried out by the Committee in order to provide a basis for the current work on the draft Recommendation on “*age-appropriate comprehensive sexuality education to strengthen responses for inter alia preventing and combatting violence against children*”, namely:
 - the approval of a “Feasibility study on age-appropriate comprehensive sexuality education to strengthen responses for – inter alia – preventing and combating violence, including risky or harmful sexual behaviour by children”: [CDEF\(2024\)08](#);
 - the update of a study on “Sexual violence and harmful sexual behaviour displayed by children: Nature, causes, consequences and responses”: [ENF-VAE\(2024\)05](#); and
 - the contribution to the CDEF guidance note “Safeguarding children from the risks of accessing online pornographic content”, to be finalised before publication.

Agenda item 4: Preliminary draft Recommendation on age-appropriate comprehensive sexuality education to strengthen responses for inter alia preventing and combatting violence against children (deliverable (3) of the terms of reference)

8. Ms Elina Stenvall, consultant, presented the outcomes of the child consultations carried out in relation to the draft Recommendation. The Committee took note of the presentation.
9. Dr Catherine O’Sullivan and Dr Meghan Campbell, consultants, gave a presentation on the preliminary draft Recommendation. The Committee held an exchange on the preliminary draft

Recommendation and took note of the comments provided by the members, observers and participants of ENF-VAE, including those made in writing ahead of the meeting.

10. This preliminary draft was generally supported as a good basis for consultation of stakeholders. The points raised included:
 - In addition to violence against children, the Recommendation should also address more extensively **violence between children** and discuss the differences between **positive and negative relationships**, as well as education on **bonding and affection**;
 - Several participants underlined the need to enhance the references to **child protection**;
 - The importance to provide adequate material to parents as well as to other care-givers was underlined.
 - Participants suggested that the **best interests of the child** and the **right to gain information** should be stressed, for children to have legal means to access sexuality education despite parents' reluctance.
 - On **child participation**, participants underlined that there should be emphasis on the roles of **NGOs** working with children, the provision of adequate **financial resources** and of **safeguarding** of children;
 - Participants suggested including references to relevant **regional and international instruments and resolutions**, either in the Recommendation or in the Explanatory Memorandum.
 - The appropriateness of the title was discussed, with one Delegation suggesting replacing it with "**sexual health and relationships education**". This delegation also underlined that there should be a focus on the family having primary responsibility for providing sexual education;
11. The Committee instructed the consultants and the Secretariat to review the preliminary draft Recommendation in the light of the discussion and comments of the Committee, with a view to circulating the draft for stakeholder consultations. The Chair invited participants to send their written comments to the Secretariat by Thursday, 13 February 2025. The Secretariat noted that this is the first round of comments and there would be future opportunities to further examine the draft.
12. The Committee also took note of the draft list of stakeholders to be consulted on the draft Recommendation, which had been uploaded to the online shared space. The Committee was invited to provide the Secretariat with names and contact details of relevant partners to be added to this list.

Agenda item 9: Any other business

13. No further issue was raised.

Agenda item 10: Date and place of next meetings

14. The Committee took note that the next meetings of ENF-VAE would be held, in person, in Strasbourg on 4-5 June 2025 and 7-8 October 2025.

Agenda item 11: Adoption of the meeting report

15. The meeting report was circulated shortly after the meeting and approved by all members via written procedure.
