Decisions (adopted by written procedure on 31 October 2020)

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), composed of the representatives to the Committee of Ministers of the member states of the Agreement,¹

- 1. approved the Scale of Contributions for 2021 and, consequently, adopted Resolution EPAS/Res (2020)02 as it appears in **Appendix I** to this document;
- 2. approved the adjusted Budget of the Enlarged Agreement for 2021, and consequently adopted Resolution EPAS/Res(2020)03 as it appears in **Appendix II** to this document.

Resolution EPAS/Res(2020)03 concerning the Enlarged Partial Agreement on Sport Adjusted Budget 2021

(Adopted by the Statutory Committee by written procedure on 31 October 2020)

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS)³, composed of the representatives on the Committee of Ministers of the member states of the agreement.

Having regard to Resolution CM/Res(2007)8 of 11 May 2007 authorising the establishment of the Enlarged Partial Agreement on Sport;

Having regard to Articles 19, 21 et 28 of the Financial Regulations;

Having taken note of the changes in EPAS membership in 2020 compared to 2019;

Having regard to the Secretary General's proposal set out in document CM(2020)130,

Resolves as follows:

- 1. The budget of expenditure and the budget of receipts for 2021, totalling €1 078 500 in accordance with Table A annexed to this Resolution is approved.
- 2. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport, of the contributions for 2021 in accordance with Table B annexed to this Resolution.
- 3. The total of the budget of receipts shall be a function of actual receipts. The budget of expenditure and receipts will be adjusted accordingly in the course of the financial year.
- 4. took note that decisions related to salary adjustment will be approved on the basis of a general decision taken by the Committee of Ministers in the framework of the Ordinary budget.
