My Procedure	The European Qualifications Passport for Refugees is issued to refugees who claim to have completed or partially completed
	studies at the level of upper secondary school and above, including qualifications for which there is insufficient or missing documentation. The aim is to help applicants continue further studies, improve their language proficiency, apply for formal recognition
