#### Context

The implementation of deliberative processes paves the way towards more collaborative governance and stronger commitments of local authorities to open government principles. In the current context of multiple crisis, innovating democracy is key to go beyond polarisation, especially in multicultural societies, so that citizens engagement and trust in democracy is enhanced.

The use of deliberative democracy as valuable complements to the representative democracy was recognised in the latest Congress Report (2022) "Beyond elections: The use of deliberative methods in European municipalities and regions". Following up on the successful first Citizens' Assembly in the city of Mostar, and the unanimous adoption of citizens' recommendations by the Mostar City Council, this European Conference on Deliberative Democracy, which is organised in a hybrid format, is aimed at further promoting these approaches in the country and across Europe.

The Conference seeks to identify the main challenges of deliberative democracy as well as to present good practices in different European contexts. The discussions will delve into some topical issues around these types of innovative processes, including their follow up, their institutionalisation, their potential to empower underrepresented groups, or their use as valuable tools to complement other participatory initiatives. A wide range of local authorities, policymakers and researchers from across Europe will participate in the peer exchange, aiming to capitalise on the good practices and recommendations presented in order to enhance the replication and multiplication of deliberative processes in Bosnia and Herzegovina and in South-East Europe.

This conference is organised in the framework of the project "Innovating democratic participation at local level in Bosnia and Herzegovina". The project is implemented by the Congress of Local and Regional Authorities within the Council of Europe Action Plan for Bosnia and Herzegovina 2022-2025. The project aims to enhance the quality of local democracy and create opportunities for citizens to engage in innovative participatory processes in Mostar and elsewhere in Bosnia and Herzegovina. It promotes new democratic approaches, open government, public ethics, transparent and inclusive local policy making in the country.
