Committee of the Parties to the Council of Europe Convention on the protection of children against sexual exploitation and sexual abuse

Evaluation of the follow-up given by Parties to the 5 "urge" recommendations of the Special Report on "Protecting children affected by the refugee crisis from sexual exploitation and sexual abuse"

Adopted by the Lanzarote Committee on 6 June 2019

Introduction

- 1. In March 2016 the Council of Europe's Secretary General called for a series of <u>priority</u> actions to protect children affected by the refugee crisis¹.
- 2. The Lanzarote Committee decided in June 2016, in light of the high number of migrant and asylum-seeking children who arrived and continue to arrive in Europe and being aware that many may be or become victims of sexual exploitation and sexual abuse, to carry out an urgent monitoring round to map the ways in which the risks of sexual exploitation and sexual abuse of children arising in the context of the refugee crisis are being dealt with.
- 3. The Special Report on "protecting children affected by the refugee crisis from sexual exploitation and sexual abuse" was adopted by the Committee in March 2017. It assesses the replies received, in particular in order to examine whether and to what extent Parties to the Lanzarote Convention² apply their existing overall protection framework and measures against sexual exploitation and sexual abuse to children affected by the refugee crisis. It also takes stock of the introduction of specific measures to address the situation of these children and analyses them. The report highlights both the major challenges identified as well as promising practices to tackle such challenges. It also puts forward Committee's recommendations as to specific steps that might be taken to warrant an effective protection of children affected by the refugee crisis from sexual exploitation and sexual abuse and suggests priority areas for targeted cooperation, bilateral and multilateral, to fully guarantee the protection of the human dignity, the safety, and the physical and psychological integrity of these child. When the Lanzarote Committee assesses that legislation or policies are not in compliance with the Convention, or when it finds that despite the existence of legal provisions and other measures, the implementation of a key obligation of the Convention is lacking, the Lanzarote Committee urges Parties to take specific actions. The Special Report includes the following 5 "urge" recommendations addressed to all State Parties:
 - to effectively screen, all persons, in line with Article 5 of the Convention, who by their professions have regular contact with children affected by the refugee crisis for convictions of acts of sexual exploitation or sexual abuse of children in line with their internal law (R18);
 - to take the necessary measures to avoid risks that the child may be abused or exploited in case of family reunification (R27);

Today 44 out of the 47 Council of Europe Member States have ratified the Convention. The three Council of Europe Member States that have not ratified the Convention are Armenia, Azerbaijan and Ireland. In Estonia, Norway and United Kingdom the Convention entered into force after the launch of the urgent monitoring round and subsequently there was neither reporting obligation applied to these countries nor a request on follow up measures to the Lanzarote Committee's recommendations.

- to ensure that child victims of sexual exploitation and sexual abuse affected by the refugee crisis may benefit from therapeutic assistance, notably emergency psychological care (R29);
- to encourage the co-ordination and collaboration of the different actors who intervene
 for and with children affected by the refugee crisis to ensure that appropriate support
 may be provided immediately after the disclosure of sexual exploitation and sexual
 abuse (R30);
- to make use within the context of the refugee crisis of the specific cooperation tools already available in the framework of Europol/Interpol which are specifically aimed at identifying victims of sexual exploitation and sexual abuse (R33).
- 4. To follow up on this report and its recommendations, in 2018, the Committee requested all State Parties to provide information on the follow-up given to the 5 urge recommendations. To allow the Lanzarote Committee to properly map and assess progress made and evaluate compliance, State Parties were also asked to submit information to describe measures taken to fulfil all the other recommendations contained in the Special Report.
- 5. At its 22nd meeting (7-9 November 2018), the Lanzarote Committee took note of the analysis of the information submitted by Parties to outline the follow-up given to the 5 "urge" recommendations (document T-ES(2018)26). It acknowledged that only a few Parties had taken measures after the adoption of its special report and agreed that all Parties should send to the Secretariat information to demonstrate that the 5 "urge" recommendations are complied with so that a decision may be taken during its 23rd meeting (5-7 March 2019) on the way forward with respect to the Parties still not complying with these recommendations.
- 6. The revised analyses of the information submitted by Parties on the follow-up given to each of the 5 "urge" recommendations (documents T-ES(2019)03-07) demonstrated that many Parties were still not in compliance with one or more of these recommendations, mainly due to lack of information. The Lanzarote Committee, therefore, decided at its 23rd meeting (5-7 March 2019) that:
 - By 22 March 2019 at the latest, Parties may add/clarify the information submitted with respect to the situations with which they are considered not in compliance;
 - On the basis of the above analyses and additional information submitted, the Chairperson will send an individualised letter to each of these Parties, highlighting the reasons for their non-compliance and asking them to send any additional clarification to the Secretariat (lanzarote.committee@coe.int) by 5 April 2019.
- 7. The current document reviews the situation for each of the Parties concerned in order to examine whether and what steps are taken by them to follow-up each of the 5 "urge" recommendations. A general table first sets out the situation for each party vis-à-vis each recommendation. Then, five tables (one per recommendation) lists Parties which are in conformity with the requirements of the recommendation and those which are not, with a short explanation on the reasons why.

8. As decided during its 23rd meeting (5-7 March 2019), the Lanzarote Committee is supposed to take a final decision on each of these Parties during its 24th meeting (4-6 June 2019) and to make this public.
