Dear Ms Siino,

We do not have any immediate changes to the content of our Complaint, but we would like to provide important information regarding the progress of the court case regarding the cancellation of the status of the «Osokorky Meadows» landscape reserve.

The court case against the Kyiv City Council regarding the cancellation of the status of the «Osokorky Meadows» landscape reserve was initiated by the developer Kontaktbudservis LLC.

To preserve the «Osokorky Meadows» landscape reserve, the Ministry of Environmental Protection and Natural Resources of Ukraine and the Specialized Environmental Prosecutor's Office of the Prosecutor General joined the court case.

In their legal position, the Ministry of Environmental Protection and Natural Resources of Ukraine and the Specialized Environmental Prosecutor's Office of the Prosecutor General absolutely support the preservation of the landscape reserve.

Since the beginning of last year, 12 meetings have been held, the next one will be held on February 2. All meetings were preparatory, and the case has not yet been considered on its merits. The plaintiff Kontaktbudservis LLC is delaying the consideration of the case in every possible way.

At the end of last year, another restructuring of ministries took place in Ukraine. The Ministry of Environmental Protection and Natural Resources of Ukraine was disbanded, and the Ministry of Environmental Economy and Agriculture of Ukraine was established in its place. Due to this transformation and the accompanying personnel changes, the newly created

ministry will most likely not have time to provide a response to the Complaint by January 31.
As far as we know, the response may be provided within the next month.
