# Bern Convention - Complaint No. 2021/07 - Serbia-lithium mine in the Jadar Valley Second report - August 2023

Thank you for the opportunity to contribute with our Report on the status of the Jadar lithium mine project in Serbia.

Please find below our joint report for the September sitting of the Bureau:

## **Earth Thrive Report:**

For this Report, on our part, we would like to submit only one point and document that we have come into possession of recently:

In the Government's first Report to the Standing Committee, they quoted a File with the Reference Number **353-02-1167/2021-03**.

# The File under that reference number refers to one of the environmental impact assessments related to the activities in the Jadar valley and the proposed mine - namely, the very important Decision on the annulment of the Decision on determining the scope and content of the EIA and is therefore rather pertinent to this case and our Complaint.

When a law firm 'Sreten Djordjevic' requested to see the said File under the Information of Public Importance Act, they were told by the Ministry for the Protection of the Environment that such a File "was never received [by the Ministry], hence it does not exist and it was impossible to access it."

We attach the translation of the first page of this Communication from the Ministry for the Protection of Environment to Mr Djordjevic's law firm where we have highlighted the said statement.

In the Communication the Ministry quotes all the available documents related to the Case, and indeed lists the same allegedly non-existing reference number 6 times under the points 95, 96, 97, 101, 110, 115 in the same Communication to Mr Djordjevic's firm!

We attach the translation of the above points for your ease of reference.

We also attach the entire Communication for your reference - in Serbian language. It would be important to clarify this inconsistency on the part of the Ministry, as the Ministry did quote it no less than 6 times in the same Communication where they had first denied the receipt and existence of the same said File. If we are to take their first statement as true - and the Ministry has never received the File under the above reference **353-02-1167/2021-03**, then they told untruth in their Progress Report sent to the Bern Convention Standing Committee dated 18 January 2023?

If, however, they **are** in possession of the said File and did not share it with the parties requesting an insight, this would be a breach of the Information of Public Importance Act.

To highlight the importance of this, the said reference number, as in the Government report states in the Progress Report refers to: "Decision of the Ministry of Environmental Protection (No. 353-02-1167/2021 of 14 February 2022), suspending the procedure initiated at the request of Rio Sava Exploration d.o.o. from Belgrade pertaining to determining the scope and content of the Environmental Impact Assessment Study for the project referring to the underground exploitation of lithium and boron deposits in Jadar, ore beneficiation plant and disposal of tailings generated by the mining activities..."

This inclarity surrounding one of the key procedures adds to mounting concerns about whether the project's permits have actually been canceled, the concerns that we already expressed in our previous report. Adding to this is the continued presence of the company in the area and outspoken interest to develop the project, and the adjudication cases filed by the company against the Government's decisions with the Administrative Court, as reported by the Ministry of the Environmental Protection(T-PVS/Files(2023)17), about which there is no further public knowledge to date.

In any case, we would be grateful if the Standing Committee would ask the Serbian government to clarify this, explain their inconsistency and provide an insight into this important File given that they did quote it in their official Report to the Bern Convention Secretariat and Bureau.

#### Zastitimo Jadar i Radjevinu Report to Complaint No. 2021-7, August 2023

Dear Secretariat of the Berne Convention,

We are obliged to share with you with the information on the current state of the "Jadar" project, regarding the report to our Complaint.

Probably the most concerning documents Serbian government is about to adopt is Integrated National Energy and Climate Plan of the Republic of Serbia for the period 2030 with the projections up to 2050<sup>1</sup>. On the page 183<sup>2</sup> of its English version in the table 4.2 is mentioned production of "Lithium/Boron and related products" in the amount of 3 000 000 tons by 2050 starting from 2030. The document does not mention where from the lithium/boron would be obtained but we all know that the only source of these amounts could be "Jadar" project. This is in direct opposition to the government's decision to abolish the project in January of 2021.

All the research permits company had, have expired and all the contracts the company had with the land owners to perform research drills on their land, have expired. Since there is no legal reason to renew the contracts in order to keep the remains of the drills, the company is giving money, donations or voucher to the land owners and to anyone from the territory of municipalities of Loznica and Krupanj who is willing to accept<sup>3</sup>. The company is breaking the law because agriculture, education nor none other activity they are funding is the activity they are registered for. The only activity Rio Tinto is registered for in Serbia is "Exploitation of minerals, production of mineral fertilizers and chemicals". Concerning the obvious corruption (of which the company was accused in the USA this year) the organization Protect Jadar and Radjevina has submit a report to the public prosecutor and the case is ongoing. The problem remains though, since none of the republic inspections we contacted is reacting:

- Tax administration at the Ministry of Finance does not react to our multiple applications and e-mails since the 5<sup>th</sup> of May. Employees in their office in Loznica state that they may not do anything about our demand unless they get the approval from Belgrade.
- The inspection at the Ministry of Education does not react to our demand to perform the inspection since the company offered paid summer internship<sup>4</sup> to the students of all faculties except to the students of Faculty of Mining and Geology, which is the only activity the company is registered for.
- The inspection at the Ministry of Labor does not react as well.

The Ministry of Mining and Energetics refuses to intervene and make the company remove the remains of the research drills and return the land in the previous condition and do what is necessary to recover the soil.

As you can see, once again Serbian institutions remain silent and fail to protect citizens, our rights and simply do their job. In the situation where company pays for advertisement of false information, the local communities feel constantly threatened and live as hostages of propaganda<sup>5</sup>.

The Serbian legal system does not recognise documents as "internal studies" and that is exactly what company promotes in their advertisement: they will represent their own EIA and their own feasibility study etc. But these documents cannot have legal importance since there is a law saying that those studies must be approved by the institutions like the Ministry of Environmental Protection. The company also keeps repeating that they are about to finish the feasibility study which must had been done long before the approving of the Spatial plan back in

2020. They are practically admitting that they had already broken the law without any consequences.

The president of Republic of Serbia, Aleksandar Vučić<sup>6</sup>, keeps regretting the withdrawal of the "Jadar" project offending all of us who opposed the project in his public speeches. Saying that we are "foreign mercenaries" working against the development of Serbia he directly threatens our security and safety.

The company not only continues to promote the project but they are doing it in such manner that it disturbs not only local communities but wider public. The commercials promising new jobs, economic growth and development are everywhere and we, as local communities, do not get the chance to speak the truth publicly since media freedom does not exist in Serbia and current sociopolitical context which all together leads to company that has money to represent "their truth" and mislead the public. Not to mention how much their neocolonial narrative offends us as simple habitants of Serbia disabling us from peaceful enjoyment of our private property and from planning our future.

On the other hand, mountain of Cer that was partly in the abolished Spatial plan, was placed under the protection of the state "as a natural asset of international, national, i.e. exceptional importance and is classified in the I category of protection, as an Area of Exceptional Characteristics" on the 30<sup>th</sup> of June 2023, which is speaking in favor of the Complaint we submitted to the Secretary and is stating once again that "Jadar" project must not be realised and we are asking the Secretary once again to make the decision in favor of all living beings in Jadar and Radjevina.

Rio Tinto does not have the consent of either formal or informal members of the community, and especially not the local population except for few individuals, so we consider that everything it does is not only illegal, that it has gone deep into bribery and corruption but that they are harming our basic human rights preventing us to live peacefully.

Due to all of the above, we are not convinced of the sincerity of the government of Republic of Serbia, that it is committed to its decision to cancel the "Jadar" project, and we are increasingly convinced of the necessity for you, as the competent institution, to end the proceedings on our appeal with your decision, and that as we requested in the appeal. # **REPORT BY PROTECT JADAR AND RADJEVINE / ZAŠTITIMO JADAR I RAĐEVINU**

#### Dear Secretariat of the Berne Convention,

We are obliged to share with you with the information on the current state of the "Jadar" project, regarding the report to our Complaint.

Since our previous communication, the Government of the Republic of Serbia has not been acting like someone who cancelled the "Jadar" project including all the documents related to it. On the contrary, the Government is trying, both directly and indirectly, to revive the "Jadar" project, in a very perfidious way, both through the actions of the Prime Minister and relevant ministers, and the President of the Republic Aleksandar Vucic, and through the public appearances of certain experts<sup>7</sup> connected to the Government or the company.

On several occasions, almost during each address to the nation, the President of the Republic, Aleksandar Vučić, mentions and expresses regret that the "Jadar" project was cancelled. Addressing the public on the national television service from January 4th, 2023<sup>8</sup> President Vučić even promised a referendum on lithium (even though the referendum in Serbia no longer has a census) while speaking about the subject that is already regulated by domestic and international laws, and conventions which the president himself persistently ignores. In this address, as in many others, he insulted the activists and the people who stood for the suspension of the "Jadar" project.

Newly appointed Minister of Mining and Energy, Dubravka Đedović, stated on the November 4th, 2022 that it is necessary to "consider how to use domestic lithium reserves"<sup>9</sup>, and on December 29th, 2022<sup>10</sup> she openly declared that the Government of the Republic of Serbia will decide on lithium, forgetting that the Government of the Republic of Serbia has already made a decision on it on January 20th, 2022 when the "Jadar" project was cancelled by the decree with legal force.

Prime Minister of the Republic of Serbia, Ana Brnabić, during almost every address in the media, makes statements that the "Jadar" project will be reconsidered<sup>11</sup>.

At the regional meeting and conference "Look up"<sup>12</sup> dedicated to the green agenda and the circular economy on December 7th and 8th, 2022 to which our association "Protect Jadar and Radjevina"<sup>13</sup> was invited as a participant, at the opening of the conference, Minister of Environmental Protection Irena Vujović as well as the president of the Serbian Chamber of Commerce, Marko Čadež, stated that lithium is a great opportunity for Serbia.

On December 15th, 2022 Jakob Stausholm, one of the CEOs of Rio Tinto, stated that the company has not given up on the "Jadar" project<sup>14</sup>. In addition, the company advertised for positions in Serbia<sup>15</sup> in January 2023, as did the company Bechtel, also recruiting employees for the "Jadar" project<sup>16</sup>.

The request for the exploitation field that the company requested from the Ministry of Mines and Energy has not yet been approved, but it has not been rejected neither and it still stands as an active request.

The authority given by the Roads of Serbia to the Rio Sava exploration to change the route of the Loznica-Valjevo regional road has not yet been withdrawn.

It is symptomatic that not a single law firm from Serbia, NGO or citizen's association has approached any international institution such as Secretariat of the Bern Convention probably out of fear that projects like "Jadar" could actually be stopped. We get the impression that most NGOs and associations are satisfied with the status quo, that is, that projects like the one mentioned last as long as possible without a real epilogue. So, in Serbia, the high corruption is on the scene, as we mentioned in the last report and the aforementioned actors confirmed by reviving the "Jadar" project. We would like to inform you that in the last three years, since the fight against the "Jadar" project has been going on, not a single domestic institution (judiciary, prosecutor's office, inspections and similar bodies) has responded to any application, lawsuit, or complaint related to the issue submitted so many times by many, including us.

The company Rio Sava Exploration, a subsidiary of Rio Tinto in Serbia, in cooperation with some representatives of the professional public, representatives of the government and some NGOs and associations of the civil sector, is exerting pressure on public opinion, in order to create the impression that everything is over, i.e. that the implementation of the "Jadar" project is inevitable, even though all the arguments are against it. In support of this statement are the job advertisements of the companies Rio Tinto and Bechtel, which clearly advertise that they are hiring employees to work on the "Jadar" project. The company insists on completing the Feasibility Study, which not only is not needed for anything and anyone now because the project has been officially cancelled, but to, as we have already stated, to create false public opinion. An additional question arises concerning the Feasibility study, as to where the study had been before the adoption of the Spatial Plan of the Special Purpose Area for the "Jadar" project and the adoption of other supporting documents, on the basis of which all other documents were approved in the first place, if that study was neither completed nor available to the public. From all of the above it is clear that the study has not been completed even today. From reliable sources close to the association, we learn that both the Feasibility Study and the Environmental Impact Assessment Study have been completed, but that they are not even remotely able to meet the requirements of preserving biodiversity and the environment, and that for these reasons they were never presented to the public.

This constant insistence, which has been going on for a full year since the cancellation of the "Jadar" project, with the media's most often biased reporting, exerts constant pressure on the people of Serbia, especially on the people living in Jadar and Radjevina, violating many of our rights guaranteed by law, bringing us to a situation where we live in fear every day, not having the possibility of peaceful enjoyment in our homes, the possibility of planning for the future and so on.

Taking into account the decisions of the COP15<sup>17</sup> United Nations Summit that was held in Montreal in December 2022 and in which the Republic of Serbia also participated<sup>18</sup>, we consider and hope for your help to protect the rich biodiversity of Jadar, Radjevina and its surroundings for the benefit of entire humanity, and Nature as a separate entity that has its own Rights.

If you any of the above should be clarified, we will make a statement at your request. Considering that we are the only complainant on the ground every day as a local association and as residents of Jadar and Radjevina, and the only one in a situation where we can continuously assess the situation and have valid information, while we have not been in a situation to establish any communication with the other co- complainants for a long time, we ask you, as last time, that you inform us directly of everything that happens regarding this Complaint, so that we can act in a timely manner.

Once again, we repeat that your decision regarding our Complaint and the arguments submitted in the Complaint is very important to us. Since we have no contact with the other co- complainants, as we previously informed you about, we are obliged to repeat, for the sake of clear and precise communication, that we are not represented in this proceeding by anyone but ourselves.

Bern Convention - Complaint No. 2021/07 - Serbia-lithium mine in the Jadar Valley

Thank you for the opportunity to contribute with our Report on the status of the Jadar lithium mine project in Serbia.

First, we would like to confirm that, officially and to publicly available knowledge at least, the key licences and procedures for the project have been 'terminated' or 'revoked,' however, as we shall show, the project has *not* been annulled in its entirety as the Government has publicly stated. In the response by the Ministry for Environmental Protection to the Secretariat of the Bern Convention dated 27 January 2022 (T-PVS/Files(2022)16) is listed a series of acts that have been terminated, however it appears that there are several key outstanding matters:

 Request for approval of exploitation field, which was declared as "ongoing" procedure in the Ministry response to the Secretariat. Two requests for access to info of public importance to the Ministry of Mining and Energy were submitted concerning this procedure by <u>Mars sa</u> <u>Drine</u>, one on May, 04th and October, 05th 2022.

1<sup>st</sup> Answer: May, 11th 2022.

"The company Rio Sava submitted the "Request for the approval of exploitation field no. 3" on January, 06th 2021. process still in progress." (Appendix 1, the part quoted is highlighted in red.)

Along with this there is also a map of coordinates of e.p.3.

2nd Answer: October, 10th, 2022.

To their question: Is the procedure concerning the "Request for the approval of the exploitation field no. 3", from January 06th 2021. suspended?

Answer was: Upon inspection of the official documentation of the Ministry of Mining and Energy, it was established that the procedure is <u>ongoing</u>.

(Appendix 2, the part quoted is highlighted in red.)

We attach the said documents as evidence. (Appendix 1)

- 2. Permit for "engineering-geological exploration" of water given to Rio Sava (Rio Tinto's local branch) in the area directly south of the "exploitation field" (the area according to the Spatial Plan would include the mine and a processing plant), is still marked as <u>active</u>, according to the public registry of the Ministry of Mining and Energy of the Republic of Serbia, as of the most recent update of the database (30 December 2022). Screenshot attached. (Appendix 3)
- **3.** Given that the state-owned road company Putevi Srbije (Serbia Roads), granted Rio Sava a power of attorney, we have a well-founded suspicion that they did the same for the construction of gas pipelines, transmission lines, and railroads.

The Power of Attorney was granted before the project was "terminated,", however, it states that it is valid until the 'licence to build' has been issued -which means it is still a valid

document given that no licence to build anything has been granted yet - to our knowledge.

We believe that it would be good to present our doubts to the Secretariat, so you could ask the State of Serbia if they have granted Rio Sava authorization for any/all of the above, considering that they did so for the road construction.

We attach the said document as a proof. (Appendix 4)

**4.** Local movement Ne damo Jadar has alerted that a number of plots of land have been registered at the Cadastre on the name of Rio Sava in 2022, even after the official termination of the Spatial Plan, EIA and related procedures. It is unclear on which legal basis the company would continue to acquire land, since it is the Spatial Plan that altered the purpose of the land plots from agricultural to construction. By the decision from April 19, 2022, the Republic Geodetic Authority has returned the purpose of the plots of land under the previous Spatial Plan from construction to their original uses (Agricultural, Forest, Pasture, Housing).

This should be further investigated.

**5.** It has been documented that company Bechtel, one of the contractors, has been collecting Expressions of interest for water waste processing plant for the project Jadar. The civil society was alerted about an e-mail circulated internally on August 8, 2022, months after the supposed 'termination' of the project. Further to that, it appears that Bechtel is currently advertising for the position of a 'Mine Area Manager,' "with an initial assignment supporting the Jadar Project." (Page archived on 30 January 2023)

We attach the said screenshots as evidence. (Appendix 5)

To this should be added that, in the media, political sphere and especially on the ground however, there are noticeable works going on in the background which give us reasonable doubt that those are all in preparation for the project to be reinstated and the mine to be opened in due course.

The company has repeatedly declared that they are still interested in the project and "exploring all the options," and the CEO has as recently as December 2022 claimed that "we haven't given up." (Reuters) The President of the Republic of Serbia has multiple times over the year commented that supposed "termination" of the project by the Government was a mistake, effectively increasing the pro-mining rhetoric as the time goes on. (Istinomer) It seems that the public is being prepared for another push to approve the project, and that instead of 'terminating' the project, as the Prime Minister officially announced in January 2022, Project Jadar has rather been put 'on hold.'

Therefore, as we claim in our original Complaint, there is an ongoing threat to the flora and fauna species and wild habitats in the region from this mining project.
