**Subject:** File Complaint No. 2010/5: Case-file open on "Greece: threats to marine turtles in Thines Kiparissias"

Greece would like to provide the following information concerning the open Case File No. 2010/5 to the attention of the Bureau of the Bern Convention in view of the September 2022 Bureau meeting. Greece would like to inform the Bureau that the country is still working on this case having Recommendation No. 174 (2014) as a guiding tool. According to nesting data provided by the NGO 'Archelon', there is a positive trend in nesting activity in Kyparissiakos Bay over the last decade, from 828 nests recorded in 2012 to 3239 nests recorded in 2021 in the core of the biotope (Arkadikos-Neda area).

As regards point 3<sup>1</sup> of the Recommendation, Greece reiterates its statement presented in the October 2021 report that COIEL/SYGAPEZ2<sup>2</sup> blocked the roadways in June 2021 and has proposed an environmental study to be paid and implemented by the offender on the restoration of sand dunes, the inversion of erosion as well as the restoration of the area after the destruction of the roadways. COIEL/SYGAPEZ revisited the area in 2022 and reported that nothing has changed. The Ministry reserves the right to contact the Bureau as soon as any updates regarding this case are available.

We remain at your disposal for any clarification you may need.
