CONCLUSIONS

Local Steering Committee EU/CoE Partnership for Good Governance 2019 – 2021

Baku, 3 October 2019

The Partnership for Good Governance (PGG) **Local Steering Committees (LSC)** of a tri-partite nature (European Union, Council of Europe, Beneficiaries) have been established regarding each of the countries covered by PGG. The LSCs meet once a year with a view to:

- monitor the implementation of the Annual Plans of Action (APAs) in each country;
- monitor the implementation of regional/multi-country projects regarding both regional action and the specific actions of the country concerned;
- formulate recommendations with a view to steering the projects;
- transmit proposals for revised APAs to the PGG Steering Committee (PGG-SC) and formulate recommendations as to the initiation of any other national intervention under PGG, as well as any recommendations regarding regional Action;
- make proposals to the PGG-SC as to the use of reserve funds.

The first meeting of the LSC for Azerbaijan was held on 3 October 2019 in Baku in accordance with the Agenda shown in Appendix I. The list of participants is shown in Appendix II.

Recommendations and conclusions

Further to detailed presentations of the different PGG projects involving Azerbaijan and in-depth exchange of views, the LSC made some specific recommendations and came to the following conclusions:

- The PGG projects, both country-specific and regional, involving Azerbaijan are relevant for the ongoing reforms in the areas of judicial reform and countering money laundering and provide substantial support to bring the national legislation and practice closer to the European standards and to contribute to the achievement of the EU 2020 Deliverables. Participants considered that the actions aiming at preventing and combating discrimination and domestic violence are also relevant for the country and should be pursued.
- The LSC noted that the modalities and degree of involvement of the national partners in the regional co-operation can vary from project to project. In particular regarding the regional project "Strengthening the access to justice through non-judicial redress mechanisms for victims of discrimination, hate crime and hate speech in the Eastern Partnership Countries", notably its "hate

speech" component, the Azerbaijani authorities underlined that the modalities of the country involvement will be further defined in the light of concrete activities.

- While no request under the Quick Response Mechanism has been submitted by Azerbaijan so far, beneficiaries have taken note of the possibility to use this tool.
- The LSC underlined that permanent contacts and interactions between the main PGG stakeholders
 Council of Europe, European Union and the national authorities are required to monitor the Programme activities and to adjust them in accordance with the country's needs.
- The PGG country specific and regional projects parameters (including objectives, implementation modalities and proposed activities) were endorsed by the LSC participants.
- Specific recommendations regarding the projects will be reflected in the relevant APAs with a view to their consideration by the PGG-SC. They include:
 - ✓ The project "Strengthening the access to justice through non-judicial redress mechanisms for victims of discrimination, hate crime and hate speech in Eastern Partnership Countries" should reflect the level of involvement of Azerbaijan (see above).
 - ✓ The work plan for the regional project "Women's access to justice: delivering on the Istanbul Convention and other European gender equality standards" will be further developed and reflected in the APA.
- The LSC noted that the PGG communication and visibility actions should not only regularly provide update on the Programme implementation to the PGG stakeholders but also provide comprehensive information on the PGG concrete benefits to citizens.
- The LSC also noted that the information flow on regional activities needs to be further reinforced.
- The LSC welcomed the participation of civil society organisations (CSO) in the PGG actions and noted their expressed wish to participate in the roundtables/capacity building events, as well as monitoring of the implementation of projects.
- In this context it was suggested however to invite to the LSC meetings only those CSOs which are stakeholders in the implemented PGG projects or specialised in judicial reforms, countering money laundering, anti-discrimination and fighting violence against women and domestic violence in order to better focus the LSC debates.
- As for the needs to inform a wider range of civil society of the PGG activities, it was suggested to hold an information meeting for CSOs as a separate event back to back to the LSC.
