The Partnership for Good Governance (PGG) **Local Steering Committees (LSC)** of a tri-partite nature (European Union, Council of Europe, Beneficiaries) have been established regarding each of the countries covered by PGG. The LSCs meet once a year with a view to:

- monitor the implementation of the APAs in each country;
- monitor the implementation of regional/multi-country projects regarding both regional action and the specific actions of the country concerned;
- formulate recommendations with a view to steering the projects;
- transmit proposals for revised APAs to the PGG-SC and formulate recommendations as to the initiation of any other national intervention under PGG, as well as any recommendations regarding regional Action;
- make proposals to the PGG-SC as to the use of reserve funds.

The first meeting of the LSC for Ukraine was held on 11 October 2019 in Kyiv in accordance with the Agenda shown in Appendix I. The list of participants is shown in Appendix II.

Recommendations and conclusions

Further to detailed presentations of the different PGG projects involving Ukraine and in-depth exchanges of views, the LSC made some specific recommendations and came to the following conclusions:

- The LSC endorsed the country specific project¹ as well as regional projects, considering that they are all relevant for Ukraine. Specific recommendations regarding some projects were made as follows:
 - ✓ The project "strengthening measures to counter money laundering and financing of terrorism in Ukraine" should involve the Bar association as one of its beneficiaries; specific

training and involvement of the Bar association in the training is planned, as well as its involvement in activities relating to the supervisory functions over the legal profession were recommended. The involvement of the National School of Judges (NSJ) in this project is fully relevant. Considering the priority given by the NSJ to enhance skills of judges on cybercrime, the regional Joint Programme in this area for Eastern Partnership should consider involving this institution in some of its activities.

- ✓ The project "strengthening the profession of lawyer in line with European standards": the Bar association is not convinced of the relevance of this project for Ukraine; further discussions and consultations should be carried out within the best possible delay to clarify the project's content as regards Ukraine.
- ✓ The project "Strengthening the access to justice through non-judiciary redress mechanisms for victims of discrimination, hate crime and hate speech in Eastern Partnership countries" is very relevant for Ukraine, notably as regards the objective to set up a system to collect disaggregated data. Civil society's active involvement in this project is of utmost importance. The LSC highlighted the need to widely raise awareness in this area, as well as to diversify the participation of civil society representatives within this framework.
- ✓ The project "Women's access to justice: delivering on the Istanbul Convention and other European gender equality standards": In view of the regional nature of the project, the LSC recommended that the specific bilateral project of the Council of Europe², should support the capacities of social workers and police officers in this area.
- The LSC noted the complementarity between PGG and other European Union projects such as PRAVO (Police and Justice projects, the EU Anti-corruption initiative and the "European Union and Council of Europe working together for strengthening the protection of human rights in Ukraine". Close co-ordination, but not duplication, between all these projects should be ensured towards the achievement of EU 2020 deliverables.
- Communication with beneficiaries, the European Union Delegations and Council of Europe Offices regarding regional projects should be safeguarded in a timely and efficient manner. Work plans should be shared and consultations held on a regular basis and in due time.
- While no request under the Quick Response Mechanism has been submitted by Ukraine so far, the tool has been acknowledged.
