CONCLUSIONS

Local Steering Committee EU/CoE Partnership for Good Governance 2019 – 2021

Yerevan, 1 October 2019

The Partnership for Good Governance (PGG) **Local Steering Committees (LSC)** of a tri-partite nature (European Union, Council of Europe, Ministry of Foreign Affairs, Beneficiaries) have been established regarding each of the countries covered by PGG. The LSCs meet once a year with a view to:

- monitor the implementation of the APAs in each country;
- monitor the implementation of regional/multi-country projects regarding both regional action and the specific actions of the country concerned;
- formulate recommendations with a view to steering the projects;
- transmit proposals for revised APAs to the PGG-SC and formulate recommendations as to the initiation of any other national intervention under PGG, as well as any recommendations regarding regional Action;
- make proposals to the PGG-SC as to the use of reserve funds.

The first meeting of the LSC for Armenia of the PGG phase 2 (2019-2021) was held on 1 October 2019 in Yerevan in accordance with the Agenda shown in Appendix I. The list of participants is shown in Appendix II.

Recommendations and conclusions

Further to detailed presentations of the different PGG projects involving Armenia and in-depth exchanges of views, the LSC made recommendations and came to the following conclusions:

• As demonstrated by phase I, the PGG Programme is an efficient instrument providing tangible and results oriented technical assistance to the EaP countries in the implementation of domestic reforms with the aim to bring the national legislation and practice closer to the European standards and to contribute to the implementation of the EU-Armenia Comprehensive and Enhanced Partnership Agreement (CEPA) and the achievement of the EU 2020 Deliverables. The PGG projects, both country-specific and regional involving Armenia are relevant including as regards the on-going reforms in the justice area and to prevent and counter corruption. Participants considered that the actions aiming to preventing and combating discrimination and domestic violence should also be pursued.

- The Quick Response Mechanism has been acknowledged. The three requests made by Armenia since the beginning of the programme show that Armenia has a good awareness of the tool and makes use of it. The use of QRM beyond the Venice Commission may be considered for requesting objective and high-quality legal advice in other areas.
- Considering the fast-evolving reform environment, the PGG needs to make sure that the flexibility
 inherent to this joint programme is fully taken into consideration as regards actions in Armenia. In
 this context, steady contacts between the beneficiaries, including the Ministry of Foreign Affairs,
 the National Coordinator of PGG, the Council of Europe and the European Union will be maintained,
 notably relating to judiciary reforms and fight against corruption in order to ensure that projects
 can timely respond to the authorities' needs.
- Specific recommendations regarding the projects will be reflected in the relevant APAs with a view to their consideration by the PGG-Steering Committee. These include:
 - As regards the project "Support to the judicial reform", component 2 "Supporting the criminal justice reform and harmonising the application of European standards in Armenia", after the adoption of the Criminal Code and the Criminal Procedure Code it is expected to focus attention during subsequent trainings on the pre-trial stage. There should be a larger involvement of investigators in these trainings.
- The links between the objectives of PGG and the EU-Armenia Comprehensive and Enhanced Partnership Agreement (CEPA), both referring to the EU 2020 Deliverables were highlighted. It was agreed that clear cross referencing would be made whenever feasible.
- An appropriate level of communication and visibility is crucial to show how PGG actions are beneficial for citizens in Armenia.
- Communication and visibility were also highlighted as a necessary support for raising the general
 public's awareness in areas such as combating discrimination and violence against women and
 vulnerable groups. In the light of recent debates within the country regarding notably the Council
 of Europe Convention on preventing and combating violence against women and domestic violence,
 the need to ensure objectivity in communication to feed healthy debates was praised by the
 participants. Through its actions, PGG should aim at creating sound public awareness across the
 country.
- The interrelations between PGG projects (including between regional projects that also offer a wider framework for the exchange of best practices) require appropriate co-ordination between them. Likewise, co-ordination with other international organisations and actors in the field should be ensured.
- Participants emphasized the importance of building institutional capacities through training activities and the need to continue developing tools allowing measuring the extent to which newly acquired skills are used by those having been trained.
