This questionnaire will test citizens' knowledge regarding the protection of personal data., and their rights.
3. As part of the activities for the International Data Protection Day and in anticipation of January 28th, the Information and Data Protection Commissioner's Office, in collaboration with the Canadian Institute of Technology, will keep an open lecture on 24 January 2025. During this open lecture, the attendees will be acquainted regarding both areas of responsibility of the Commissioner's Office, right to information and personal data protection. - To celebrate Data Protection Day this year, the Gibraltar Regulatory Authority (the “GRA”), as the Information Commissioner (the “Information Commissioner”), will publish a report on the results of a Data Protection Survey (the “Survey”). The Survey, which aims to assess public awareness about data protection, was first carried out in 2019 with a report published on [Data Protection Day 2020](#). The Survey was re-launched in September 2024 with its report due to be published on Data Protection Day 2025. The aim of this initiative is to assess any changes in public perception over the last five years.
- The results of the Survey will help determine whether the data protection issues prioritised by the Information Commissioner, based on inbound complaints and enquiries, align with the concerns of the community or, if additional issues in other areas require attention. This insight will shape the Information Commissioner’s forward action plan and identify areas for his office to focus on.



On the occasion of «Data Protection Day» (28th of January 2025), the Personal Data Protection Service of Georgia will host a series of notable events to commemorate the day and promote the significance of personal data protection. These events will include:

1. Opening Ceremony of the New Office Premises

The Service will inaugurate its newly restored and renovated office space within the premises of its historic building. Originally designed by the renowned late 19th and early 20th-century architect — Alexander Ozerov, the building now reflects a harmonious blend of historical restoration and modern functionality.

The new office space features specially designated areas for meetings and training sessions, which will enable the Service to implement a range of educational initiatives. One such initiative is a series of weekly awareness-raising sessions with high school students, aimed at enhancing understanding of the importance of protecting minors' personal data.

2. High School Students Awards Ceremony

The Service will host an awards ceremony for the winners of its essay contest, announced in late 2024. Over 150 high school students from Tbilisi and other regions participated in the competition. The top three participants will be formally recognized and awarded during the event.

3. Lecture by Professor Norbert Bernsdorf
