



Hate Speech

Facebook removes hate speech, which includes content that directly attacks people based on their:



Hate Speech

What do you mean by an attack?

- Any violent speech or support for death, disease or harm
- Dehumanizing speech in the form of comparison to animals, filth or criminals
- Suggestion to use a weapon against a Protected
 Characteristic
- Calls for exclusion

Hate speech - attack

- We separate attacks into three tiers of severity, as described below.
- Tier 1 attack: violent speech, dehumanizing speech, mocking hate crimes
- **Tier 2 attack:** statements of inferiority, physical, mental, or moral deficiency, expressing contempt or disgust
- Tier 3 attack: calls to exclude or segregate, use of slur

Challenge ideas, institutions and practices. Share content containing for the purpose of raising awareness or educating others

Humour, satire or social commentary Authentic identity = more responsible when they share this kind of commentary Urge people to be conscious of their audience when sharing this type of content


