## Foreword

These Protocols have been prepared for staff at the Public Health Care Facility of the Institute for Forensic Psychiatry Sokolac within the Joint Programme of the European Union and the Council of Europe Horizontal Facility for the Western Balkans and Turkey I - "Enhancing human rights protection for sentenced and detained persons in Bosnia and Herzegovina".

The purpose of the Protocols is three-tiered and they may be used as:

- supporting material in the initial training of newly employed staff, i.e., as a way to introduce the topic of human rights protection
- assistance in professional development of more experienced medical staff in the area of human rights protection
- basis for future operational procedures or instructions for some work posts at the Public Health Care Facility of the Institute for Forensic Psychiatry Sokolac

The Protocols and standards of human rights protection for forensic patients contained in this paper are not meant to replace in any way the existing good practice, but instead to enrich and complement it by recommendations provided by European Committee for Prevention of Torture, Inhumane and Degrading Treatment or Punishment (CPT).

For the purpose of this paper, the protocol means a series of steps to be undertaken in a sequence, as a response to a certain situation implying the risk of violation of human rights of forensic patients.

The Chapter "Control and Restraint" relates to staff at the Public Health Care Facility of the Institute for Forensic Psychiatry Sokolac dealing directly with patients and does not in any way prejudice the description of duties of medical staff or security department employees.

Sections of the Protocols are based on the previously prepared Training manuals on core and advanced competencies for prison staff, the Guidelines on dealing with persons deprived of liberty in closed environment and the Protocols for enhancing health care and human rights in closed environment.

The languages in which the documents are written are Bosnian, Serbian and Croatian, in accordance with personal preferences of the authors. The alphabets used in the texts are Latin and Cyrillic- reflecting personal preference of the authors as well.

All references to staff in this paper are equally made to both male and female persons and do not in any way prejudice gender identity.

The Protocols' legal framework is based on the following pieces of legislation:

- the Law on medicines and medical equipment
- the Law on radiation and nuclear security in BiH
- the Law on managing medical waste
- the Law on preventing misuse of drugs
- the law on records in the health care sector
- the Law on dentistry
- the Law on restricted use of tobacco derivatives
- the Law on medicines in the Federation of BiH
- the Law on medical profession
- the Law on nurses and midwives
