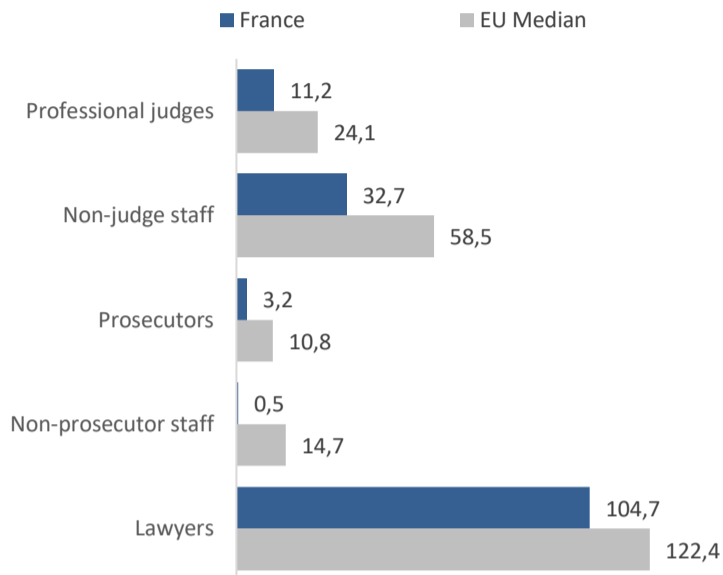

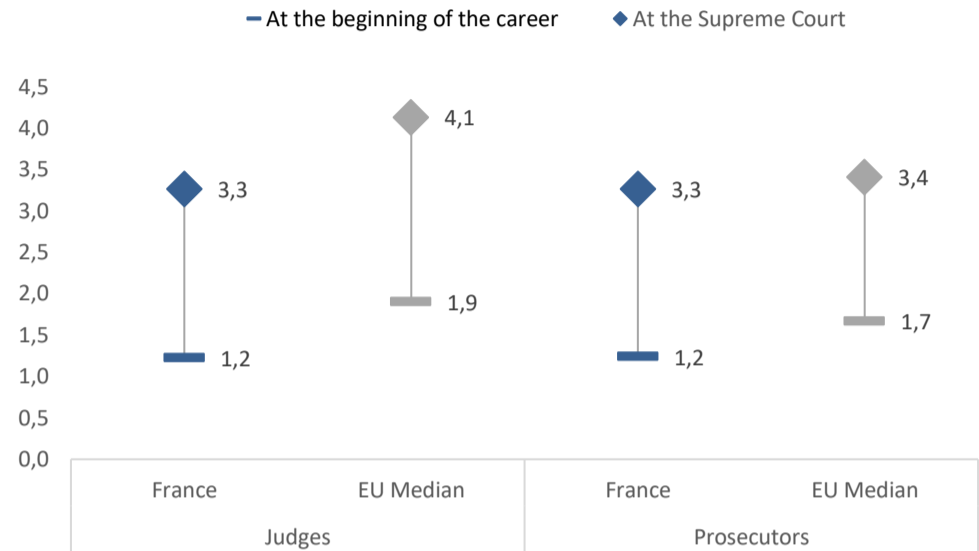

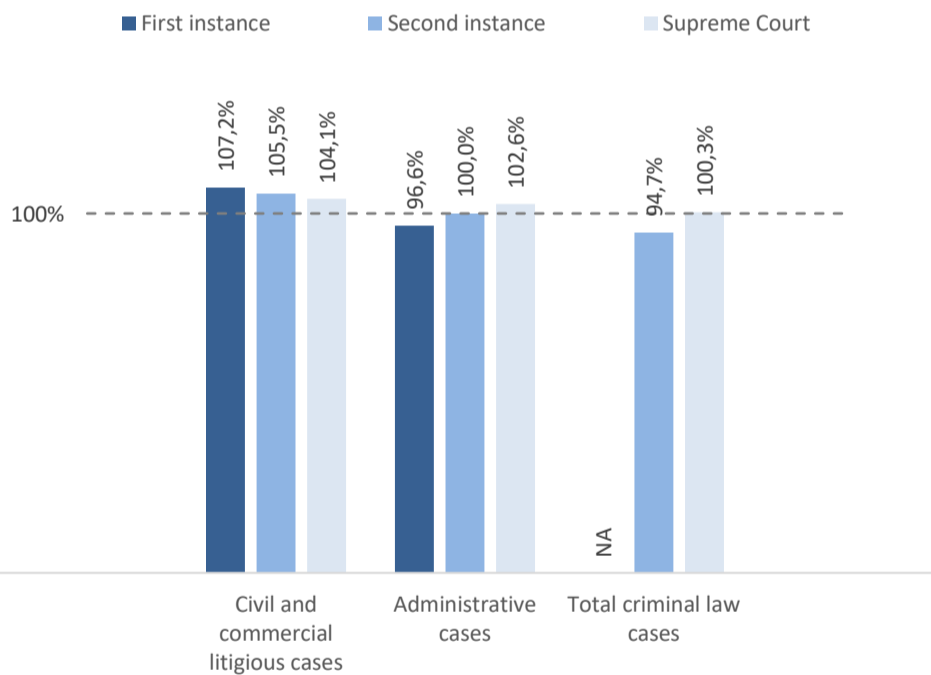


Gross salaries of judges and prosecutors vs average annual salary in 2021

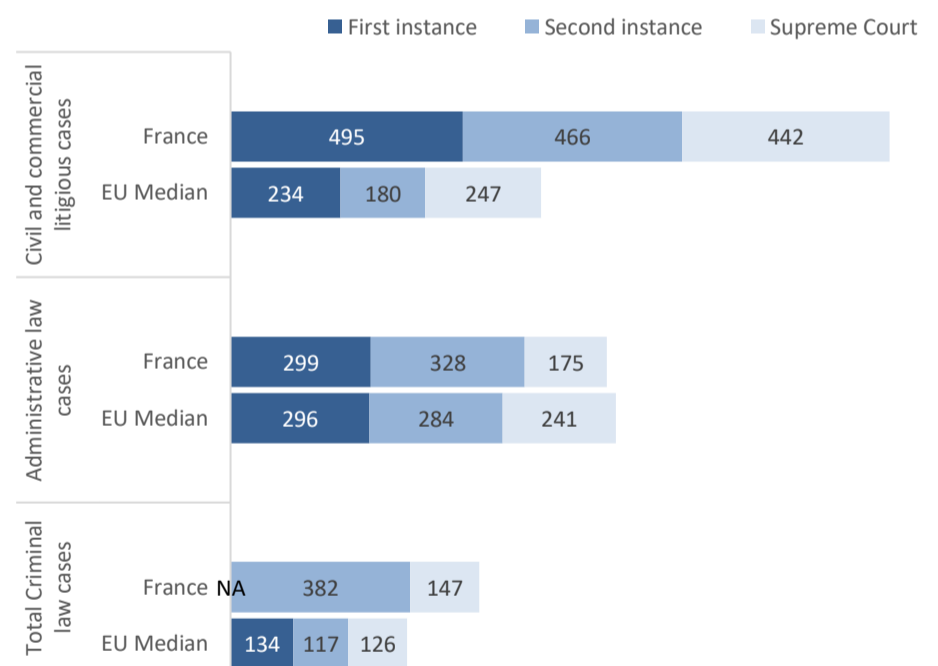

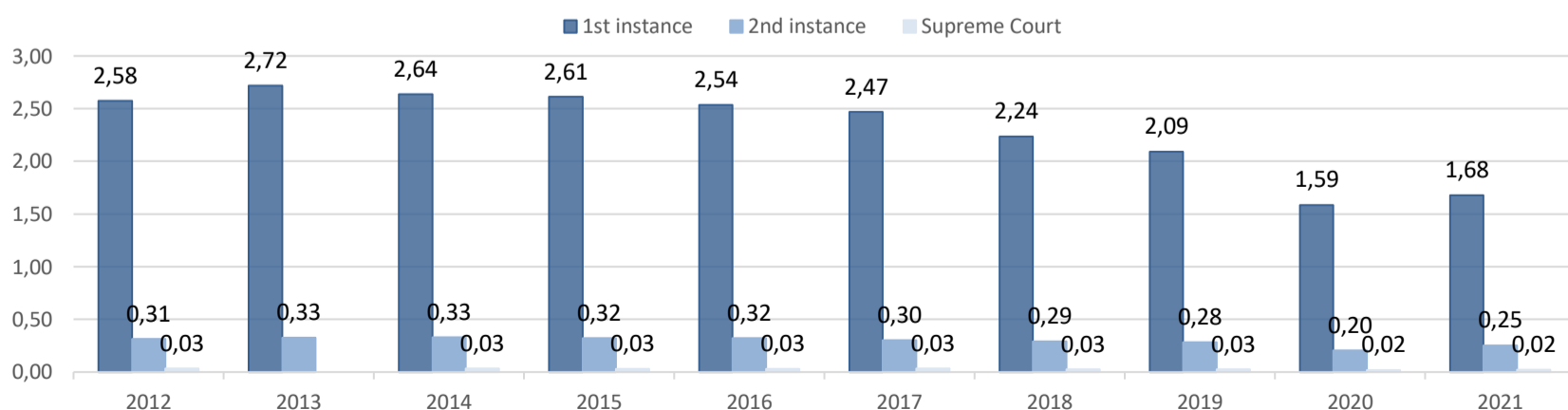


Disposition Time by instance and by matter in 2021 (days)

1. Judicial organisation in France (2021 data)

In 2021 in France, the number of courts considered as legal entities is 1 063. Namely, there are 206 courts of general jurisdiction and 857 specialised courts.

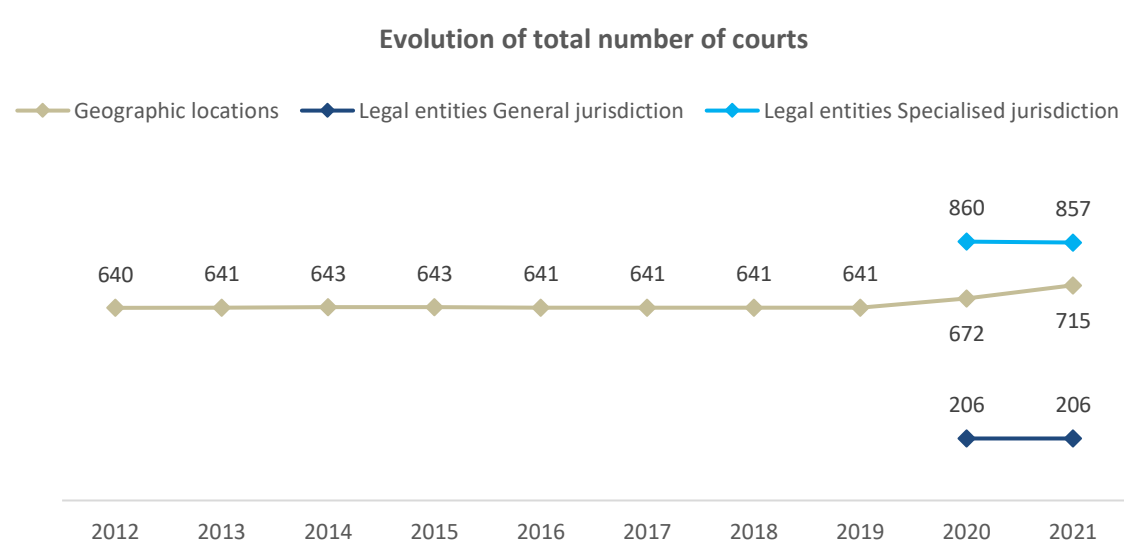
Among the 206 legal entities of general jurisdiction, the 164 "tribunaux judiciaires" and the 4 TPI have competence at first instance, the 37 Courts of appeal are the second instance courts of general jurisdiction, while the Cassation Court is the highest instance court of general jurisdiction in the French judicial system.

Among the 857 legal entities of specialised jurisdiction, 848 act at first instance, while 9 are higher instance specialised courts (infra).

In terms of geographic locations, there are 715 courts among which 661 are of first instance. When a court of first instance and a court of appeal are located on the same site, they have been counted separately.

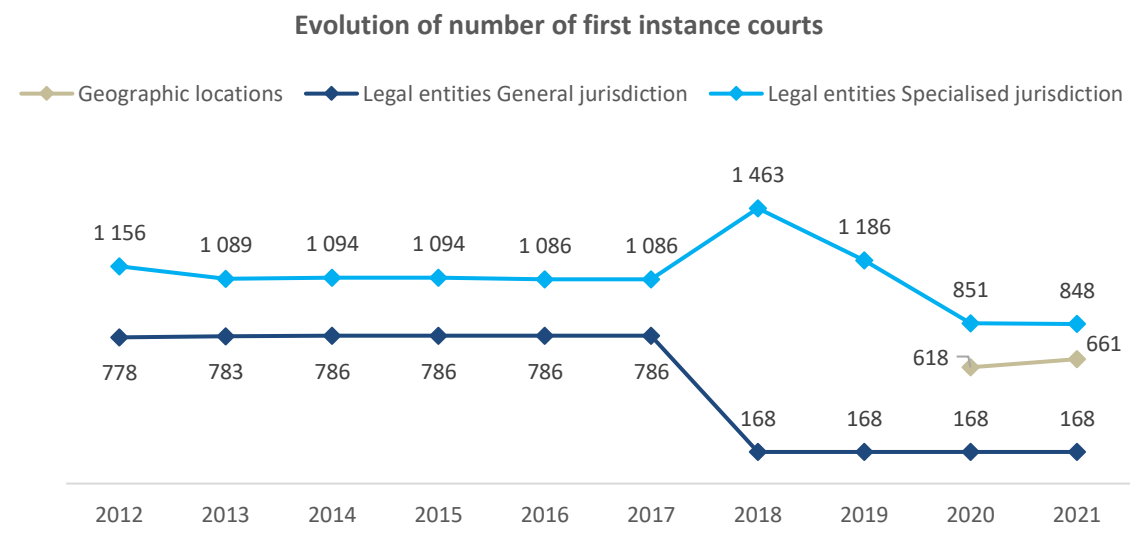

On the one hand, the decrease in the number of first instance courts of general jurisdiction in 2018 was the result of the implementation of the justice reform (Law No. 2016-1547 of November 18, 2016 on the modernization of justice in the 21st century; Law no. 2019-222 of 23 March 2019 on programming 2018-2022 and reform for justice).

On the other hand, since January 1, 2019, social litigation is within the competence of first instance courts of general jurisdiction (tribunaux judiciaires) and the specialized jurisdictions have been abolished. Since November 1, 2019, litigation concerning military disability pensions has been transferred to administrative courts.

Distribution of first instance general jurisdiction and specialised courts



The distribution between first instance general jurisdiction courts and first instance specialised courts is 16,5% - 83,5%, which is in contrast with the distribution tendency in EU: 72,8% - 27,2%. Indeed, in 2021, France is the EU member State with the highest number of specialised courts.

In France in 2021, at first instance there are 216 labor courts (211 "conseils de prud'hommes" and 5 labor courts); 152 commercial courts; 42 administrative courts; 156 juvenile courts and 282 other specialised courts (272 parity courts for rural leases (tribunaux paritaires des baux ruraux (TPBR)), the Court for navigation on the Rhine; the Court for navigation on the Moselle; 6 Maritime courts; the National court of asylum; the "Commission du contentieux du stationnement payant").

In matters of enforcement of sentences, the enforcement judge (JAP) is a court of first instance for the enforcement of sentences, being at the same time a decision-making, monitoring and follow-up body. The Court for the Enforcement of Sentences (TAP) is a court of first instance, composed of three JAPs of the judicial courts (most complex and sensitive cases). In each court of appeal, a TAP is established. The exact number of enforcement of criminal sanctions courts is not available. However, as it is a small number it would not significantly affect the total.

In matters of terrorism, a derogatory jurisdiction is provided for under ordinary law (articles 706-22-1 and D 49-75 to D49-81-5 of the CPP). The Paris enforcement courts specialized in terrorist matters (JAPAT, the TAPAT and the enforcement chamber) have exclusive jurisdiction to monitor persons convicted by specialized terrorism trial courts; shared jurisdiction with ordinary law enforcement courts to monitor persons convicted of acts of terrorism and other offenses falling within the scope of Article 706-16 of the CPP by ordinary law courts.

Concerning military jurisdictions, in peacetime courts of general jurisdiction are competent, while in times of war, the territorial courts of the armed forces are competent as exceptional jurisdictions.

Higher instance specialised courts exist only in administrative matters - the 8 Administrative courts of appeal and the Council of State.

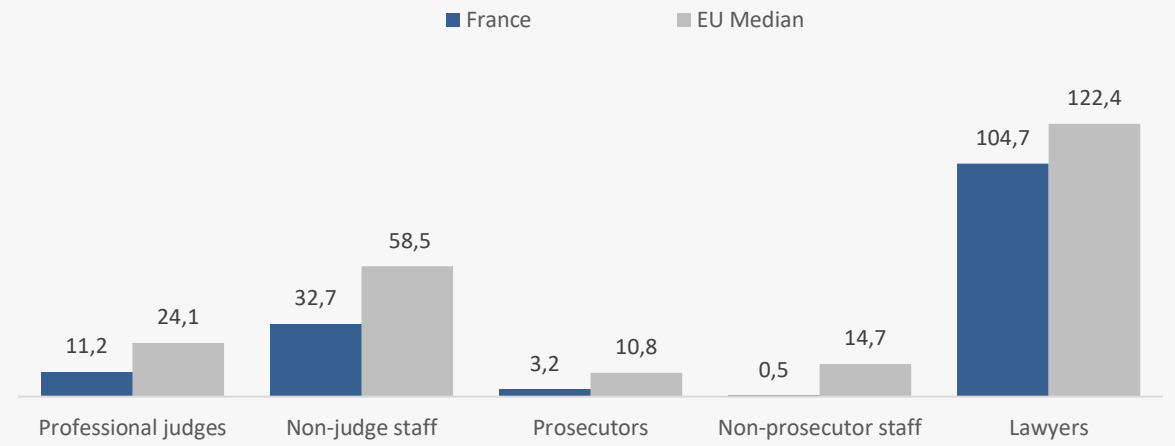

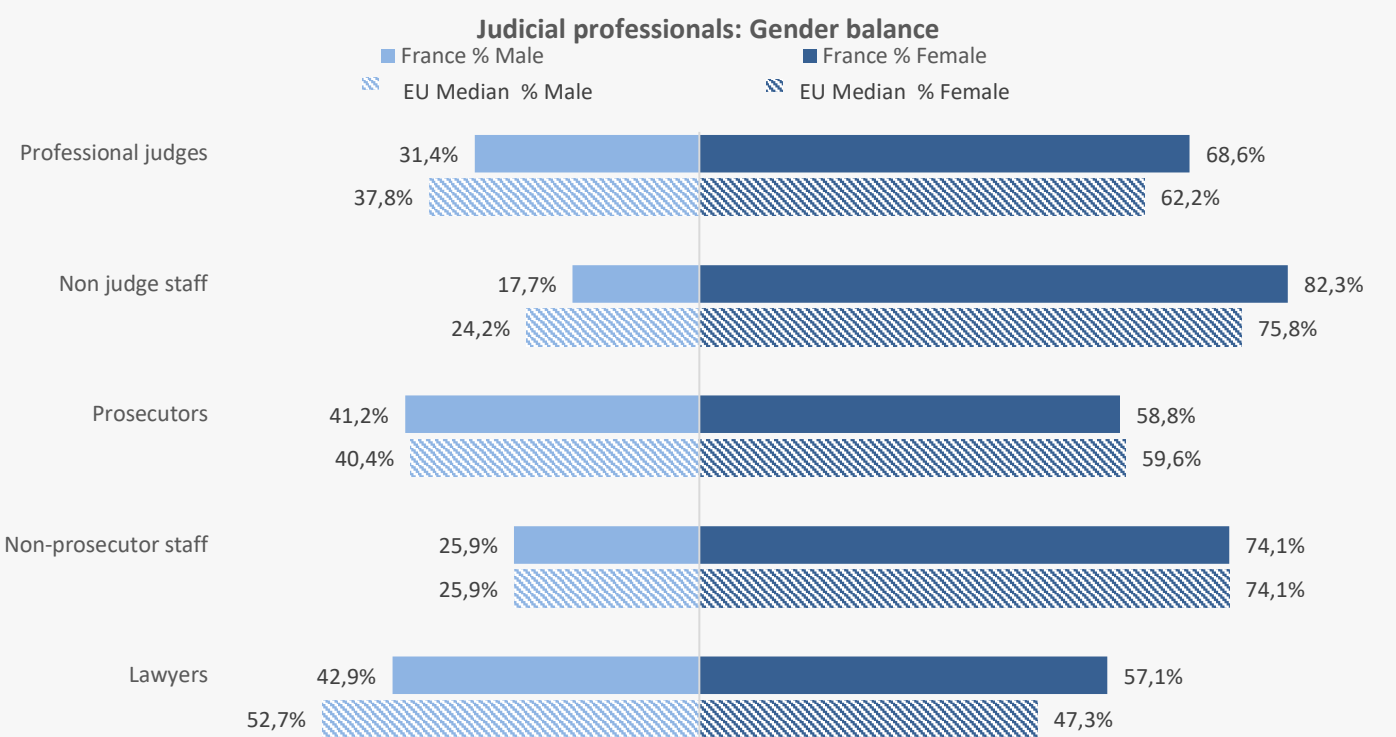

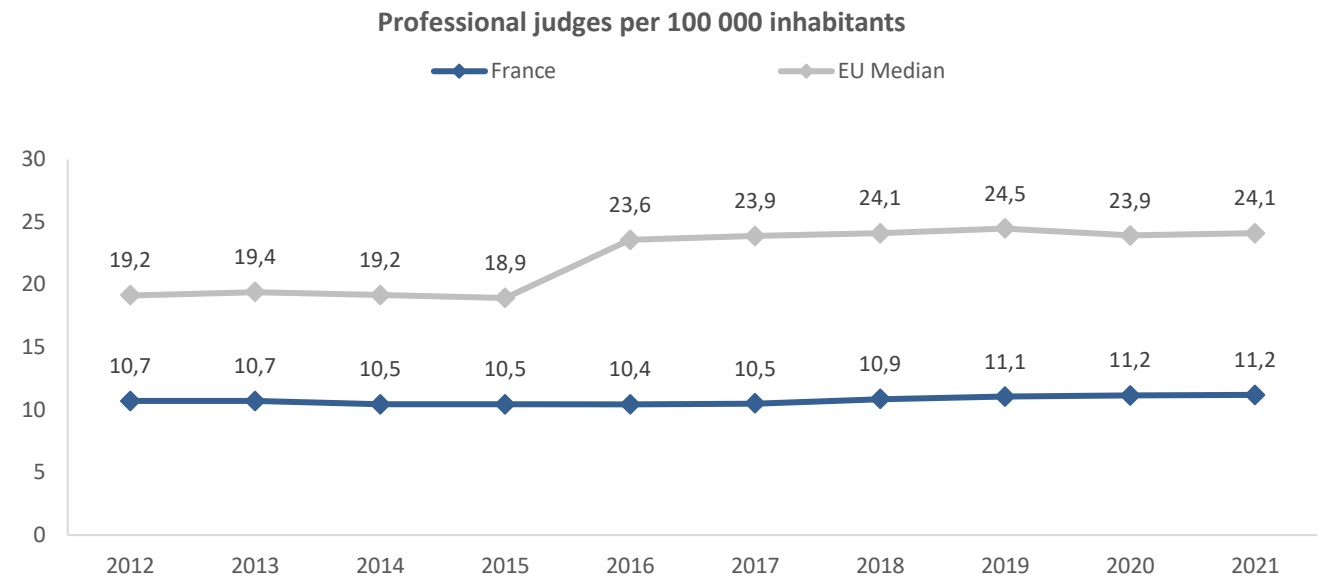

According to 2021 data, the total number of professional judges sitting in courts (all instances) in France is 7 574, which is 0,7% more than in previous cycle.

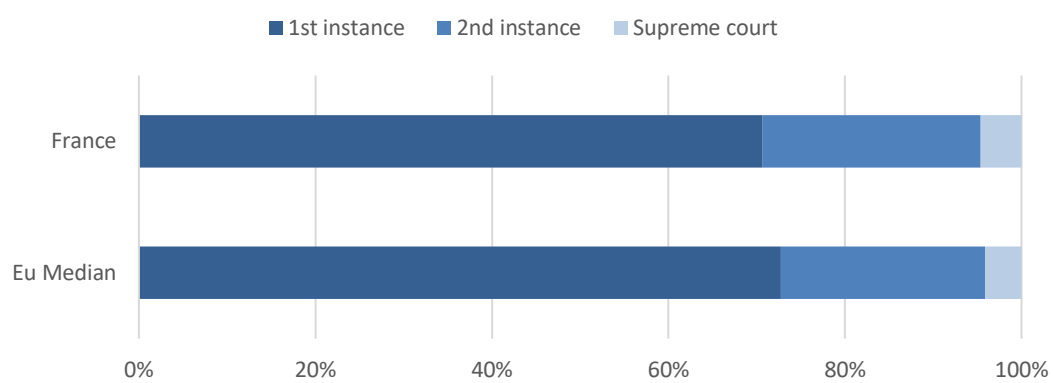
More precisely, in France, there are 11,20 professional judges per 100 000 inhabitants (this figure is below the EU median of 24,11 judges per 100 000 inhabitants) and about 2,92 non-judge staff per judge.

There is no significant difference compared with previous cycle when this ratio was at 3,20 non-judge staff per judge.

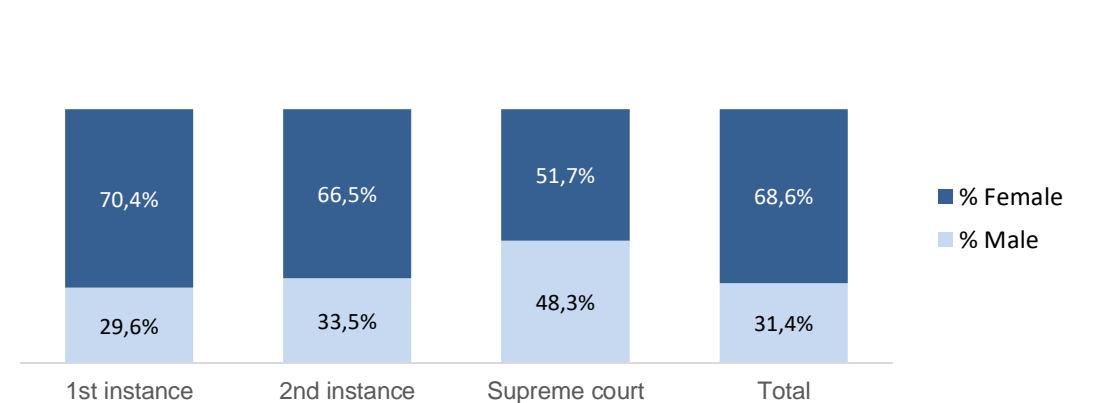

In this cycle, the total number of Female professional judges (all instances) is 5 194, which represents 68,6% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 5 354 are sitting in first instance courts (of which 3 768 are Female); 1 868 are sitting in second instance courts (of which 1 243 are Female) and 352 are sitting in Supreme Court (of which 182 are Female).

Compared with the EU distribution of professional judges per instance, a similar trend is observed in France. If the number of first instance judges is slightly below the EU median, those of second and third instance judges are slightly above the respective EU medians.

As regards the distribution of the number of judges among the different judicial instances, it has been specified that members of the National Court of Asylum (CNDA) and the Paid Parking Litigation Commission (Commission du contentieux du stationnement payant) are counted as first instance judges.

As regards the distribution Male/Female, it has to be specified that in France, in 2021, female judges have the majority at all instances. It is worth pointing out that the gender distribution is based on the number available in FTE for all professional judges except for administrative judges for whom the distribution is available in FTE only for the total.

Distribution of professional judges by instance and matter

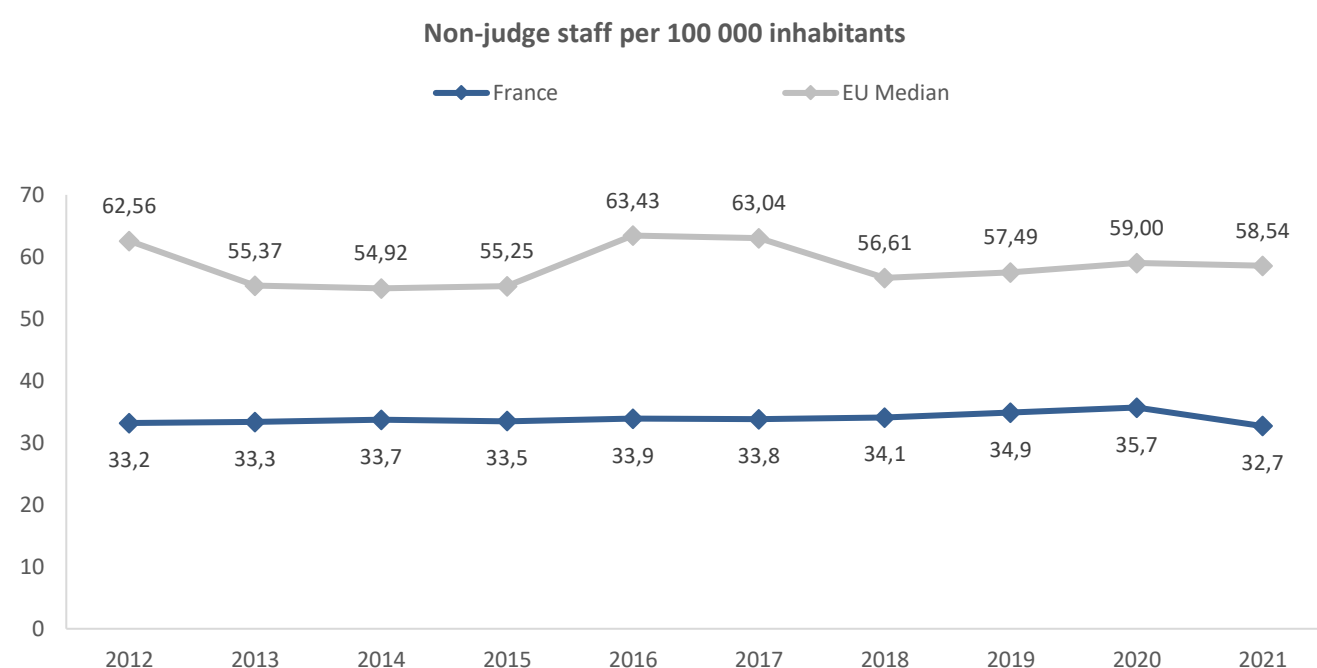

Non-specialised judges, who account for approximately 45% of the staff of the civil and criminal courts, are required to work in both criminal and civil matters. As a result, the distribution between the different types of litigation is not quantifiable, as these assignments fall within the organisational powers of the head of court.

Similarly, certain specialised judges (juvenile judges and liberty and custody judges) are also likely to intervene in both civil and criminal cases due to their areas of competence.

In 2021, France has 22 115 non-judge staff (of which 18 200 are Female). The total number of non-judge staff in comparison with the previous cycle reveals a decrease of -8,1%.

In 2021, the number of non-judge staff per 100 000 inhabitants has decreased (from 35,7 in 2020 to 32,7 in 2021).

During the same period, the number of judges per 100 000 inhabitants remained stable: 11,2 judges per 100 000 inhabitants.

In this cycle, the non-judge staff is broken down as follows:

- 18 311 non-judge staff whose task is to assist the judges such as registrars (of which 15 811 are Female);
- 2 391 staff in charge of different administrative tasks and of the court management (of which 1 815 are Female);
- 816 technical staff (of which 132 are Female);
- 597 other (of which 442 are Female);

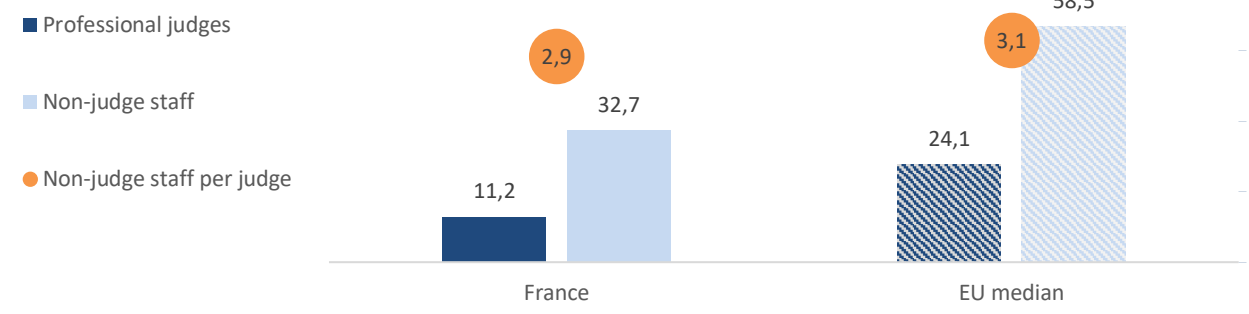
Concerning the total of 22 115, it should be noted that this figure includes 597 legal assistants and specialised assistants working only for the courts and 939 contractual staff recruited in the framework of local justice. Put differently, the "other non-judge staff" correspond to legal assistants and specialised assistants who do not work for the prosecution services, while for the other subcategories (2, 3 and 4) it is not possible to distinguish between staff working for the courts and those working for the public prosecution services.

The category "non-judge (judicial) staff whose task is to assist the judges such as registrars" includes the category B contractual staff recruited under the support plan for justice implemented since the second half of 2020 on the sole basis of Article 7 bis of Law No. 84-16 of 11 January 1984 on the statutory provisions relating to the State civil service, created by the law on the transformation of the civil service of 6 August 2019, which institutes the project contract. These contractual employees are recruited for three years. The significant increase in the number of these contractual staff (240 more than in 2020), combined with the increase in the number of court clerks (+221 compared to last year) and the increase in the number of other non-judge staff (+210 compared to last year), contributes to the increase in the overall figures communicated for the year 2021. As on 31 December 2021, 1 666 category A and B staff (including 1 383 women) were undergoing initial training at the "École nationale des greffes", most of them on practical training in the courts. These staff will join the courts in 2022 or 2023.

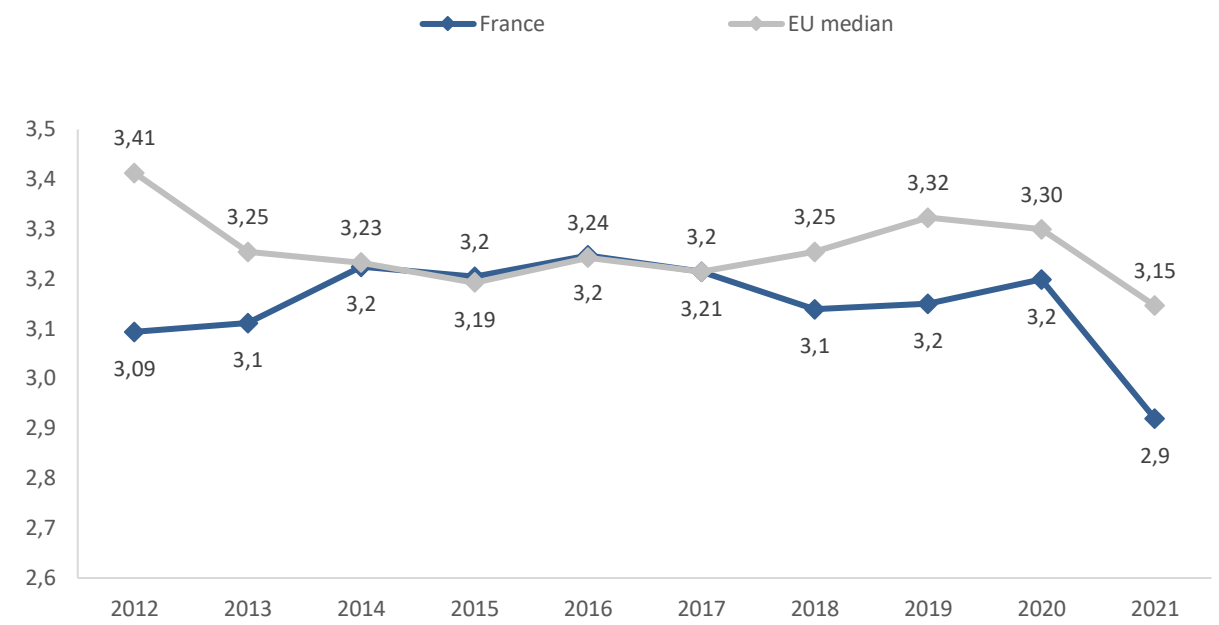
Professional judges and non-judge staff per 100 000 inhabitants, and their ratio

Evolution of the ratio between professional judges and non-judge staff

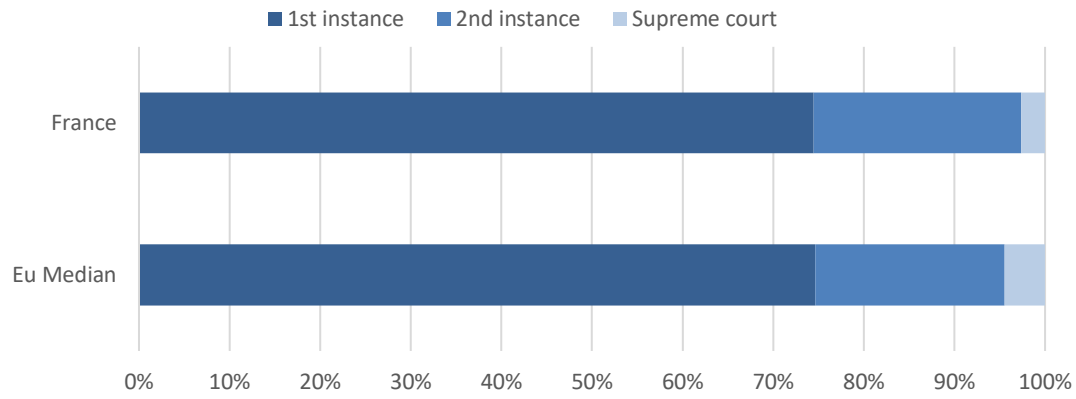

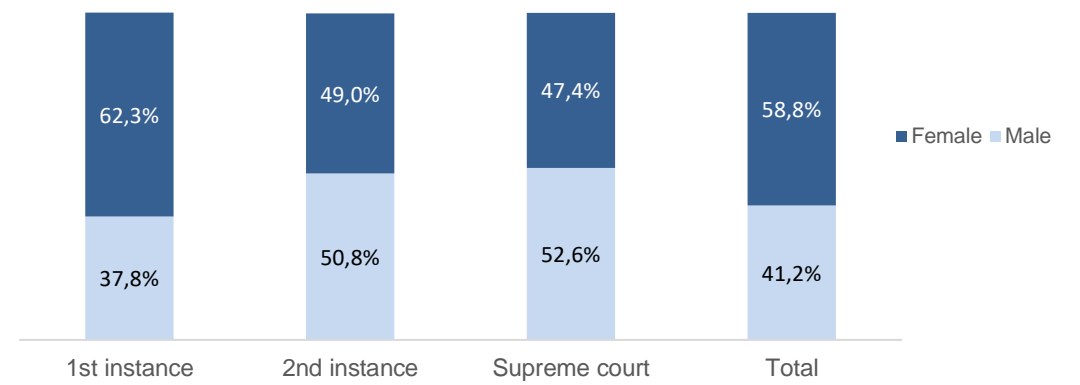

In this cycle, the total number of female prosecutors (all instances) is 1 261, which represents 58,8% of the total number of prosecutors.

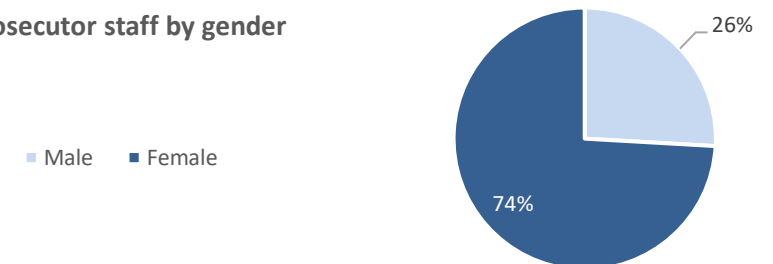

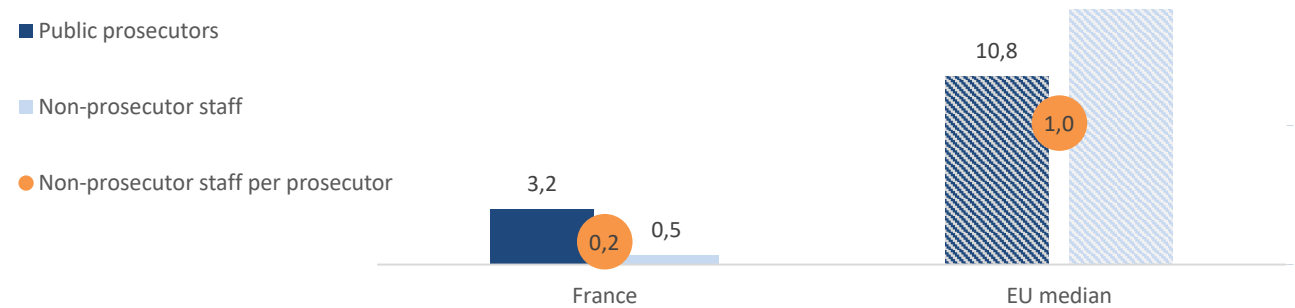
Non-prosecutor staff by gender



Ratio between non-prosecutor staff and public prosecutors

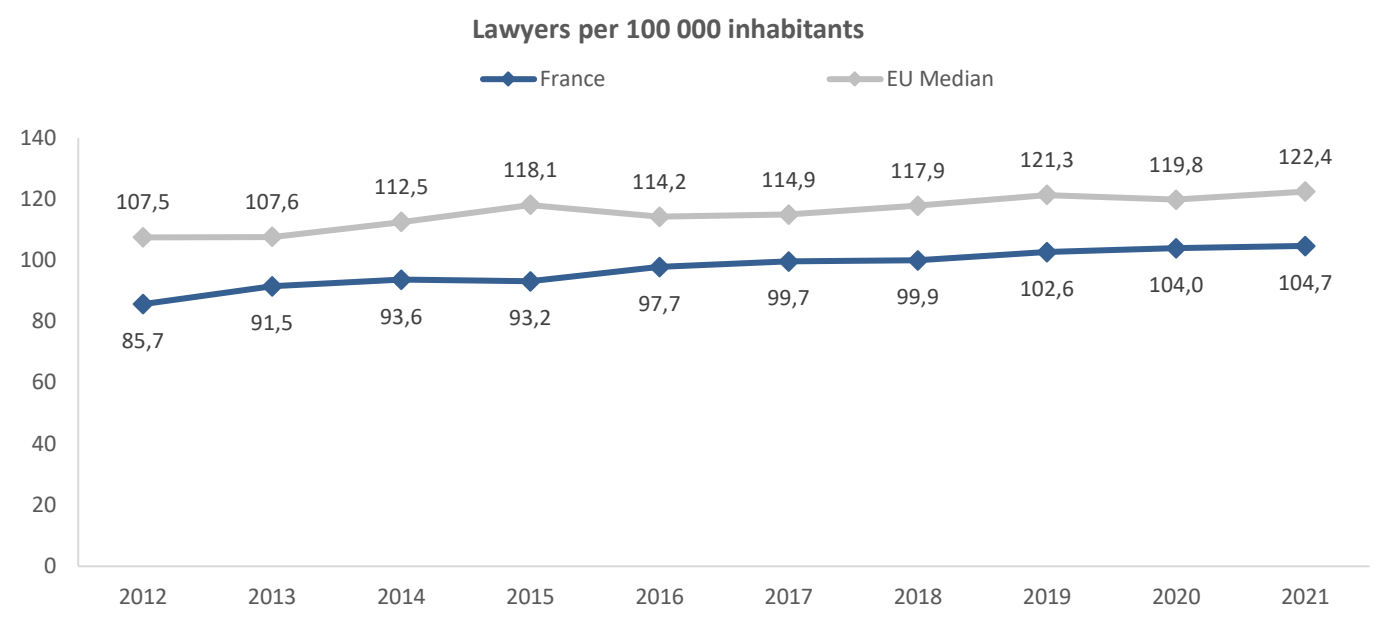

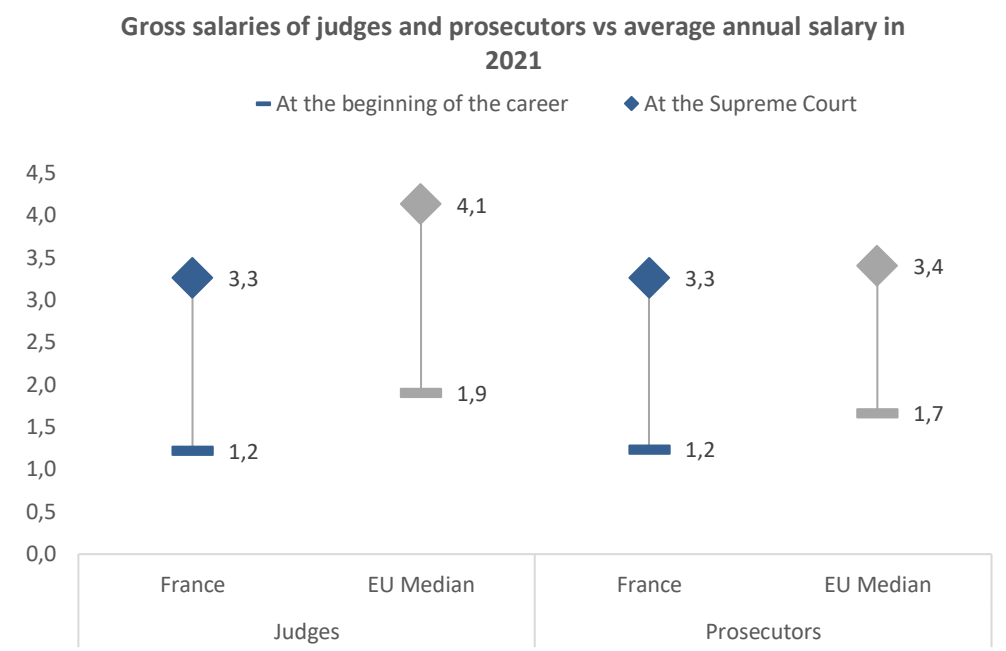


In 2021, there are 70 794 lawyers, which is 1,0% more than in 2020.

According to 2021 data, the absolute gross salary of a judge at the beginning of his/her career in France of 46 149€ is below the EU median of 52 534€. As a ratio with the annual average salary of the country, the salary for a judge at the beginning of his/her career is 1,22 which is also below the EU median of 1,90.

Is considered as "first-instance professional judge (civil and criminal courts) at the beginning of his/her career" a judge at the 3rd step of the second grade with a lump-sum compensation (35%) and flexible bonus (12%). Is considered as "public prosecutor at the beginning of his/her career" a prosecutor of the Public Prosecutor's Office at the 3rd step of the second grade with a lump-sum compensation (38%) and flexible bonus (12%).

Concerning judges of the Court of Cassation, is provided the salary of a President of Chamber CC (F: 1369) - flexible bonus 14%. With regard to prosecutor at the Court of Cassation, is provided the salary of the First Advocate General CC (F: 1369) - flexible bonus 14%.

It is noteworthy that the data provided are those of the civil and criminal justice. Concerning the administrative justice, the data are as follows: professional judge of first instance, beginning of career: 50 200, 41 300; judge of the Supreme court or of the last instance of appeal: 95 100, 76 900.

3. Legal aid and court fees in France (2021 data)

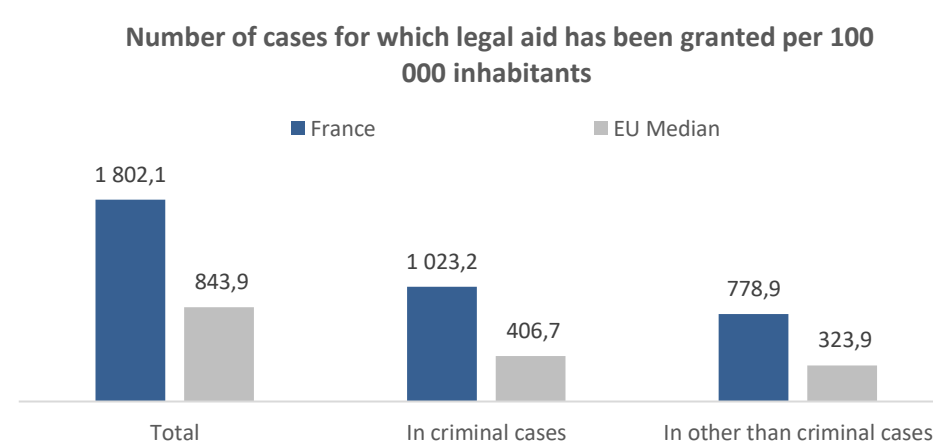
Enforcement agents can be appointed to enforce any court decision for a beneficiary of legal aid, either as a continuation of the proceedings or separately. Article 11 of the Law of 10 July 1991 provides for that legal aid "shall apply as of right to procedures, acts or measures for the enforcement of justice decisions obtained with its benefit, unless enforcement is suspended for more than one year for a reason other than the exercise of an appeal or a decision to suspend enforcement". In addition, Article 10 of the Law of 10 July 1991 provides for that legal aid may be granted "in connection with the enforcement on French territory of a court decision or any other enforceable title, including if they emanate from another member State of the European Union" (except Denmark).

Articles 40 and 40-1 of the law of 10 July 1991 on legal aid provide for that the beneficiary of legal aid is entitled to the assistance of a lawyer and all public or ministerial officers (enforcement agents, solicitors and notaries in particular). He/she is also exempt from paying, advancing or depositing all costs relating to the instances, procedures or acts for which it has been granted (expert reports, social surveys, family mediation, etc.), with the exception of a pleading fee of €13.

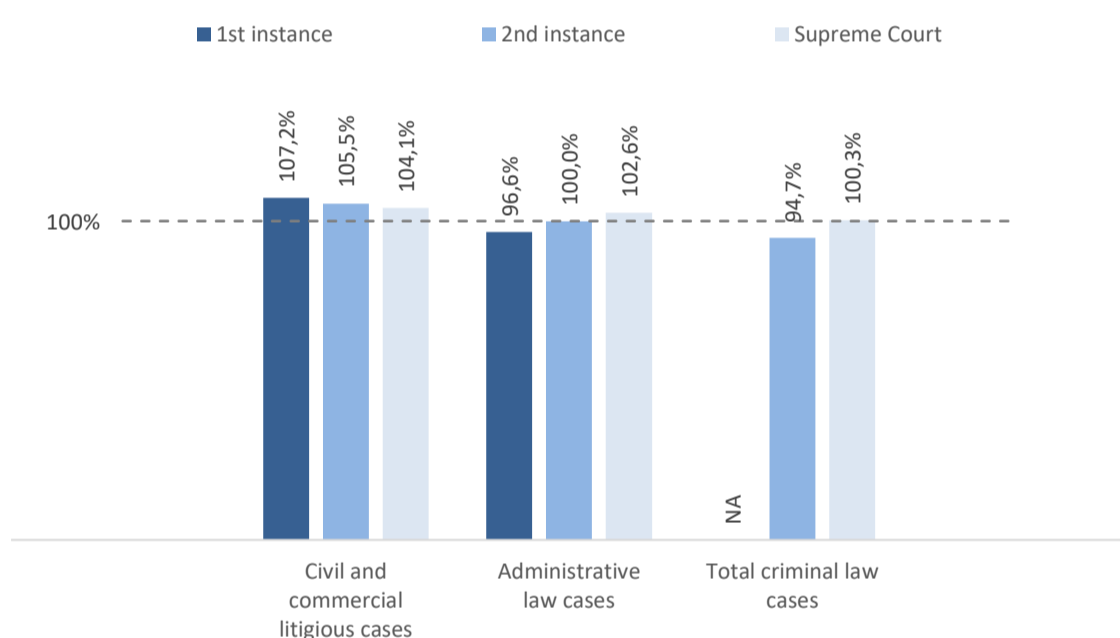

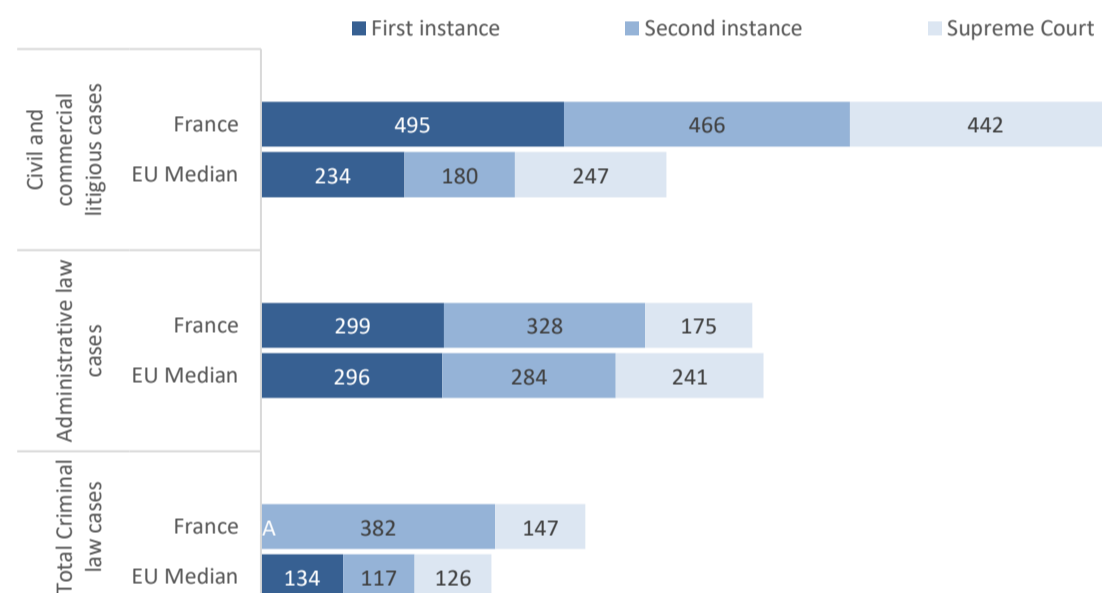

In 2021, in France, the total length of civil litigious proceedings, all instances considered together, is longer than the one of administrative proceedings which goes against the trend observed at the EU level. As a matter of fact, the Disposition Time indicator in civil matters exceeds considerably the respective EU medians for all three instances, despite the very positive results in terms of Clearance Rate. However, it should be highlighted that these positive values of the Clearance Rate in 2021 allowed reducing the Disposition Time in a very important way at all three instances. Accordingly, the total length of civil litigious proceedings in France decreased from 1 729 days in 2020 to 1 403 days in 2021.

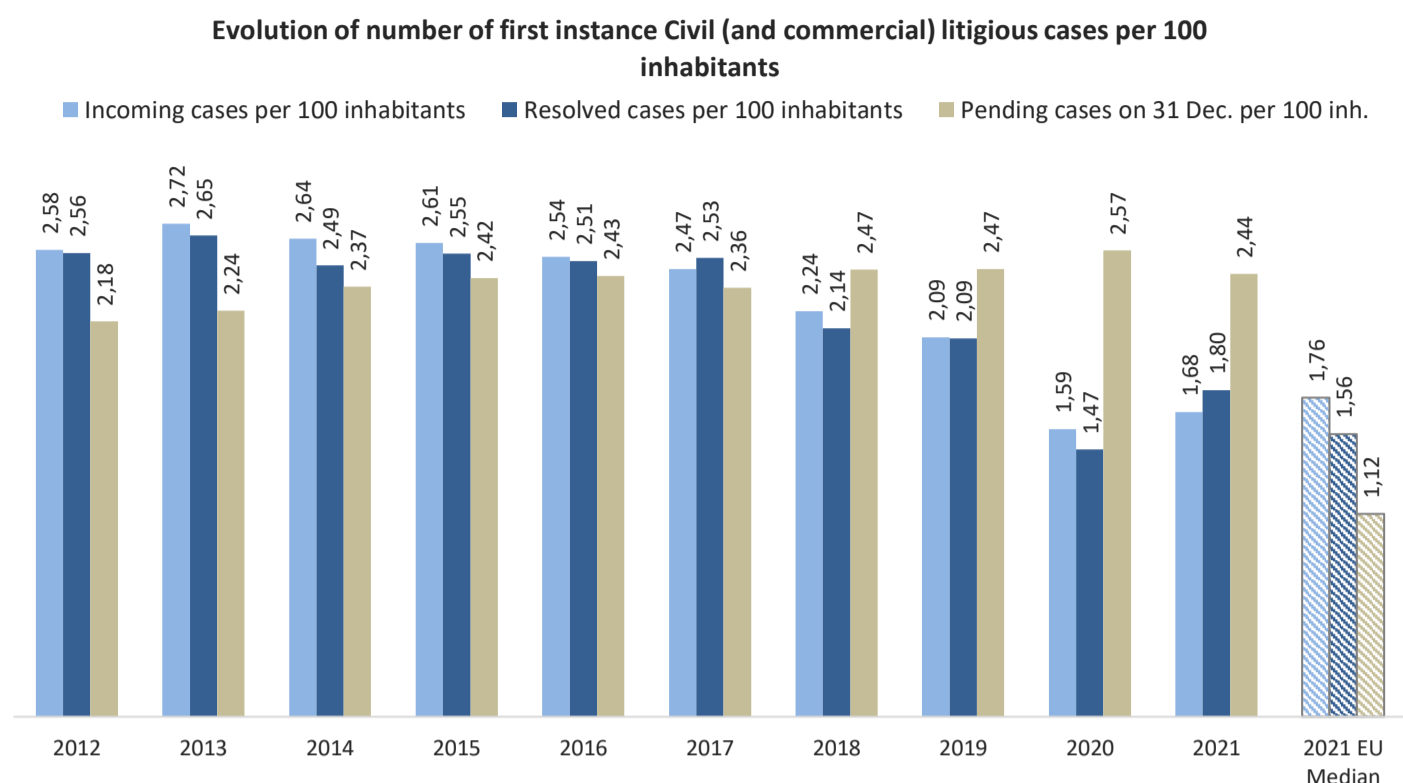
In administrative matters, the Disposition Time of second instance cases is slightly above the EU median, while this indicator is below the EU median at the level of the Council of State and very close to the EU median at first instance. It is worth recalling that the output of the administrative courts of appeal (CAA) fell sharply in 2020 (-10%) because of the COVID-19. When the situation returned to normal, the CAAs gave priority to foreigners' litigation, which accounts for almost 50% of their entries, and the stock therefore aged mechanically.

Data on criminal matters are partial which does not allow calculating the Clearance rate and the Disposition Time for first instance criminal cases. At second instance, it appears that courts of appeal have encountered some difficulties in 2021 in dealing with the case flow. As a result, even if the Disposition Time slightly decreased since 2020, it is still considerably above the EU median. As to the Court of cassation, its Clearance Rate was satisfactory in 2021, but the Disposition Time indicator remained at the same level as in 2020, slightly exceeding the EU median.

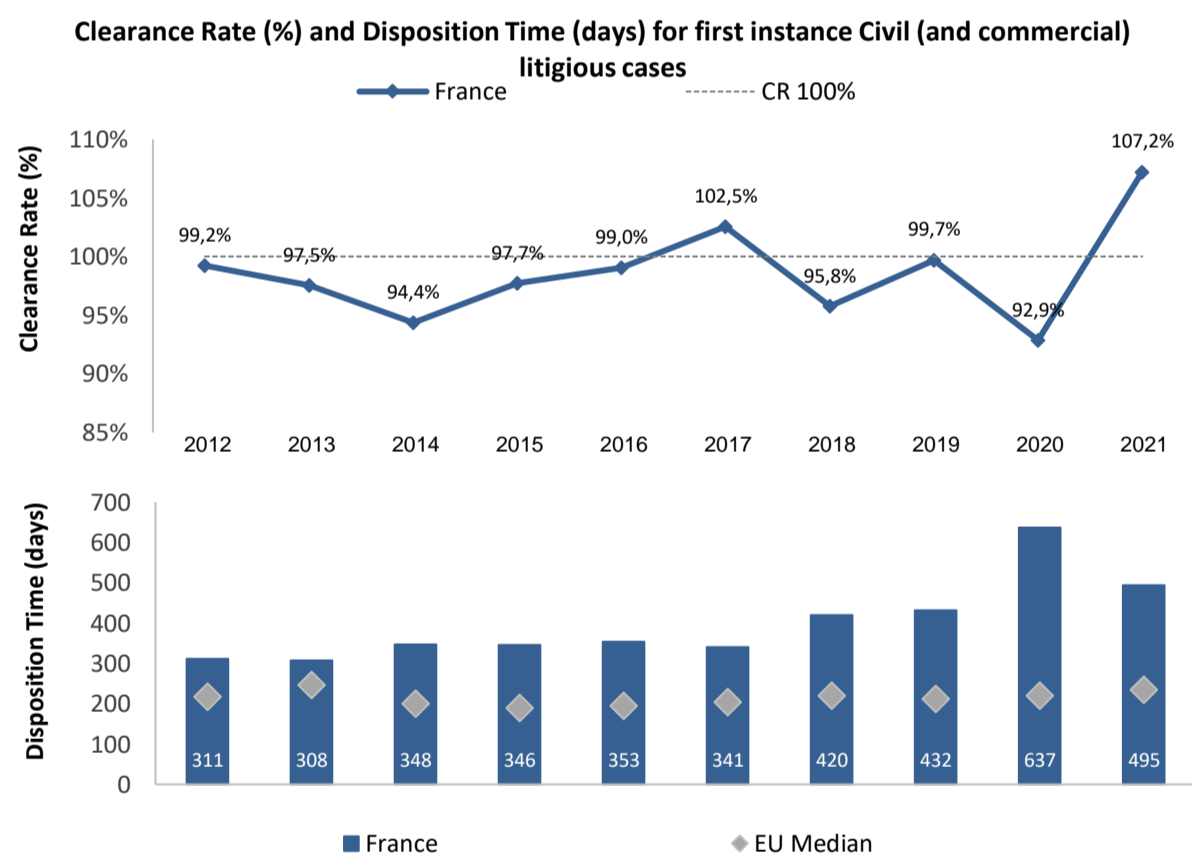

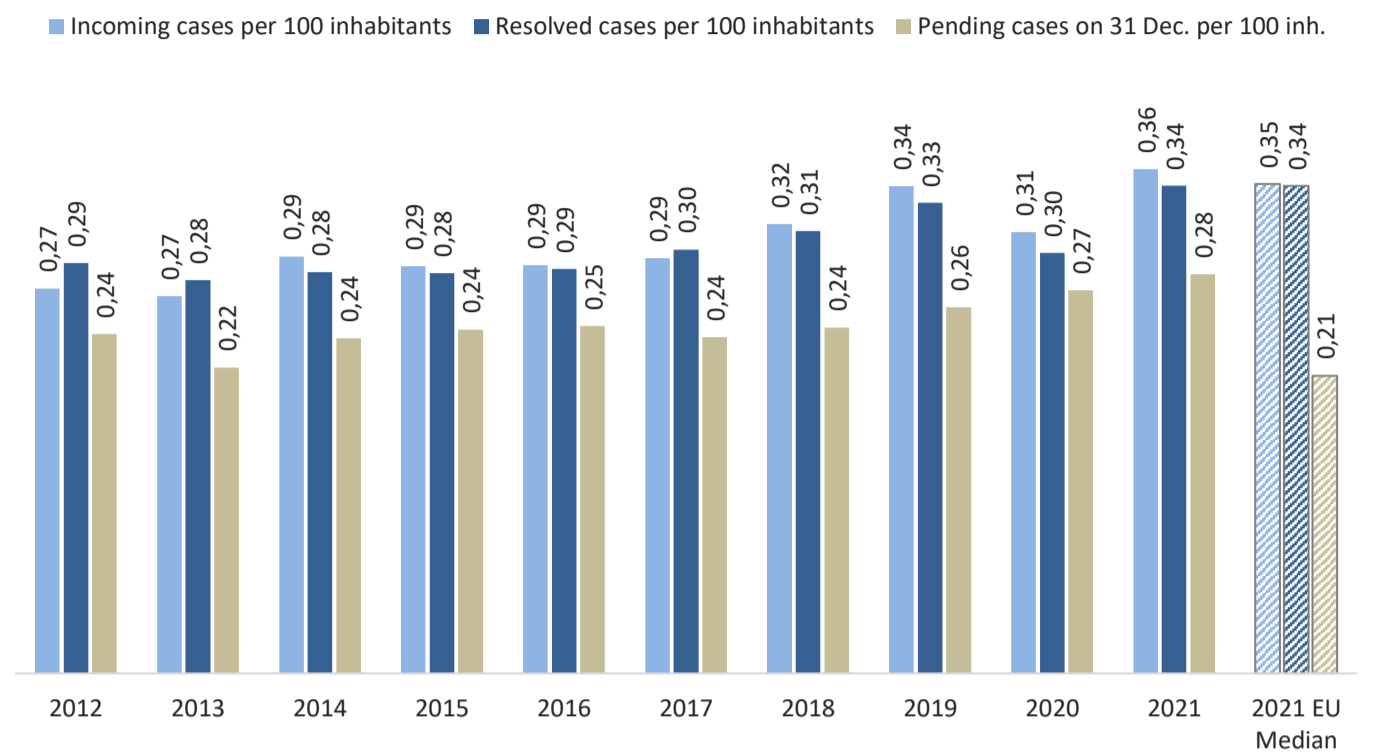

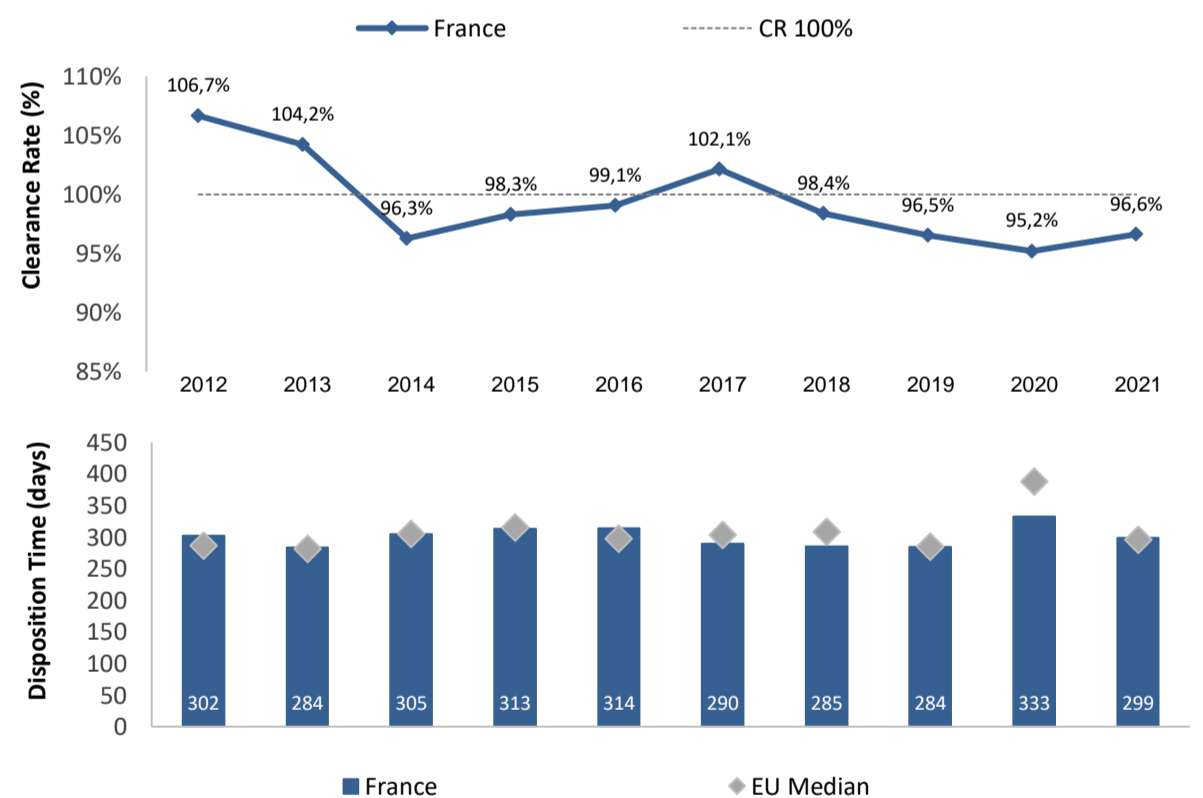

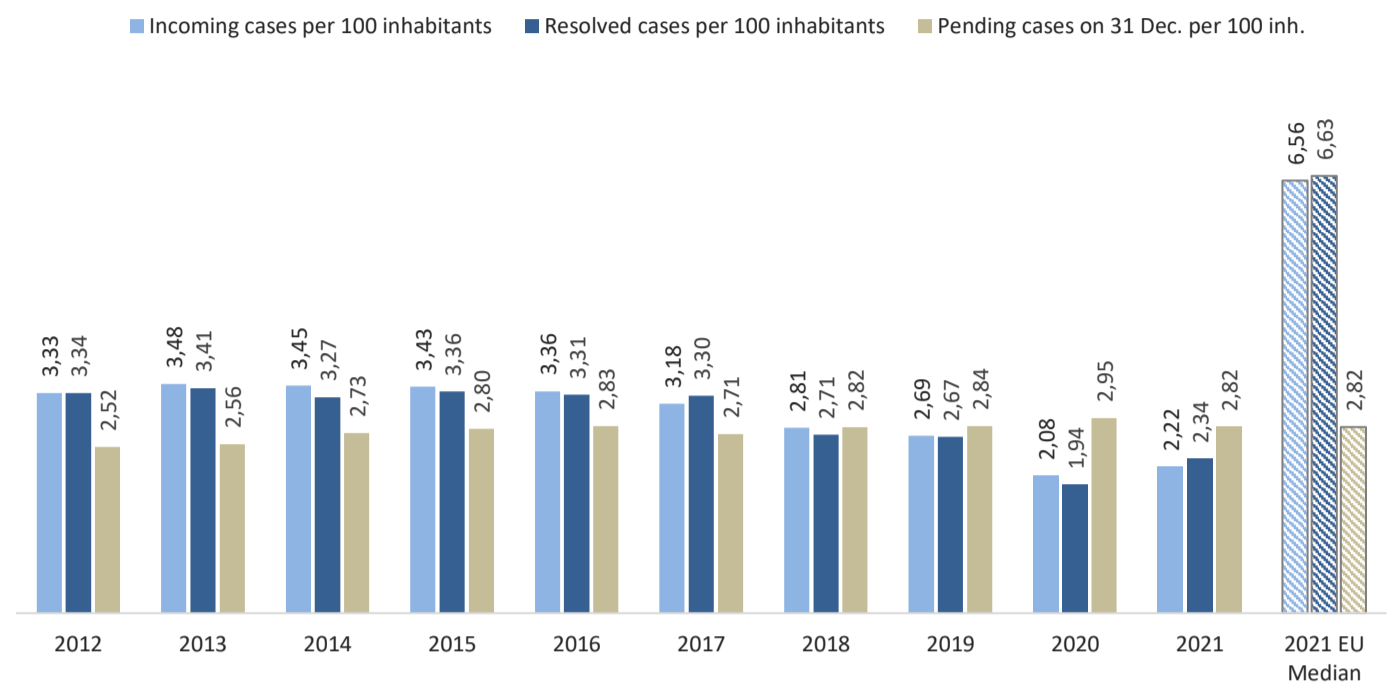

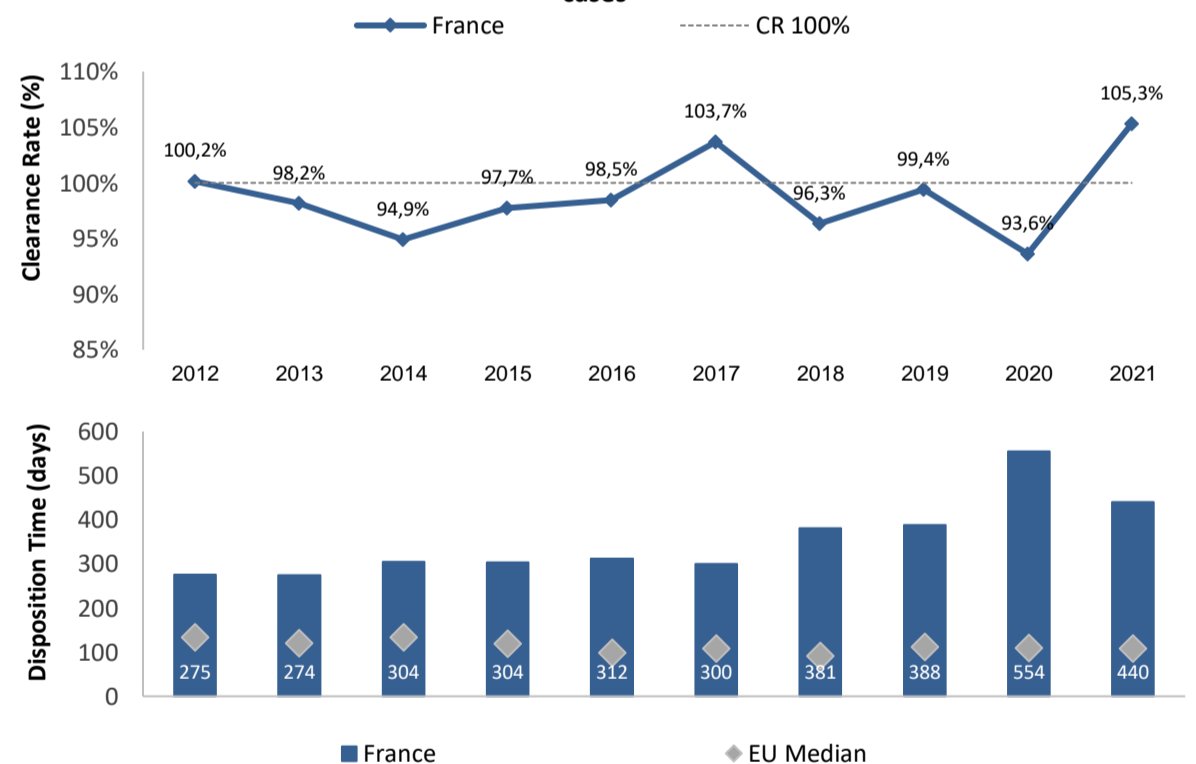

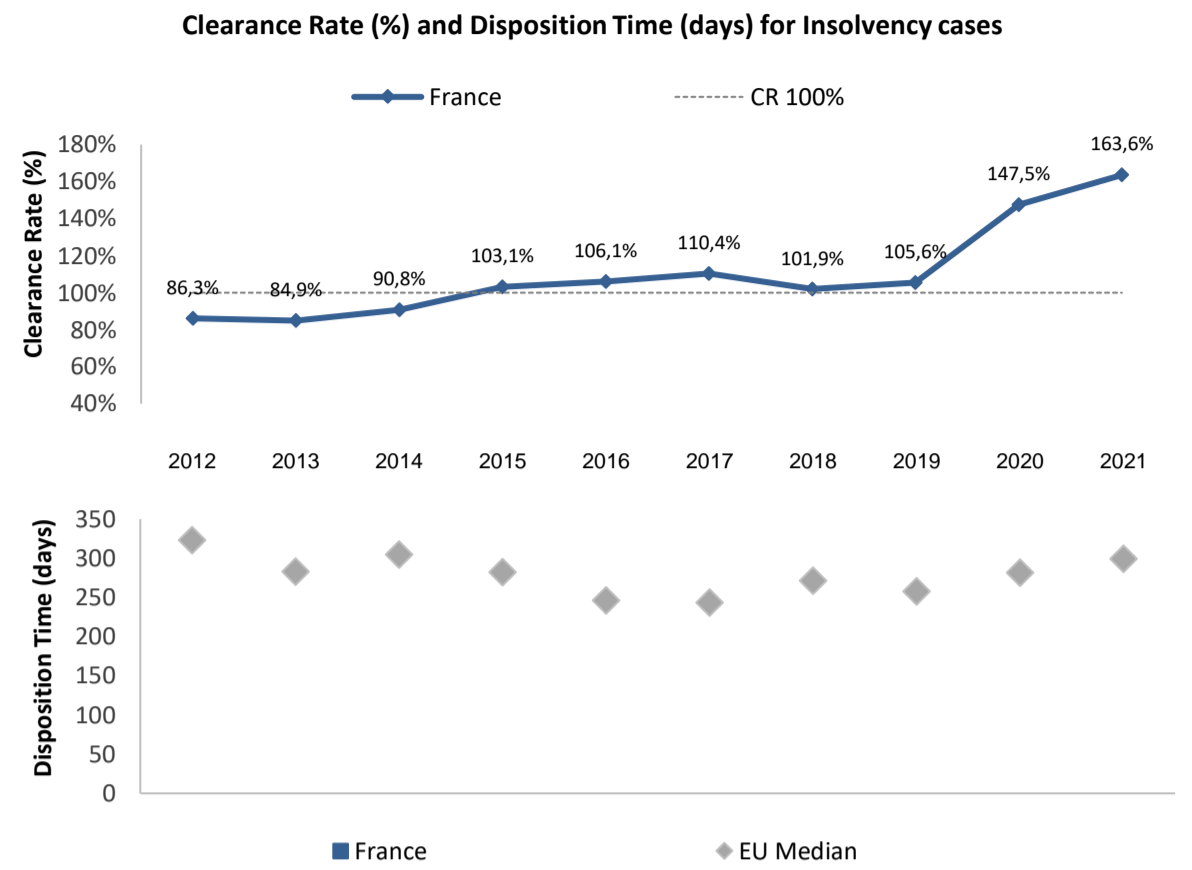

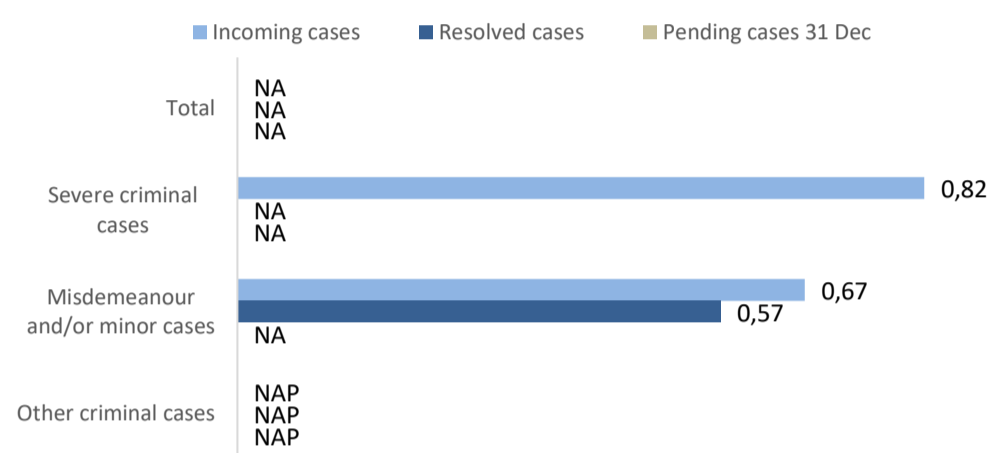

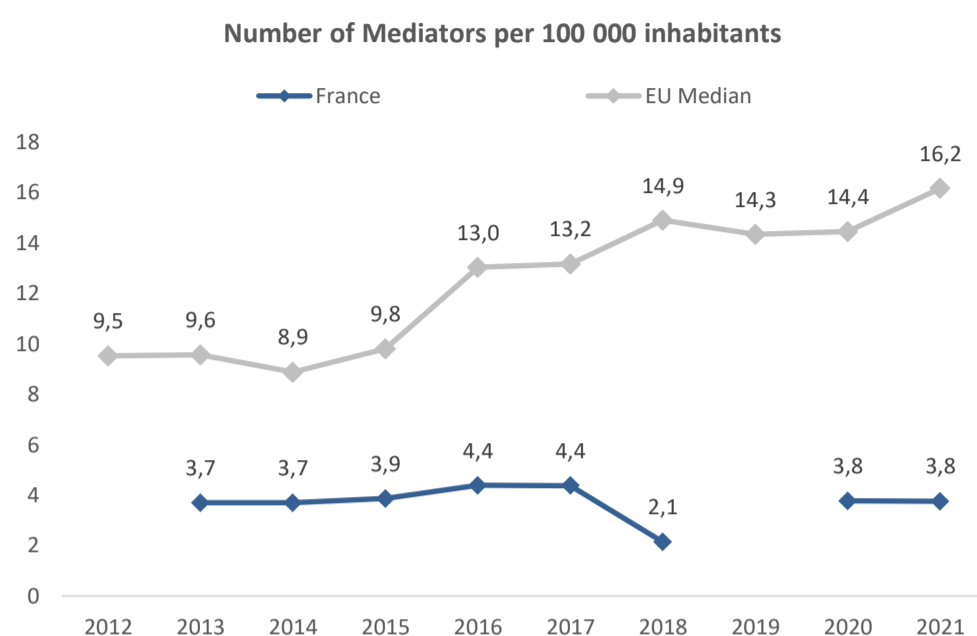

In criminal matters, mediation does not strictly speaking lead to a settlement. In fact, in the event of successful mediation, the public prosecutor's office will close the case on the grounds of successful "criminal mediation". If the mediation fails, the prosecutor's office takes over the prosecution, based on the opportunity principle, and can decide to prosecute the perpetrator in court.

It is useful to recall here that a voluntary project has been launched in the field of mediation at the initiative of the judge before the administrative courts, with each court having to reach a quantified objective of mediations proposed by the judge and accepted by the parties (but without any obligation to see these mediations lead to an agreement, which the court does not control. The objective is, over the period 2019-2022, to reach approximately 2000 mediations initiated by the judge before the administrative courts (i.e. approximately 1% of the entries of the TA and CAA).

In respect of non-judge staff, the Management and Distribution Tool for Civil Servants (OUTILGREF) was created in 1992. It has been online via the private Justice network since 2006. It measures the workload of registry officials (i.e. excluding legal assistants and specialised assistants) and assesses the need for registry staff (FTE) in the courts and regional administrative services (RAS). It also includes an assessment of the workload of the common or support services. A data collection exercise is carried out each year to feed it.

As regards judges and prosecutors, the answer is currently no. However, since December 2019, the Directorate of Judicial Services (DSJ) has been working on a more effective management tool to measure the activity of judges, based on a case weighting system (SPA). Operational case weighting tables should be available by the end of 2022 for the first instance, once the results of the survey conducted in the pilot courts have been analysed. These tables will be organised around jurisdictional activity but also support activity. During 2023, the weighting tables should be able to be translated into an IT application that will improve the administration of justice by strengthening the ministry's management capacities.

Once implemented, the information from the case weighting system will be used to allocate judges' workload more accurately between the various courts and, in the longer term, to better assess the need for judges and, more broadly, for judicial staff to deal with the activity of the courts and tribunals.

8. Systems for measuring and evaluating the performance of courts and public prosecution services in France (2021 data)

In France, quality standards are determined for the judicial system at national level (e.g. quality systems for the judiciary and/or judicial quality policies). Specialised personnel within the courts and the public prosecution services is entrusted with implementation of these national level quality standards.

Quality standards developed for public administration are used in the judicial system. The charter of the administrations thus sets the rules for the reception of litigants in all courts and can lead to certification. There are also local initiatives aimed at setting up a "quality system" based on certification by an external body, which consists in establishing procedures describing the reception process, the organisation of work and the management of a case.
