



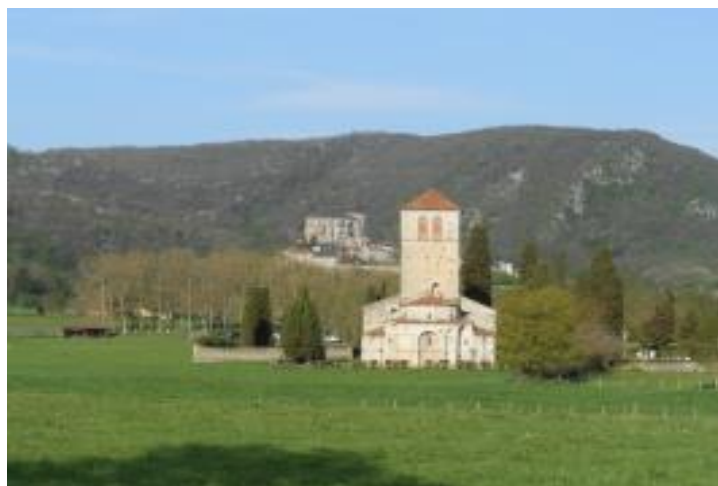

Le réseau Paysage a pour objectifs de participer à l'accompagnement, la mise en œuvre et la promotion de la politique du paysage en région. Ils se traduisent dans quatre domaines d'intervention :

- échanger, produire, former et informer

et se déclinent autour de trois thématiques :

- développement et appropriation des connaissances : atlas, observatoire et études
- professionnalisation des compétences : accompagnement, mobilisation et formation
- transfert et diffusion : échanges d'expériences et de savoir-faire

Il s'agit également de renforcer les échanges interprofessionnels et l'interconnaissance entre les acteurs du paysage : services de l'État, collectivités locales, institutions, organismes publics et professionnels.

Le fonctionnement du réseau repose sur trois instances de propositions : le comité de pilotage, le comité d'animation et la réunion plénière annuelle.

Une des spécificités du comité d'animation est d'associer, depuis 2010 sous la forme d'un partenariat, les universités et écoles supérieures de la région investies dans la formation et/ou la recherche sur les paysages, la culture et les territoires.

Le réseau associe des représentants des administrations et d'organismes publics et compte environ 400 membres. Il fédère plus d'une centaine d'institutions.

Des réalisations de nature variée

Les activités du réseau s'inscrivent dans un programme pluri-annuel, actuellement sur la période 2018-2021. Il se décline annuellement, après propositions et avis des différentes instances et des groupes de travail. Les principales réalisations en cours sont :

- organisation et/ou participation à l'animation de séminaires et de journées thématiques d'échanges (2 à 3 par an)
- contribution à la connaissance des paysages sur la région, au travers des atlas de paysage et des plans de paysage
- construction et alimentation d'un centre de ressources sur les sites Internet de la DREAL et de l'UR
- rédaction d'une lettre d'information trimestrielle, Paysage-info
- rédaction de dossiers thématiques
- création de plaquettes thématiques autour du paysage
- mise en place d'un plan de formation : journées et ateliers de terrain animés par des universitaires (workshop)
- création d'une plate-forme Observatoire régional des paysages : fédérer les observatoires existants (PNR, CAUE, PNP, Pays...), autour d'un projet commun et d'une architecture collaborative.

Animer pour échanger et se rencontrer

Le réseau constitue un vecteur privilégié d'échanges, de rencontres et de confrontations pour les nombreux acteurs des paysages en région. Il favorise ainsi leur mise en réseau au sein de groupes de travail qu'il réunit et anime pour approfondir les connaissances et développer une ingénierie collective; en organisant des journées d'échanges et des séminaires.

Produire et capitaliser des connaissances sur les paysages en région

Le réseau impulse la réalisation d'études et de travaux afin d'approfondir la connaissance des paysages en région et de mettre à disposition de tous des outils d'analyse et de compréhension des dynamiques et des enjeux paysagers. Il capitalise sur différentes thématiques les expériences et témoignages présentées au cours des journées d'échanges et des séminaires et les valorise sous la forme d'une collection de dossiers documentaires.

Accompagner et former

Le réseau contribue à la mise en place d'un plan régional de formation-compétence. Il organise des journées de terrain sur la base de dispositifs participatifs pour des formations collectives et inter-services. Il co-organise en tant que partenaire et intervenant des journées de formation avec le CVRH et le CNFPT, sur le thème paysages et aménagement du territoire.

Diffuser, relayer et informer

Le réseau diffuse une lettre trimestrielle, intitulée Paysage-info, et relaie les informations auprès de ses membres. Il réalise et diffuse des publications relatives à des sujets d'actualité et gère un espace dédié sur le site internet de la DREAL et sur le site de l'UR des CAUE d'Occitanie, constituant ainsi un espace collaboratif qui contribue à développer une culture commune favorisant l'esprit réseau.
