# I. Opening of the meeting and adoption of the agenda

Members are invited to review and adopt the <u>draft agenda</u>.

# II. Exchange of views with Snežana Samardžić-Marković, Director General of Democracy, Council of Europe

The Director General will have an exchange of views with the GEC in light of the current budgetary challenges the Council of Europe is facing and possible implications for the intergovernmental programme.

## III. Exchange of views with Dunja Mijatović, Council of Europe Commissioner for Human Rights

The GEC has held exchanges of views with the previous Commissioners for Human Rights. This will be the first exchange with Ms Mijatović since her appointment. The Commissioner has <u>gender equality and women's rights</u> among her priorities and often raises these issues on her country visits. Please see the Commissioner's <u>annual report</u> which includes some strong gender equality messages.

### IV. Draft 2020-2021 terms of reference of the Gender Equality Commission

Members are invited to examine and endorse the proposed <u>draft terms of reference</u> for the biennium 2020-2021.

## V. Council of Europe Transversal Programme on Gender Equality

### 1. Gender Equality Strategy 2018-2023

## a. Conference "Tackling Gender Stereotypes and Sexism" (Helsinki, 28-29 March 2019)

The conference rapporteur has delivered a <u>preliminary draft report</u> which will be developed further and finalised after the meeting on the basis of feedback from the members. Members are invited to discuss the report and any follow-up to be given to the conference.

### b. Objective 1 – Prevent and combat gender stereotypes and sexism

- Follow-up to the adoption by the Committee of Ministers of the Recommendation on preventing and combating sexism (CM/Rec(2019)1)

Members are invited to discuss ways in which the <u>recommendation</u> can be promoted in the member states.

# c. Objective 2 - Prevent and combat violence against women and domestic violence

- Exchange of views with Feride Acar, President of the Group of Experts on Action against Violence against Women and Domestic Violence (GREVIO)

Members are invited to take note of the observations of the <u>GREVIO</u> President and to engage in a discussion with her about issues of common concern. The time available for this exchange of views will not allow for members to provide extensive reports on their country's efforts to sign, ratify or comply with the Istanbul Convention. Discussion should be strategic and address, in particular, how the intergovernmental programme, gender mainstreaming and cooperation programmes can best complement the work of the GREVIO.

# d. Objective 3 - Ensure the equal access of women to justice

- Exchange of views on the way forward

Members are invited to contribute to the discussions on how to advance in the area of <u>access</u> to justice in line with this objective of the Gender Equality Strategy 2018-2023.

# e. Objective 4 - Achieve balanced participation of women and men in political and public decision-making

 Follow-up to the 2017 <u>analytical report</u> on the third round of monitoring on the implementation of Recommendation Rec(2003)3 of the Committee of Ministers on balanced participation of women and men in political and public decision-making

Members are invited to report back on any follow-up in their country on the <u>recommendations</u> (page 111) in the analytical report and to provide instructions/proposals to the Secretariat as to future work in this area.

# f. Objective 5 - Protect the rights of migrant, refugee and asylum-seeking women and girls

Factsheet on the rights of migrant, refugee and asylum-seeking women and girls

Members are invited to examine, comment and contribute to the <u>draft text of the factsheet</u> and agree to its publication. They are also invited to consider further steps towards implementing this objective of the strategy.

# g. Objective 6 - Achieve gender mainstreaming in all policies and measures Gender mainstreaming in Council of Europe activities

Members are invited to take note of the activities taking place in the area of <u>gender</u> <u>mainstreaming within the Council of Europe</u>.

### h. Committee of Ministers request for information and comments on Recommendations by the Parliamentary Assembly of the Council of Europe

- (i) <u>PACE Recommendation 2152 (2019) "Promoting parliaments free of</u> <u>sexism and sexual harassment</u>" and
- (ii) <u>PACE Recommendation 2155 (2019) "The situation of migrants and</u> refugees on the Greek islands: more needs to be done"

Members are invited to consider and adopt the <u>draft comments prepared by the Secretariat</u> on these two PACE recommendations, and instruct the Secretariat to transmit them to the Committee of Ministers.

# i. 2019 annual report on the implementation of the Gender Equality Strategy 2018-2023

A <u>modified structure</u> for annual reports was agreed at the meeting in December 2018. Members are invited to propose topics for the thematic section of the annual report for 2019. The members are reminded that the request for contributions to the annual report, including the template outlining each member state's activities and measures at the national level contributing to the achievement of the objectives of the strategy, will be sent out following the GEC meeting.

## VI. Co-operation activities

- Presentation by Marta Pietrobelli, Council of Europe expert, on capacity building and co-operation projects - making the implementation of the Istanbul Convention a reality

Marta Pietrobelli will present an overview of all the <u>co-operation projects</u> being carried out by the Gender Equality Division in the member states and beyond. This will be followed by a "project fair" (in the Hall between Rooms G04 and G05, 2<sup>nd</sup> Floor, Agora building) at which project managers will be available to explain over refreshments the aims and achievements of the projects.
