**Women represent** only 26% of parliamentarians in Council of Europe member States.

**Women represent** only 23% of ministers in Council of Europe member States.

**Women represent** only 25% of news subjects and 17% of experts in media in Europe.

1 in 3 women in Europe has experienced some form of physical and/or sexual assault since the age of 15.

1 in 10 women in Europe has experienced some form of sexual violence since the age of 15, and 1 in 20 women has been raped since the age of 15.
