- 1921 Partition of Ireland and creation of Northern Ireland
- 1953 Prison Act
- 1969 Start of the Troubles
- 1982 Probation Board for Northern Ireland established
- 1995 NIPS becomes an agency
- 1998 Belfast (Good Friday) Agreement
- 2000 Criminal Justice Review
- 2010 Devolution of Justice
- 2011 Owers Review of NIPS
- 2019 Joint Presentation to Council of Europe

Conflict









Impact of conflict

- Nearly 4,000 people murdered from 1969 to 2019
- 31 Prison Officers/Staff murdered from 1974 to 2016 (including 10 in 1979)
- 1981 Hunger strikes
- 1983 Maze breakout
- 1998 Release of conflict related prisoners
- 2015 Bomb attack on PBNI office in Derry/Londonderry
- 2017 Increase in threat level to PBNI
- 2019 Reduction in threat level to PBNI

2000 Criminal Justice Review

- NIPS and PBNI to remain separate organisations
- Prisons had had become highly contentious battlegrounds over the course of the 'Troubles'.
- Community ethos and credibility achieved by PBNI would be at risk if amalgamation took place.
- Noted the NIO Policy of criminalization had removed 'Special Category' status of prisoners convicted of conflict-related offences.

Recommendations

- Greater co-operation at management level, staff interchange, joint training programmes and offending behaviour programmes.
- Acknowledgement that Northern Ireland has different characteristics from other jurisdictions (2003 Carter Report & establishment of NOMS in England & Wales)
- PBNI to become an agency when NI Executive has responsibility for Justice.



- Period of transition from conflict has seen ongoing process of 'Normalisation'
- 1996 Criminal Justice Order both organisations moving towards public protection function & multiagency approach.
- 2003 Murder of Attracta Harron
- 2008 Criminal Justice Order establishment of Parole Commissioners, Public Protection Sentences & concept of 'Whole Sentence' tariff (Custody & Community – removal of automatic 50% remission.

Review of NI Prison Service 2011 – Dame Anne Owers



Five High Level Recommendations

- Agreement & ownership of the vision safer society international best practice and human rights/Council of Europe rules
- 2. Properly resourced Change Programme.
- 3. Governance, Accountability & Performance measures
- 4. Staff Development Package Early Retirement Scheme, Recruitment and Progression, External Training.
- 5. Improved and consistent procedures focus on dynamic security.

"The Prison-Probation partnership can and should develop much further without threatening the operational independence and different traditions of the two services"

40 Recommendations

30 – Prisoners to have personalised sentence plan based on needs, strengths and risks.

- 31 NIPS & PBNI to undertake joint work to plan and deliver integrated services.
- 32 NIPS to recruit a Director of Rehabilitation
- (incorporating education, work and skills training).

Main focus on the pressing need for prison reform – seen as costly and over-securitized.

Expansion of PBNI Role

- Practice Standards and need to balance public protection and professional judgement /discretion.
- Retention of social work as core qualification for Probation Officers
- Importance of community based Board & partnerships with Voluntary and Community Sector.
- Leadership of cross-border Public Protection Advisory Group

Recent Examples of Innovation

- Victims and Restorative Interventions
- Enhanced Combination Orders alternative to short prison sentences.
- Problem Solving Justice Substance Misuse, Domestic Violence & Mental Health
- Use of technology including PBNI mobile phone app made available to prisoners on release & those in community

Challenges for prison service Complaints to Prisoner Ombudsman for 'Severe' threat to lives of serving prison Northern Ireland triple officers in Northern Ireland Maghaberry Prison 'not safe' Child killer dies in prison says chief inspector **Belfast's Hydebank Wood** prisons 'not good enough'

Challenges for Probation

- Funding for projects on short term basis
- Increase in complexity of cases including rise in complexity of mental health issues
- Lack of legislative assembly and NI executive

Lessons Learned

- History of Northern Ireland
- Importance of relationships, responsibility and respect
- Risks from terrorism/politically motivated offending/radicalisation
- Learning from others PPAG, Council of Europe & CEP

NI Programme for Government 17-21

- Outcome 7 To create a safer Northern Ireland where we respect the law and each other.
- Prisons 2020 document acknowledges unique partnership between NIPS & PBNI – revised language 'People in our care'
- Recent Inspections have highlighted excellent joint working (Resettlement May 2018 and Maghaberry Prison November 2018)
- Learning from others PPAG, Council of Europe & CEP
