Impact of war on Protected Ares in Ukraine



- 1426 Protected areas affected
- Contamination by UXO and land mines: ca. 1.1 million ha
 - 5 Nature Reserves (14 197 ha)
 - 3 Biosphere Reserves (334 217 ha)
 - 15 National Parks (270 098 ha)
 - 15 Landscape Parks (125 972 ha)
 - 739 Biotopes (328 537 ha)
 - Other protected areas (27 406 ha)



Main impacts of the war on fire management and local communities



- Threat for life of foresters and population dependent from non timber forest products
- Cases of fatalities due to UXO of forests visitors
- Fire aviation, detection by cameras, use of UAV, patrolling prohibited due to security or safety reasons.
- Long-term (decades) contamination with UXO (shelling, mines, bombing, incl. cassette, rockets)
- Contaminated areas not accessible for forestry, fire management (prevention / suppression / detection), pest management etc.
