L'opportunité de la mise en place d'une politique globale sur le paysage a été donnée par la ratification de la Convention européenne du paysage, devenue la loi 3827/2010. À cette occasion, et compte tenu de l'évaluation – révision des Plans Régionaux de l'Aménagement du Territoire qui était en cours, des 12 Régions de la Grèce, il a été prévu d'intégrer, dans cette révision, la dimension paysagère .

L'intégration horizontale du paysage à l'aménagement du territoire permet aussi une meilleure gestion et protection de la nature et du patrimoine culturel. L'approche paysagère implique l'examen à la fois des changements physiques, et culturelles dans l'espace et dans le temps.

Ainsi en tenant en compte la dimension paysagère, l'aménagement du territoire peut aller plus loin dans ses objectifs environnementaux, économiques ou sociaux. Nous avons donc intégré en Grèce la dimension paysagère dans les instruments d'aménagement du territoire surtout au niveau régional et local.

À travers cette approche le paysage est traité comme une ressource en matière du développement régional, renforçant la compétitivité entre régions, et constituant en même temps, non seulement, un avantage pour chaque région mais pour l'ensemble du pays.

Η ελληνική έννομη τάξη είχε από μακρόν ανταποκριθεί στην αναγκαιότητα σεβασμού της φύσης, όχι μόνον υπό την έννοια του φυσικού περιβάλλοντος (πανίδα, χλωρίδα, δασική βλάστηση, γεωμορφολογικοί σχηματισμοί), αλλά και για λόγους αισθητικούς (αισθητική, ψυχική υγιεινή, απόλαυση και ανάπαυση), πολιτιστικούς, εθνικής οικονομίας (τουρισμός). Η προστασία ανάγεται τόσο σε επίπεδο Συντάγματος, όσο και κοινής νομοθεσίας, με έτος εκκίνησης το 1938.

Θα ακολουθήσουν ο ν.1469/1950, που εισήγαγε την έννοια των τόπων ή έργων «χαρακτηριζομένων ως ιδιαίτερου φυσικού κάλλους» (ΤΙΦΚ), και προέβλεψε γι' αυτά καθεστώς προστασίας σύμφωνα με τις διατάξεις του Αρχαιολογικού Κώδικα (ν. 1469/1950 (Α169) άρθ.1 και κ.ν.5351/1932). Η αρμοδιότητα χαρακτηρισμού, υπαγόμενη αρχικά στο Υπουργείο Προεδρίας της Κυβερνήσεως, μεταφέρθηκε το 1984 στο τότε ΥΠΕΧΩΔΕ, σύμφωνα με την κρατούσα άποψη ότι το περιβάλλον (φυσικό και πολιτιστικό) συνιστά ενιαίο έννομο αγαθό, εκφάνσεις του οποίου αποτελούν οι εν λόγω τόποι. Έπονται τα ν.δ. 8/1969 και 996/1971 (ν.δ. 8/1969 (Α7) Δασικός Κώδικας, άρ.78 «Εθνικοί δρυμοί, αισθητικά δάση και διατηρητέα μνημεία της φύσης», όπως διαμορφώθηκε με ν.δ.996/1971), που υιοθετούν δύο νέες κατηγορίες προστατευόμενων περιοχών:

Το Σύνταγμα του 1975-1986/2001 εμφύσησε νέα πνοή στην προστασία του περιβάλλοντος, την οποίαν ανήγαγε σε Συνταγματικά προστατευόμενα αξία και υποχρέωση του κράτους. Σε αρμονία με τις Συνταγματικές επιταγές και νέες αντιλήψεις, ο ν.1650/1986 (ν. 1650/1986 (Α160) «για την προστασία του περιβάλλοντος» άρ.1,2,18,19,21, και ο ν.3937/2011(Α60) «Διατήρηση της βιοποικιλότητας»), προσέγγισε την έννοια «περιβάλλοντος» ως «το σύνολο των φυσικών και ανθρωπογενών παραγόντων και στοιχείων, τα οποία ευρίσκονται σε αλληλεπίδραση και επηρεάζουν την οικολογική ισορροπία, την ποιότητα ζωής, την υγεία των κατοίκων, την ιστορική και πολιτιστική παράδοση και τις αισθητικές αξίες». Αναγνώρισε την προστασία του περιβάλλοντος ως «θεμελιώδες και αναπόσπαστο μέρος της πολιτιστικής και αναπτυξιακής διαδικασίας και πολιτικής» και θέσπισε ιδιαίτερο προστατευτικό καθεστώς.

Επίσης μια συγκεκριμένη μεθοδολογία για την προστασία του τοπίου από τα αιολικά πάρκα εγκρίθηκε από το Ειδικό Πλαίσιο Χωροταξικού Σχεδιασμού και Αειφόρου Ανάπτυξης για τις Ανανεώσιμες Πηγές Ενέργειας (ΑΠΕ) το 2008. Το ειδικό πλαίσιο των ΑΠΕ είναι ένα παράδειγμα του χωροταξικού σχεδιασμού εθνικής κλίμακας, και προωθεί την παραγωγή ηλεκτρικής ενέργειας από ΑΠΕ, και τον μετριασμό των αρνητικών επιπτώσεων στο περιβάλλον.

Η κύρωση της Ευρωπαϊκής Σύμβασης του Τοπίου, έγινε με τον νόμο υπ.αριθ. 3827 (ΦΕΚ Α 30/25.2.2010). Με την αφορμή αυτή και δεδομένης της χρονικής συγκυρίας της αξιολόγησης αναθεώρησης των Περιφερειακών Πλαισίων Χωροταξικού Σχεδιασμού και Αειφόρου Ανάπτυξης (ΠΠΧΣΑΑ) των 12 Περιφερειών της χώρας, ενσωματώθηκε ένα κεφάλαιο που αφορά στην πολιτική και διαχείριση του τοπίου στις προδιαγραφές της αξιολόγησης-αναθεώρησης των Περιφερειακών Πλαισίων. Στόχος της προσπάθειας αυτής είναι στα αναθεωρημένα Περιφερειακά Πλαίσια να υπάρχει μια ολοκληρωμένη και εξειδικευμένη προσέγγιση στα θέματα του τοπίου, η οποία θ' αναγνωρίζει στο χώρο κάθε Περιφέρειας τοπία ιδιαίτερης σημασίας, στα οποία θα επιδιωχθεί κατά προτεραιότητα η εφαρμογή συντονισμένων δράσεων ανάδειξης και διαχείρισης. Το τοπίο, αντιμετωπίζεται σαν πόρος περιβαλλοντικού και αναπτυξιακού σχεδιασμού, αποτελώντας συγκριτικό πλεονέκτημα της χώρας.

des Changements Climatiques, 2011). L'objectif de cet effort est d'avoir dans les nouveaux (révisés) plans régionaux une approche intégrée et spécifique en matière de paysage. Ainsi dans chaque région il y aura l'identification des « paysages de grande importance » auxquelles seront désignées, en priorité, des actions pour leur mise en valeur et leur gestion. A travers cette approche le paysage est traité comme une source en matière du développement régional, constituant en même temps, non seulement, un avantage pour chaque région mais pour l'ensemble du pays.
