## **List of decisions adopted at the 33rd meeting (18-21 June 2024)**

**1. Agenda Item 2: Adoption of the agenda and order of business**

GREVIO adopted its draft agenda (see Appendix) and draft order of business.

**2. Agenda item 4: Adoption of the report of GREVIO's 32<sup>nd</sup> meeting and matters arising**

GREVIO adopted the draft report of its 32<sup>nd</sup> meeting (document GREVIO(2024) RAP32-prov). The final meeting report appears as document GREVIO(2024)RAP32.

**3. Agenda item 8: Adoption of the 5<sup>th</sup> General Report on GREVIO's activities**

GREVIO approved its fifth general report of activities, covering the period from 1 January to 31 December 2023. The report will be published in the course of 2024.

**10. Agenda item 15: Approval of the preliminary draft report on Sweden**

GREVIO approved the preliminary draft report on Sweden, as amended. In accordance with Article 68, paragraph 10 of the Convention, the draft report will be transmitted to the national authorities for comments. In addition, and in accordance with its Rules of Procedure (Rule 43), GREVIO agreed to set a time-limit of two months to receive comments.

**11. Agenda item 19: Designation of rapporteurs**

Having regard to GREVIO's planned schedule for the upcoming evaluation procedures of parties to the Convention, GREVIO designated two rapporteurs, and one substitute rapporteur, for the first thematic evaluation procedures in respect of Andorra, Belgium, Bosnia and Herzegovina, Estonia, Malta, Poland, Romania, San Marino and Slovenia. It also appointed two rapporteurs and three substitute rapporteurs for the baseline evaluation procedure to Ukraine, two rapporteurs and one substitute rapporteur for the baseline evaluation procedure to Latvia and 3 rapporteurs and one substitute rapporteur for the baseline evaluation procedure of the European Union.

**12. Agenda item 23: Dates of the next meeting**

GREVIO decided to hold its 34<sup>th</sup> meeting from 15-18 October 2024 in Strasbourg, and its 35<sup>th</sup> meeting, from 25 to 28 March 2025 and 1 to 4 July, also in Strasbourg.
