# WORKING GROUP ON CIVIL SOCIETY PARTICIPATION (GT-CS)

**REPORT OF THE 2nd MEETING** 

(Online meeting, 2 October 2024)

The CDDEM Working Group on Civil Society Participation (GT-CS) held its 2nd meeting on 2 October 2024 (by videoconference via Zoom – 09:30-17:30). The meeting was facilitated by the CDDEM Secretariat (Secretary Ms Urška Umek) with the approval of the GT-CS, pending the election, during the 2nd plenary meeting of the CDDEM, of Committee Chair, Vice-Chair, and the subsequent election of Working Group Chair, Vice-Chair and Bureau.

#### 1. Opening of the meeting and adoption of the agenda

The Secretariat opened the meeting and welcomed all participants, the list of which appears in Appendix I of this report. The agenda was adopted as it appears in Appendix II.

## 2. Discussion of the revised draft Guidance Note on civil society participation in the intergovernmental work of the Council of Europe

The members and participants of the GT-CS examined the revised text of the draft Guidance Note in detail; they reviewed individual comments made on the text during the last revision and discussed their implications. Members and participants commented on the Secretariat's drafting proposals and sought the most appropriate solutions to the outstanding issues.

Prior to the meeting of the Working Group, the Secretariat had received proposals and comments from several delegations (Belgium, Finland, Greece, Romania, United Kingdom), from the secretariats of other Steering Committees and Council of Europe bodies and services (Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI), Children's Division, Directorate of Programmes and Budget, Directorate General of Human Rights and Rule of Law, Civil Society Unit), as well as from twelve member organisations of the Conference of INGO's of the Council of Europe (CINGO)), which were either already included in the text or whose inclusion was to be discussed during the meeting. The GT-CS discussed each comment in turn.

The discussion focused on the scope of the document and whether it was advisable to include references to specific groups (such as children) or specific issues (such as environmental protection). Several members felt that the inclusion of references to specific groups and/or issues risked excluding other groups and thus limiting the scope of the text. The GT-CS also discussed the scope of the Guidance Note, which is only applicable to intergovernmental committees, but could also serve as an inspiration for other Council of Europe structures in their engagement with civil society. A number of suggestions were made to reinforce the importance of consistent approaches and clarity for the benefit of civil society, and an addition to this effect was proposed to be finalised at the CDDEM plenary. The members of the Working Group also discussed a proposal to call for a single information point for civil society actors with easily accessible information and different ways to engage with the Council of Europe. However, as a civil society portal already exists, the text rather emphasised the importance of providing substantive information on opportunities for civil society participation. In this context, the Directorate for Programmes and Budget proposed an addition, which was included in the introductory text, mentioning the different possibilities for civil society to cooperate with intergovernmental committees under the existing rules.

With regard to the guidelines part of the Guidance Note, their structure was slightly modified, in particular because it was agreed that, in order to respect the different mandates of the different Council of Europe structures, the Note should be limited to substantive issues, while refraining from calling for specific changes to existing instruments. It was also decided not to broaden the scope by including in the text the possibility for National Human Rights Institutions (NHRIs) to contribute to the exchange of information about the Organisation; however, it was accepted to include a guideline encouraging regular dialogue with civil society at the national and sub-national levels with a view to exchanging views on topical issues related to the activities of the Council of Europe. Members agreed to include a provision on the possibility for civil society to participate in the work of intergovernmental committees and subsidiary bodies, in order to express their views, including critical ones, freely and without fear of repercussions. One delegation drew attention to the possibility that individual civil society organisations could pose a risk to legitimate interests of member states, such as national security or public order concerns. Some text was redrafted to reflect the conclusions of the Working Group and some parts were repositioned between different sections to better reflect the logic of the Guidelines. The Secretariat

made several drafting proposals during the meeting in order to finalise the text as far as possible and proposed to make further drafting proposals after the meeting, in line with the agreed orientations, for consideration and finalisation at the CDDEM Plenary.

# 3. Discussion of the draft Feasibility Study on updating Recommendation CM/Rec(2007)14 of the Committee of Ministers to member States on the legal status of non-governmental organisations in Europe

At its first meeting in July 2007, the GT-CS had mandated Mr Jeremy McBride, Council of Europe consultant and President of CINGO's Council of Experts on NGO Law, to prepare a feasibility study on updating Recommendation CM/Rec(2007)14 of the Committee of Ministers to member States on the legal status of non-governmental organisations in Europe. The resulting draft Feasibility Study had been circulated to the GT-CS in advance of the meeting for review and comments at the meeting.

Mr McBride presented the draft text, which received general approval from the Working Group members, who expressed their satisfaction with the quality of the document. Mr McBride addressed the structure of the study, as well as issues which were covered in the original Recommendation but which would need to be further addressed in the revised text, and finally possible additions to be made in the context of a new Recommendation to replace CM/Rec(2007)14. In the ensuing discussion, it was stressed that the new text should not weaken the achievements of the original Recommendation in terms of the level of protection of civil society organisations and their ability to operate. Mr McBride considered that about two thirds of the original Recommendation was still valid and should therefore be incorporated into the new text without significant changes.

The Secretariat reiterated the need to reach a basic agreement on the aim, form, direction and content of the feasibility study so that it could serve as a useful basis for updating the Recommendation. The Working Group then discussed some of the issues raised in the study, such as the need to further differentiate between "lobbying" and "advocacy" in the context of civil society activities. The GT-CS agreed to review certain aspects of the text and asked the consultant to provide drafting suggestions in writing.

#### 4. Next steps

Regarding the draft Guidance Note on civil society participation in the intergovernmental work of the Council of Europe, the GT-CS agreed that the Secretariat would revise the text in accordance with the conclusions and orientations expressed during the meeting, and send it to members with the possibility of making final suggestions before or at the 2nd Plenary meeting of the CDDEM.

Concerning the draft Feasibility Study on updating Recommendation CM/Rec(2007)14 of the Committee of Ministers to member States on the legal status of non-governmental organisations in Europe, the GT-CS agreed to provide possible further written comments and suggestions until 15 October, upon which they would be taken into account for the revised text to be presented during the 2nd Plenary meeting of the CDDEM. Comments and suggestions submitted past this date would be considered at a later stage.

With regard to the third task before the GT-CS, namely to contribute to the review of the implementation of Recommendation CM/Rec(2018)11 of the Committee of Ministers to member States on the need to strengthen the protection and promotion of civil society space in Europe, to be prepared by the Steering Committee for Human Rights (CDDH), several delegations provided good practices pertaining to their national and/or sub-national legal framework and practices. The Secretariat informed the members of the GT-CS that in addition, a brief overview of the results of recent studies by the CINGO Expert Council on NGO Law was being prepared for possible inclusion as a CDDEM contribution and would be circulated by 10 October, prior to the CDDEM Plenary meeting.

#### 5. Any other business

None.

#### 6. Date of the next meeting

The decision on the date of the next meeting (2025) of the Working Group was postponed until after the election of CDDEM and GT-CS Chairs, Vice-Chairs and Bureaus during the 2nd plenary.
