# WORKING GROUP ON DEMOCRACY AND TECHNOLOGY (GT-DT)

### **MEETING REPORT**

#### **VIDEOCONFERENCE MEETING**

#### 24 September 2021

## 1. Opening of the meeting and adoption of the agenda

The Chair, Mr Almir Šahović (Bosnia and Herzegovina), welcomed the members of the Working Group to the 5<sup>th</sup> meeting. The list of participants can be found in Appendix I. The agenda was adopted as it appears in Appendix II.

Mr Dan Popescu, Head of Democracy and Governance Department, introduced and welcomed Ms Alina Tatarenko who had been appointed Head of Division Democratic Governance and Secretary to the CDDG.

# 2. Draft Committee of Ministers' guidelines on the use of new technologies in the different stages of the electoral process

The <u>Recommendation CM/Rec(2017)5 on standards for e-voting</u> and its guidelines for implementation provided the background for the current draft guidelines. In fact, the draft guidelines were meant to complement the existing standards.

The three expert consultants (Ms Ardita Driza Maurer, University of Zurich, Zentrum für Demokratie Aarau, Switzerland; Mr Robert Krimmer, ERA-Chair Full Professorship of e-Governance, Skytte Institute, University of Tartu, Estonia; and Ms Melanie Volkamer, Karlsruhe Institute of Technology, Germany) presented the final draft guidelines which currently consisted of an introduction, 12 provisions and a glossary.

The experts highlighted that the main goal of the draft guidelines was to provide member States with a practical and comprehensive tool to think through and plan the use of ICT solutions in electoral processes – if they decided to introduce ICT solutions. The draft guidelines should not suggest that ICT solutions must be introduced.

Ms Driza Maurer pointed out that the draft guidelines were conceptualised to apply to all stages of the processes (with the exception of e-voting and e-counting) and cover a broad range of ICT solutions. Thus, the draft guidelines were general, not going into details, in order to be useful in a maximum of cases. Mr Krimmer explained that the draft guidelines were meant to offer member States an orientation, if and when they decided to introduce ICT solutions.

Ms Driza Maurer thanked member States for their comments and feedback to the previous draft and outlined the main changes. Elaborating on the concept of assumption used in Guideline 1, Ms Volkamer explained that e.g., in the context of security member States should in particular be aware of a) assumptions made about an attacker's capabilities and b) assumptions made about the trustworthiness of those who have access to encryption keys, and that these assumptions would then be evaluated in the context of the risk assessment.

Overall, members welcomed the draft guidelines. The discussion centred around the following issues: security, accessibility and usability, as well as balancing conflicting or competing guidelines.

With regards to the issue of **security**, members emphasised the importance of taking a security by design approach. Members expressed that security concerns needed to be made more prominent in the draft guidelines, as security should not be treated as an after -thought in the design process. To this end, it was suggested to include an explicit mention of security in the introductory part on general principles.

Members stressed that **accessibility** and **usability** were two distinct concepts, and the draft guidelines should reflect this better.

With regards to conflicting principles, members suggested that the question of transparency v. secrecy should also be mentioned in Guidelines 7.

In addition, members raised the question of financial resources and the costs of introducing ICT solutions.

With regards to the glossary, members suggested that the definitions of usability, accessibility and assumptions needed to be further elaborated to clarify the intended meaning, and to avoid giving the impression that achieving digital security is dependent on making assumptions, rather than a proportionate response to risk analysis.

The Secretariat pointed out that the draft guidelines would be submitted for editorial review to ensure consistency with Council of Europe language.

#### 3. Conclusions

The draft guidelines were adopted in substance. It was agreed that final suggestions should be sent in writing to the Secretariat by 5 October 2021. The draft guidelines would thereafter be reviewed by the Bureau prior to being submitted for adoption at the 14<sup>th</sup> CDDG plenary meeting on 29-30 November 2021.

#### 4. Other business

The Secretariat announced that the review meeting on the implementation of Recommendation CM/Rec(2017)5 on standards for e-voting would be held during the plenary. A questionnaire had been sent out to member States and the Secretariat had already received several replies. The Secretariat encouraged member States to send in their replies.

The Secretariat informed about an online conference on AI regulations which would take place on 26 October 2021 under the auspices of the Hungarian presidency to the Council of Europe. A save the date would be sent out.
