WORKING GROUP ON ACCOUNTABILITY (GT-RE)

REPORT OF THE 2ND MEETING

28-29 September 2020, held by videoconference

1. Opening of the meeting

The Chair of the Working Group, Mr Paul-Henri PHILIPS (Belgium, Region of Brussels-Capital), opened the meeting and welcomed the participants of the Working Group. The list of participants is set out in Appendix I.

2. Agenda

The agenda was adopted as set out in Appendix II.

3. Information by the Secretariat

The Secretariat recalled the state of play following the GT-RE's first meeting on 13-14 February 2020. Videoconferencing would allow to pursue the work despite the pandemic, so that the CDDG could be in a position to discuss the draft recommendation and accompanying report by the end of 2021, as foreseen by the terms of reference. The GT-RE might hold one or two more meetings in 2021, depending on the workplan and budget, and written consultations could be explored should the need arise.

As previously announced, a restricted access webpage¹ had been set up to gather working documents in one place and to enable members to upload documents and share information also in between meetings.

4. Drafting a recommendation on the democratic accountability of elected officials and bodies at local and regional level

The Chair recalled that according to the terms of reference, the legal instrument to be drafted will need to complement Recommendation $\underline{\mathsf{CM/Rec}(2019)3}$ on the supervision of local authorities' activities and to update previous work in this area. The GT-RE had agreed at its 1st meeting to follow a broad approach as regards the concept of democratic accountability of local and regional elected officials and bodies (not strictly limited to mechanisms focused on the direct intervention of citizens). This could also lead to a reflection concerning national elected officials.

Other background instruments to be borne in mind include:

- the Report on the recall of mayors and local elected representatives, adopted by the Council for Democratic Elections (65th meeting, Venice, 20 June 2019) and by the Venice Commission (119th Plenary Session, Venice, 21-22 June 2019), CDL-AD(2019)011rev;
- Recommendation No. R (99)8 of the Committee of Ministers on the financial liability of local elected representatives for acts or omissions in the course of their duties;
- Report on Liability of local elected representatives for acts or omissions in the course of their duties (CDLR, 1998);
- Recommendation No. R (84)15 of the Committee of Ministers relating to public liability.

In light of the discussions held by the GT-RE, the Secretariat, with the assistance of scientific experts, would prepare a preliminary draft Recommendation and accompanying report for consideration by the GT-RE at its next meeting(s) in 2021.

A questionnaire had been circulated in the summer to collect information from all CDDG member countries with regard to a broad range of accountability mechanisms (democratic, political, administrative, financial) and liability mechanisms (criminal, pecuniary). 20 countries had provided responses. The compilation of these (document GT-RE(2020)5) will be updated with further replies. The agenda of the 2nd meeting was structured along the various mechanisms of accountability.

In his presentation, Mr Duranthon referred notably to the following:

• there was a need to refine certain definitions; concerning the object, purpose and structure of the Recommendation: there was a narrow meaning usually associated with "responsabilité" in French and possibly other languages, whereas in English the concept of accountability has broader implications ("redevabilité" might thus be a better equivalent); the future instrument would have to clarify in which cases the individual, the public body or the local/regional community as a legal person bears the weight of accountability and/or liability; there did not seem to be a real need to distinguish between local and regional mechanisms

• the various forms of accountability raised issues to be addressed by the Recommendation: as regards financial and criminal liability, criteria were important to set limits to the individual liability of elected officials; financial accountability raised a number of questions: should it be administrative or judicial? Should it have criminal and/or political consequences? Was it aimed at the self-governing community or elected representatives? Should one party be held solely criminally liable, particularly in the event of wrongdoing?

Mr Teles pointed out the following:

- accountability at the local and regional level had gained more and more interest
 in the scholarly and political debate during the last 20 years in Europe. Declining
 trust in political institutions as well as the emergence of new governance
 institutions had highlighted the need to provide for, and review existing
 accountability mechanisms of core policy makers. Public administration reforms
 had also led to new players from the private and third sectors being involved in
 the policy and governance area, leading to new accountability challenges
 (intermunicipal associations, quangos etc). The variety of local tasks and of
 collaborative arrangements in service delivery called for different (combinations
 of) mechanisms of accountability;
- the drive for greater accountability had been pursued in particular through enhancing openness and transparency and by clarifying the lines of responsibility and division of work between the different bodies; accountability required two conditions: standards to follow and the availability of information (in order to check compliance) – hence the importance of disclosure policies and adequate rules on access to information;
- important prerequisites had to be borne in mind, e.g. the proportionality of accountability mechanisms and their consequences, as well as the need for clear standards and procedures.

The ensuing discussions concerning the various forms of accountability were summarised by the Secretariat:

- a revision of accountability mechanisms appeared to be justified by a number of factors including the lack of trust of citizens, the evolution of administrative structures, the trend towards more transparency and information and all forms of accountability mechanisms appeared to be important also in the light of the 12 Principles of good Democratic Governance;
- the concept of "democratic accountability" was still a source of confusions and needed to be understood as the democratic <u>forms of</u> accountability. It was clear that accountability concerned both the actions and inactions;

- some forms of accountability needed to be considered together: democratic and political accountability were a direct / indirect form of the same mechanism. In this context, the differences between the concepts of voters, citizens and population more broadly (possibly including foreigners and civil society organisations) had to be borne in mind. Some mechanisms needed perhaps to be renamed, e.g. financial liability;
- certain factors were instrumental, in particular: transparency in the action of local
 / regional elected bodies (including as regards the application of accountability
 mechanisms); access to information including on the basis of the Council of
 Europe Convention on Access to Official Documents CETS 205, the European
 Charter of local self-government and its additional protocol CETS 122 and CETS
 207; training and awareness-raising of elected officials and the population on their
 respective rights and obligations with respect to accountability;
- likewise, proportionality, clear rules / circumstances / consequences, guarantees
 against arbitrariness etc. were important considerations in a context of increasing
 fears of elected officials and preserving the rule of law (e.g. predictability of rules,
 effectiveness of mechanisms etc.);
- the work of other bodies needed to be taken into account (e.g. the Venice Commission);
- the diversity of functions associated with certain elected officials needed to be borne in mind, e.g. a mayor is also possibly part of the public / State administration as well as the head of a local administration, the chair of a local elected council and s/he could as well exert a national mandate in addition (e.g. as a member of parliament enjoying immunity).

4. Date and venue of next meeting

The next meeting of the working group could be held in the end of February or early March 2021, either by videoconference or in Strasbourg, depending on the agenda of work to be agreed upon by the CDDG and upcoming budgetary decisions for 2021. The Secretariat would inform the GT-RE about the date and place of the meeting as soon as more information becomes available.
