# EUROPEAN COMMITTEE ON DEMOCRACY AND GOVERNANCE (CDDG)

## WORKING GROUP ON ACCOUNTABILITY (GT-RE)

**REPORT OF THE 5th MEETING** 

13 September 2021, held by videoconference

#### 1. Opening of the meeting

The Chairman of the Working Group, Mr Paul-Henri Philips (Belgium, Brussels Capital Region), opened the meeting and welcomed the participants. He informed the Group that he would retire in the beginning of 2022 and that, as a result this was his penultimate attendance of CDDG activities. The list of participants appears in Annex I.

#### 2. Agenda

The agenda as set out in Annex II was adopted.

# 3. and 4. Drafting of a Recommendation for the Committee of Ministers on democratic accountability of elected officials and bodies at local and regional level

Information by the Secretariat

Mr Dan Popescu introduced the new Head of the Democratic Governance Division, Ms Alina Tatarenko, who had taken up her new duties on 1 September and who would be the new Secretary of the CDDG Committee. He then recalled the importance of this new instrument in the current European context and pointed to the particular challenges posed the subject of popular recall addressed in Annex 2, section 7.

Presentation of the study on the democratic accountability of elected representatives and bodies at local and regional level by Mr Arnaud Duranthon

Mr Arnaud Duranthon (Senior Lecturer at the University of Strasbourg) presented the study which had recently been finalised (document GT-RE(2021)6), on the basis of an analysis of the replies to the questionnaire and in the light of the (amended) wording of the draft Recommendation prepared by the working group.

The working group agreed that the study would remain a valuable source of information, to be made available on the CDDG website for future reference. It also discussed the opportunity of converting it into an explanatory report and considered that there was no need to do so since the draft Recommendation was comprehensive and self-explanatory enough, especially with the most recent additions made to the annexes to the operational part.

Discussion of the draft Recommendation

The working group examined successively the operative part of the draft Recommendation and its two annexes (document GT-RE(2021)5) after the Secretariat had presented the changes made following the working group discussions held in June and indicated that the draft Recommendation would need to be sent for review by the legal advice services and by the editorial services for legal, technical and linguistic consistency, possibly before its final consideration by the CDDG at its  $14^{\rm th}$  meeting (29-30 November).

The member from the United Kingdom submitted additional drafting proposals for the first paragraphs of the operative part, and the members from Finland, Greece and Norway, as well as the scientific experts, suggested further linguistic and conceptual adjustments, including with regard to the definitions. The working group discussed the various suggestions and approved various changes and additions.

Further proposals were submitted in writing by the Danish and the Slovak delegations, which could not be presented and discussed, including for technical reasons. The working group agreed that for the final version of the draft to be considered by the CDDG in November, and prior to that by the Bureau at its meeting of 14-15 October, those proposed changes which appear to be consistent with what the group had already discussed and agreed could be included, and that in case of doubt the suggested new wording would be highlighted in square brackets.

#### 5. Other business

In response to a question by the representative of the Conference of international non-governmental organisations who remarked that the Recommendation was covering only elected officials, it was agreed that a footnote could be added, stating the fact that local/regional accountability to be overall effective would also have to take appointed/nominated officials into account. The study could also be used to provide further explanation on this and to refer to those other Council of Europe standards and documents which already deal with public officials more broadly.
