Background

Companies have, especially where they operate at the global level as multinational enterprises, become increasingly powerful and have the ability to severely **impact** peoples' lives and the environments in which they operate. While those companies generally bring **benefits to society** in the form of tax revenues and investment, employment opportunities, and technological advancement; the operations, actions and influence of private companies can also have a **detrimental effect** on the rights of their employees and the wider community.

The question of **respect** for human rights and **accountability** for violations by companies has been the subject of increasing debate at both international and national levels. Whilst the **primary duty** to ensure the protection of human rights lies with States, companies are increasingly becoming aware of their **own responsibility** in this field.

A number of important **legal and policy developments** have been adopted at the national and international level, and companies are increasingly seeking to develop **practices and processes** to meet the growing **standards and expectations**.

This free <u>HELP online course</u> addresses the legal frameworks, methodologies, and practical actions on how States, corporate actors and legal professionals can prevent, mitigate, and remedy potential or actual corporate related human rights abuses.

This HELP course elaborates on the **State duty to respect** human rights in the context of corporate actions; provides practical guidance on how companies can conduct **human rights due diligence**; and offers an in-depth look at the **provision of remedy**.

The topics covered are explored in a practical way, using presentations, interactive screens, knowledge tests and reflective exercises.

The course was developed in 2021.

About the course

The course was published in 2021. It was developed under the Project "Online Platform for Business and Human Rights", implemented by the HELP programme in cooperation with the <u>Council of Europe Steering Committee for Human Rights</u> (<u>CDDH</u>), funded by the Dutch and German Authorities. In association with this project, this course has been developed alongside the <u>HELP</u> <u>Course on The Environment and Human Rights</u>. These two courses are intended as **complementary resources** that can be taken **together or separately**.

Target audience

This free on-line course is primarily addressed to **legal professionals** (judges, prosecutors, lawyers or court staff). It can also be used by other public authorities, including national human rights institutions, ombudspersons, mediators, as well as civil society organisations, university students etc. Additionally, it is addressed to legal and other professionals working in the **private sector**. The course does not require any previous knowledge in the topic.
