



### Article 10 (1) ECHR



- 1. Freedom of expression is the cornerstone of any democratic society as it allows for citizens participation to the public debate
- 2. Media freedom: right to impart and receive information
- 3. It disclose violations and allows enjoyment of other human rights

### Article 10 (2) ECHR



Restrictions to FoE: State's negative obligations

If there is an interference with the right to FoE:

**PART** 

1

The restriction has must have been prescribed by law;

**PART** 

2

The restriction must have been imposed in pursuit of a legitimate aim; and

**PART** 

3

The restriction must be demonstrated to have been 'necessary in a democratic society'.

#### State's positive obligations



- 1. Create a favourable environment for FoE
- 2. When there are threats or use of violence:
  - Effective criminal-law provisions
  - Preventive measures to protect journalists
  - Investigate
- 3. Broadcast regulation (media pluralism)
- 4. Employment relationships (between individuals)



#### Types of protected speech

Entertainment

- 1. Political expression attracts the highest level of protection
- 2. Artistic expression has an inherent societal value. It can also be political.
- 3. Commercial speech: higher margin of appreciation

#### **FoE and Privacy**



- Balancing competing interests
- Article 10 v. Article 8
- Criteria:
  - 1. Contribution to a debate of general interest
  - 2. How well known is the person concerned and what is the subject of the report
  - 3. Prior conduct of the person concerned
  - 4. Method of obtaining the information and its veracity
  - 5. Content form and consequences of the publications
  - 6. Severity of the sanction imposed

#### **Defamation**



- 1. Fair balance between Article 10 and 8
- 2. The attacks on reputation needs to attain a certain level of seriousness
- 3. FoE is applicable to ideas and information that offend shock or disturb



#### **Defamation**



- 1. The position of the person making the statement
- 2. The position of the person whose reputation is affected
- 3. Subject matter of the publication
- 4. Nature and severity of penalty
