#### **INPPA – ROMANIAN INSTITUTE FOR LAWYERS' TRAINING**

Provides both initial and continuous professional training for the Romanian lawyers:

- Initial professional training covers 2 years, a national examination ends the training
  - Module of European Law for the 2nd year trainees consisting of 2 out of the 3 following disciplines, at the trainees' choice: European Law of Human Rights, European Union Law (general module), European Union Law (specialized module) 24 teaching hours
- Continuous professional training: legal obligation according to the Law and Statute of the profession

## HELP IN THE LAWYERS' INITIAL TRAINING

#### March 2020

- the training activities at the Institute are entirely on-line
- the academic activities for the 2nd year trainees begins with the European Law module
- a selection of HELP courses has already been integrated on the INPPA e-learning platform (<u>https://www.inppa.ro/</u>)
- trainers may refer the trainees to the courses or they may supplement their teaching activities by using the HELP resources on the platform

- Launched in Bucharest in January 2017
- In cooperation with the Romanian School of Magistracy (2 groups of lawyers, prosecutors and judges)
- 34 lawyers successfully accomplishing the activities
- 2nd launch by UNBR and INPPA in June 2017
- 20 more lawyers successfully accomplishing the activities

#### DATA PROTECTION AND PRIVACY RIGHTS



- Launched in Bucharest on 11
  October 2018
- 27 lawyers successfully accomplishing the training activities
