#### **Integrated Approach**

##### **INTRODUCTION - THEME 1.**

The first theme introduces the competent Hungarian government authorities and organisations with legal responsibilities for heritage policy and management. It is worth to mention that since 2001 an integrated approach has been developed on the field of built (architectural), archaeological and movable heritage. The responsible ministry for this professional field was the competent ministry for culture, and a new organisation was established in 2001 for the administrative, management and research functions. The responsibility for landscape heritage was and is handled separately, basically under the auspices of the ministry responsible for the environment (in the frame of environment protection and nature conservation).

Since January 2013, this structure has been rearranged, presently the movable, the intangible heritage, the national and historical Memorial Sites and the World Heritage fields belong to the competence of the minister responsible for culture (the Ministry of Human Resources), including the maintenance of the fundamentally restructured heritage agency, the former National Office for Cultural Heritage. While the Ministry of Interior became responsible for legislative and professional direction of immovable (built/archaeological) heritage, and the Ministry of Public Administration and Justice supervises and directs the governmental agencies that perform the official tasks, manage the inventories and carry out certain research tasks relating to movable heritage.

The restructured heritage agency, the Gyula Forster National Centre for Cultural Heritage Management (Forster Centre; which previous name was National Office for Cultural Heritage) has to carry out different tasks on movable heritage (protection, export licence, procedures in illicit issues), and it is responsible for the provision of certain scientific tasks, such as the collection, assessment, registration and publication of cultural heritage related documents as well as the management and enlargement of collections, and the participation in the implementation of the World Heritage Convention. As the former National Trust of Monuments for Hungary was merged with the Forster Centre, it is also entrusted to manage

40 cultural heritage sites and ensembles (about 200 properties). The Forster Centre began to elaborate new strategies for the proper management of these cultural heritage assets.

On the administrative level, the Township Offices (21 governmental agencies at county level and in case of Budapest 2 District offices) and the Governmental Offices on County level (20 offices including Budapest as well) administer as first and second instance authorities the cultural heritage protection tasks within their defined jurisdictions. In the case of the listed historic monuments the agencies issue construction permits relied on the special expertise of the heritage inspectors (special regulations refer areas of historic significance and excavation licences). The registration, inventarisation and research of immovable heritage temporarily belong to the Government Office of the Capital City Budapest.

On the field of archaeology, the Hungarian National Museum (which has a special branch for archaeology, the Nemzeti Örökség Központ/National Heritage Centre), the universities with an archaeological faculty, and the Institute of Archaeology of the Hungarian Academy of Science can conduct site exploration, research and planned excavation. The preventive archaeological tasks are carried out by the urban museums with a county range, involving local museums. The museum structure had been reorganised in January 2013, and task of the sustenance of the previous county museums was moved from the county government to the local government of the county seats. These museums are legally designated to investment-led archaeological interventions in the form of contract archaeology (without the existence of private firms), and they have to fulfil the unexpected rescue tasks as well.

On the field of architectural heritage/monument research, beside the Forster Centre, the Government Office of the Capital City Budapest, the Research Institute for Art History of the Hungarian Academy of Science, and the special department on the University of Technology and Economics, Faculty of Architecture play an important role. Referring to landscape heritage the scope of duties lies with National Parks, and the National and the ten regional Inspectorates for Environmental Protection, Nature Conservation and Water Management. There are several professional organisations on each field, including the Hungarian filiales of the international bodies (like ICOMOS and ICOM,...). Different organisations exist also with a wide range of functions, but there are no explicitly commercial bodies and very few voluntary organisations. Some training is offered by the above mentioned organisations.

In 2012, the Hungarian heritage sector was subject to major structural changes which followed from the basic reorganisation of government administration,. It is the right of the museums to make excavation on archaeological sites (predominantly



urban museums which have a sphere of action in a county) .The Hungarian National Museum has special licenses to carry out excavation and other archaeological heritage related tasks throughout Hungary.

The National Park directorates are responsible for the operation of the Ranger Services. State rangers are entitled to take measures on behalf of the authorities, and equipped with appropriate service devices and a uniform. Their primary duty is the protection of the natural assets and areas, and also of registered archaeological sites.

#### **INTRODUCTION THEME 2.**

It is important to mention in the introduction of the different heritage inventories that an initial form of integrated approach can be traced in the inventories on architectural and archaeological heritage. The inventory of the protected movable heritage (cultural goods) has been developed together with the customs office and it contains data on the stolen and looted cultural goods. A separate inventory on nature conservation contains data on landscape heritage, but there are overlapping elements between the mentioned protections (for example earthen fortifications, and so called Cuman barrows). The web based inventory on immovable heritage is operated as an intranet system for the heritage authorities. Originally it was managed by the heritage agency (National Office of Cultural Heritage), but after the recent reorganizational process it belongs to the Government Office of the Capital City Budapest which provides data in case of official request. The general public (investors, planners, owners) could obtain data as well, as a service from this authority. The inventories on cultural heritage are legally authentic; they certify the protection of elements of cultural heritage included in them. In the database of the architectural heritage information is included on the different protected (listed) items: listed buildings, conservation areas (listed historic sites), protection zones (environment of the protected architectural heritage) and protected historic landscapes (with only one item) The inventory of archaeological heritage contains data on known archaeological sites (dated before 1711), including protected sites and territories, but it does not cover the so called archaeologically sensitive areas. In case of a proposal to protect a new site, a scientific documentation is prepared based on official protection criteria and guidelines. In case of architectural heritage and the protected archaeological sites (which is only approximately 3% of the registered archaeological sites, having outstanding scientific importance), after a scheduling/listing procedure a ministerial decree states the protection status. The registered archaeological sites (which do not have a protected status) are included in the inventory by the heritage authority. Both individual sites and monuments and ensembles can be protected. In case of individual items a protective zone could also be defined.

There is statutory obligation to prepare standardised documentation on each archaeological activity that should be sent to a central archaeological archive kept in the Hungarian National Museum. Since 2001 the National Office of Cultural Heritage also collected one copy of the documentations (now this is the duty of the Government Office of the Capital City Budapest), and a further copy is placed in the museum where the archaeological finds are stored. According to the legal regulations, archaeological finds – either unexplored or excavated – belongs to the State. Finds are not tradable, and it is not allowed to export them. They should be preserved in public collections especially in museums. It is mandatory to report on chance discoveries, and the appointed museums must perform the related scientific tasks. Due to the favourable geographical location and a great number of archaeological sites from different periods, Hungary is target of intensive illegal metal detection. Among different attempts against illegal trade it is worth to mention the recent change in the legislation, which introduced in January 2013 the licensing system for the use of metal detectors on non-registered archaeological sites (the use of metal detectors on registered archaeological sites is and was only possible with a licence from the heritage authority).

#### **Integrated Approach**

Next to the heritage elements which are protected on a national level, the world heritage sites are acknowledged by the Hungarian legal system. (Act No. 77. of 2011. on the world heritage.) The regulation states that all world heritage sites must have an individual protection which suits the protection system on the national level. World heritage sites do not have additional protection.

#### **Archaeological Heritage**

Next to the protected national level, there are archaeological sites which are protected on a local level as well. (All known archaeological sites are protected by the force of law, according to Act No. 64. of 2001 on the protection of cultural heritage. Listed archaeological sites got extra protection through a ministerial decree. All listed archaeological sites are selected from the group of the known sites, and this category is reserved only for the most important sites.) Their protection is issued by the local government (with certain regulations), but there is no centralised inventory for the locally protected archaeological elements. This system may be considered an additional protection, which is the lowest in the hierarchy of the archaeological protection system for known sites. Definition of terms according to the Act on cultural heritage archaeologically sensitive areas (or areas with archaeological interest all areas, natural or artificial cavities and waterbeds on which or in which an archaeological site might be found or assumed to exist archaeological sites clearly defined geographical areas on which the elements of archaeological heritage can be found in

their primary relations and which have been registered by the National Office of Cultural Heritage all detectable signs of human life originating before 1711 on the ground, under the ground or water surface and in natural or artificial cavities, which help to reconstruct the history of mankind and its relationship with the environment is considered part of the archaeological heritage protection zones for archaeological heritage the environment of a protected (listed) site, ensuring its sustainability, accessibility and landscape protection.

### **Architectural Heritage**

Listed monuments (buildings and sites) are chosen from the most significant elements of the architectural heritage on a national level (their protection is issued through a ministerial decree). The system is similar for the conservation areas, the protection zones and the protected historic landscapes. Next to the protected national level, there are built heritage elements which are only protected on a local level. Their protection is issued by the local government (with certain regulations), but there is no centralised inventory for these locally protected sites or buildings. They are mainly acknowledged in the master plan of the settlements. #### **Archaeological Heritage**

2.5.B. There is no separate specific law on the illicit trade of heritage, but the Penal Code

(Act IV. of 1978.) includes provisions for crimes committed against cultural goods, archaeological sites or historic monuments. This law recognises the illicit trade of the cultural goods (archaeological finds are also included in this category) as a criminal offense as well. Additionally, the law on the protection of cultural heritage (Act LXIV. of 2001) regulates the export of cultural goods: a license is required for each object older than 50 years.

**INTRODUCTION THEME 3.**

This section illustrates in detail, how the legislative systems mentioned in Theme 2.3 is implemented in practice. In the field of archaeology, recently a so called Preliminary Archaeological Documentation (PAD) was introduced in case of large scale developments. PAD is an impact assessment document, which should be based on the results of archaeological surveys (field walking and either non-destructive methods like geophysics, aerial photography, etc., or test pits). In the legislation it is also prescribed which site categories should be avoided by the development projects, and how the built archaeological remains should be handled or preserved in their original context (preferably kept *in situ*). As far as the built heritage is concerned, legal authorization is needed for interventions on listed items protected by the Heritage Act. Depending on the type of the intervention the responsible authority is either the building authority or the cultural heritage authority. Field work (research and restoration activities) is also liable to authorized licence. The supervision of the process of restoration of fixtures has to be defined in the licence and is carried out by a commission. Onsite inspection of the restoration of buildings is administered jointly with the building authority.

Development plans of settlements (which have to be periodically revised in Hungary) have a compulsory heritage impact assessment chapter. Its recommendations and specifications should be taken into account in decision making, but its integrated approach is often but formal. There are no private firms specialised in heritage conservation. Contractors are selected on the basis of reference. The same applies for restorers of fixtures and fittings. In the field of research there are only a few small private firms, but hardly any that works exclusively in this filed. There is one state organisation (the successor of a formerly independent research and planning centre, now a department of the Hungarian National Museum), that is professionally dealing with building archaeology and planning. Commissions to all sectors may come from either the state or the free market. A new entity in research and restoration is the Forster Centre, one of the successors of the former National Office of Cultural Heritage.

The EU directive on Environmental Impact Assessments (EIA) and the Strategic



Environmental Assessment (SEA) is adapted by separate governmental decree, which prescribes that the EIA should take into consideration the cultural heritage elements (including cultural landscapes) as well.

Nevertheless, archaeological heritage is included in the planning process from an early stage (requiring a preliminary archaeological document) in large scale investments, or in investments which has a priority on national level.

**INTRODUCTION THEME 4.**

Sustenance of the heritage organisations and means to perform their basic tasks (like the legal procedure of protection/listing) are provided from state budget. As a provision, in case of architectural heritage, public (direct) funding is available for conservation and restoration (but not for maintenance). There are exceptional cases for tax redundancies for owners or developers (like in respect of local taxes) but no tax benefit is available in VAT or in inheritance.

The investment-led archaeology – according to the principles of the La Valletta Convention – is supposed to be financed by the developer both in case of public and private development. However, recently a budgetary limit has been introduced in the legal regulations for large scale developments (both private and public developments, and also in case of EU funding). The expenses of the archaeological activity in these cases can be maximum 1 % of the total budget of the development, and this sum cannot exceed 7000 euros. In preventive archaeology (by large scale developments) the preparation of a Preliminary Archaeological Documentation is obligatory; in special cases this survey could be financed by the state. The developer has to cover the expenses of the archaeological survey, the excavation, the documentation, the primary find conservation, the costs of the primary find processing and the extraordinary expenses of the temporary storing. The archaeological post-excavation process should be covered by the organisation excavating the site; but certain scientific and cultural funds are available for these tasks.

Private funding and sponsorship is very rare and *ad hoc*; there are few examples both for conservation and restoration of built heritage items and for archaeological research.

#### **Archaeological Heritage**

4.1.B. Primarily it is the Nemzeti Kulturális Alap (National Cultural Fund - [www.nka.hu](http://www.nka.hu/)) which provides public financial support for culture and cultural heritage.

The National Cultural Fund was established by the Hungarian parliament in 1993 with the Act 23.

This State Fund has fiscal autonomy. Its main income source is the 90 per cent of the

tax of the National Lottery. The Fund supports among others the development of new cultural initiatives, and scientific research on the cultural, architectural and archaeological heritage.

4.1.C. In principle, the preventive excavations are financed by the developers. There is no distinction between private or public developments. However, in case of large scale investments (the term is defined in the law on cultural heritage, except of the extent of the development site – Act 64. of 2001), the developer is only obliged to pay 1 per cent (or maximum the gross amount of 200 million HUF) of the total investment cost.

### **Architectural Heritage**

The Nemzeti Kulturális Alap (National Cultural Fund - <http://www.nka.hu/>) provides public financial support for the architectural heritage as well, primarily the restoration works on the listed buildings. The owners have to apply for the funding, and the decision is made by a committee. The resources are far shorter than the justifiable needs.

The National Cultural Fund is operated on a yearly budget in a number of different fields.

#### INTRODUCTION THEME 5.

The legal regulations on cultural heritage have provisions for owners of the protected heritage items to provide access to heritage sites and cultural goods. Although presently, the official heritage inventory is publicly not accessible, certain information are available online. In the last five years an integrated heritage web based platform has been created (TÉKA) and there is non-official websites available specialised on monuments. The bigger museums also operate selected access to their outstanding sites. Additionally, there are a number of printed professional publications and guides (like on the monuments of the different counties, the **Itinerarium Hungaricum, etc.) which are often out of date practically, but usually quite high quality scientifically. These publications do not always differentiate between the public and private locations.**

The European Heritage Days are organised in Hungary since 1999, each year the event has

a central theme. The number of the participating settlements is around 300 annually (approximately 500 sites).

There are few NGOs which are active in supporting and promoting cultural heritage or heritage sites, and there are very few examples for the participation of NGOs in heritage education. On the field of awareness-raising there is a lot to do. There were progressive initiatives of the State Service for Archaeology (presently operating within the Hungarian National Museum), on how to involve the different stakeholders and how to increase the level of understanding of the heritage values in the different strata and age groups of the society. Heritage related special programs, festivals, events, professional workshops and conferences are organised from the national to the local levels, and are also promoted by the relevant public administration. There are statistical data collected on the number of visitors in museums, archaeological parks, monument sites, or other heritage sites opened to the public, but there are not precisely elaborated indicators to present the profit/benefit of these visits, or on the economic return of heritage tourism.

On the field of the dissemination, the position of the grey literature (the preliminary scientific reports) is quite developed. In case of archaeological interventions it is obligatory to send a report within a very short time after the works are finished, and most of these reports are published in the forthcoming year in one publication. The results of the archaeological surveys/excavations are regularly published in the great number of professional periodicals of the different heritage, organisations. However, the reports and monographs are very rarely available online. Due to the very intensive fieldwork of archaeological activity in the last 15 years (until the year 2010 around one million square meters were excavated annually) there are significant backlogs in evaluating and publishing the results.

5.2.B The Association Porta Speciosa is a non-governmental organisation promoting the preservation of built heritage among school children, with a special focus on students of secondary schools and vocational schools providing specialised courses in architecture and the protection of built heritage. The trainings organised by the Association are targeted mainly at teachers of these schools, with the goal to assist in delivering the specialized courses in the field of the protection of built heritage. The Association does not have the resources to employ staff, therefore all trainings are carried out on a voluntary basis both from the part of the Association and the trainers. The funds that the Association manages to raise from different grants allow only for renting the venues for the trainings as well as to provide meals for the participants. The trainers involved are mostly university professors at universities of architecture as well as professionals from the National Office of Cultural Heritage and from other relevant institutions of the protection of built heritage. It has a long tradition in Hungary to compile an annual publication which consist a short preliminary report on all archaeological surveys (predominantly excavations, but nowadays other types of surveys could be included as well) within a year. The first volume was published in 1958 by the Hungarian National Museum which was responsible - as a documentation center - for collecting the documentation of the archaeological excavations. Since 2002, the National Office of Cultural Heritage publishes it under the title: Archaeological Investigations in Hungary. It is not obligatory by law for the archaeologists to make the preliminary reports.

The last published volume refers to year 2009. and consist 602 preliminary reports on archaeological surveys from the prehistoric period to early modern age.

**INTRODUCTION THEME 6.**

There are ambitious plans for the digitisation of cultural heritage by a separate institution (the digitisation of the immovable heritage is not part of this program). Regarding public collections (museums, libraries, archives) a notable development can be observed on the field of digitisation, but this process did not improve the online access of these collections. The central inventories on cultural heritage sites has been transformed to a web based database with GIS platform, which is operating as an intranet system, providing access only for the national heritage institutions. In case of movable heritage the inventory has been generated in collaboration with the police and customs office.

Recently, in the frame on an EEA funded project an integrated, national on-line register has been developed with the aim to cover the landscape, natural and cultural heritage values. This project is still in progress.

### **Archaeological Heritage**

There is no official regulations or policy which would include specific provisions within the legislation of the cultural heritage for digitisation. However there is a general regulation on 'national data assets' which applies to the inventories of the National Office of Cultural Heritage (on archaeological heritage, architectural heritage and cultural goods). A projects is under development which would allow a common electronic data management for all databases which are considered to be part of the 'national data assets'.

The above mentioned centralised inventories of the National Office of Cultural Heritage are all in digital database formats.

### **Architectural Heritage**

There is no official regulations or policy which would include specific provisions within the legislation of the cultural heritage for digitisation. However there is a general regulation on 'national data assets' which applies to the inventories of the National Office of Cultural Heritage (on archaeological heritage, architectural heritage and cultural goods). A projects is under development which would allow a common electronic data management for all databases which are considered to be part of the 'national data assets'.

The above mentioned centralised inventories of the National Office of Cultural Heritage are all in digital database formats.

## 7.2.A Are visions or strategies for heritage going to change in the short and medium term?

### **7.2.A Vertical Tabs**

#### **Archaeological Heritage**

There were major changes in the recent one and half year in Hungary due to the dissatisfaction of the decision makers with social benefit of archaeology and with the time and money spent on investment-led archaeology. Amplified with the effects of the recession it resulted first in the modification of the cultural heritage act (Act 64 of 2001) introducing serious budgetary and time constraints in case of large scale investments. The heritage institution was restructured, the heritage administration has been decentralized. By the beginning of 2013 the whole legislation on archaeological heritage has been modified. The superintendence of the cultural heritage has been transferred from the Ministry of Human Resources to the Ministry of Interior. The regional museum system was also reorganized which strongly affected the provincial museums responsible primarily for performing tasks related to the investment-led archaeology. In the present environment the greatest challenges is how to plan and manage archaeological activity in order to ensure the professional quality and obtain appropriate scientific results. While the proportion of the excavations will be smaller, the importance of preventive exploration and evaluation will dominantly increase. In order to gain stronger social and political support, a much more efficient societal feedback is necessary. Further efforts are needed to make the common values of the archaeological heritage widely understandable.

#### **Architectural Heritage**

The reorganizational process in 2012 in the field of the cultural heritage protection resulted in a presently vulnerable situation. The short and medium term goal is to improve this situation. On the governmental institutional level it primarily means the creation of an effective legal framework, and ensuring the authorisation of interventions (e.g. establishing a system of balanced and predictable budgetary contribution). It is also necessary to disseminate knowledge on the heritage issues to the general public, to raise the awareness of responsibility and to establish or strengthen the non-government involvement in cultural heritage protection and management.

#### **Landscape Heritage**

According to Act no. 53 of 1996 on nature conservation, the visible mounds (burial mounds, Cuman-barrows, kurgans) and the hillforts/earthen fortifications are nature monuments, and are protected by the force of law. Basic information about the site of these protected nature monuments are available, and the short and medium term policy aims to provide a more solid administrative background for their maintenance. (The extent of coverage of these sites should be issued by authority decisions.) Concerning the visible mounds, their protection is included in the Good Agricultural and Environmental Condition Standards, and rules on the protection of the landscape elements should be integrated into the

regulation of other sectors as well. It is scheduled to continue the field surveying and the expansion of the database of the unique landscape features. Additionally, it is planned to issue the legislation on their protection and publication in the short term. Ensuring the implementation of the European Landscape Convention a National Coordination Committee had been established in 2009.
