Supporting enhanced access to higher quality Free Legal Aid (FLA) services in North Macedonia

What is the goal?

The Action aims at enhancing the efficiency, quality, accessibility, and awareness of free legal aid in North Macedonia. More concretely the Action will focus on the:

- harmonization of provisions, policies and practices related to free legal aid in North Macedonia;
- capacity building for the main actors in the field (Ministry of Justice, Bar Association and CSOs) including more structured and continuous coordination between the main stakeholders;
- awareness raising for the public and related institutional actors in the country to support increased access to free legal aid.

Who benefits from the project?

- Direct beneficiaries are be Free Legal Aid applicants and the general population. For this reason institutional entities and governing structures in the field of ensuring Free Legal Aid will be supported and assisted in building their capacities for a more efficient and accessible free legal aid system.
- ► The Action takes into account special needs of vulnerable groups (victims of domestic violence, children, Roma and other minorities) and gender related contexts in all stages of its implementation.

How will the project work?

- The Action is based in a regular communication, exchange and co-operation with the Ministry of Justice, the Bar Association, Civil Society Organizations in the country, Centres for Social Welfare, and the judiciary system bodies.
- Training sessions are developed and delivered during the Action, following the Training of Trainers (ToT) approach to produce higher sustainability. In this process, successful self-learning and peer-to-peer exchanges will be also used.
- To ensure an inclusive and efficient exchange between different actors, a coordination mechanism for improved communication and co-operation among stakeholders will be applied.

What do we expect to achieve?

- ▶ The legal and policy framework related to the provision of Free Legal Aid will be harmonised in line with Council of Europe standards
- Capacities of Free Legal Aid providers to deliver quality legal aid are strengthened
- Access to Free Legal Aid by the population will be enhanced and the efficiency of the Free Legal Aid in North Macedonia to be strengthened

How much will it cost?

The total budget of the Action is 800 000 EUR.
