

# Acton against Economic Crime in the Republic of North Macedonia

### What is the goal?

The Action against Economic Crime in the Republic of North Macedonia (HFII - AEC-MKD) aims at strengthening anti-corruption and anti-money laundering and countering terrorist financing regimes and thus seeks to increase trust in the rule of law and democracy in North Macedonia by. The Action will support the authorities in the effective implementation of the recent key recommendations of the monitoring bodies of the Council of Europe - Committee of Experts on the Evaluation of Anti-Money Laundering Measures and the Financing of Terrorism (MONEYVAL) and Group of States against Corruption (GRECO) and to contribute to tailored reform processes in the country.

### Who benefits from the Action?

- Main beneficiaries of the Action against Economic Crime in the Republic of North Macedonia are institutions/bodies involved in countering and preventing corruption, money laundering and financing of terrorism. More concretely: Financial Intelligence Office, State Commission for Prevention of Corruption, , Special Prosecutor's Office, Public Prosecutor's Office organised crime and corruption department, Financial Police, Ministry of Interior, Ministry of Justice, Public Revenue Office, Securities and Exchange Commission, National Bank, Supervision Commissions of the Chamber of Bar Association andof the Chamber of Public Notaries, Customs Office, Insurance Supervision Agency, Agency for Supervision of Fully Funded Pension Insurance MAPAS;
- Civil society organisations active in the field of anti-corruption;
- Private sector;
- Citizens of North Macedonia, who will benefit from more transparent and accountable work of the respective state institutions.

### How will the project work?

Action against Economic Crime in North Macedonia will be delivered by dispatching a mix of advisory and capacity building activities, tailored to specific needs of the beneficiaries, and building on the results of cooperation and assistance provided in the economic crime area in the first phase of Horizontal Facility. More concretely, the Action will focus on supporting the beneficiaries through :

- Expert opinions on legislation and policy documents;
- Support and guidance on developing or revising of policies, rules, and operational protocols and frameworks;
- Conferences, trainings and workshops on specific topics;
- Peer-to-peer exchange of good practices;
- Development of handbooks and training manuals and preparation of methodologies and document templates.

### What do we expect to achieve?

- Improved legal and operational framework on preventing and combating corruption;
- Strengthened and more efficient Asset Recovery Framework;
- ► Ehanced anti-money laundering and terrorist financing prevention mechanisms.
