# Promotion of diversity and equality in Bosnia and Herzegovina

### What is the goal?

- To strengthen the capacity of national and local stakeholders to better address issues related to antidiscrimination, combating hate-speech and protecting rights of national minorities and LGBTI persons in line with the standards and recommendations set by the Council of Europe – especially those of the Framework Convention for the Protection of National Minorities (FCNM), European Charter for Regional or Minority Languages (ECRML) and European Commission on Racism and Intolerance (ECRI).
- The action also aims at supporting Bosnia and Herzegovina's European path in the field of fundamental rights.

### Who benefits from the Action?

- The citizens of Bosnia and Herzegovina;
- ▶ National and local authorities/institutions, including law enforcement agencies;
- National minorities, LGBTI population, and other vulnerable social groups;
- Civil society organisations and/or local self-governments engaged in promoting and protecting human rights.

### How will the Action work?

- Through a combination of legal and strategic support to institutions; capacity building activities; peer-topeer exchanges with regional and European partners; awareness raising campaigns and public discussions on selected anti-discrimination topics; support to CSOs and/or local authorities by small grant schemes, to enhance their capacities to tackle discrimination and reach out to the citizens;
- It builds on the results of earlier co-operation programmes in the field of anti-discrimination in the country, also co-funded by the European Union and Council of Europe.

### What do we expect to achieve?

- To improve the record of implementation of anti-discrimination policies and legislation, at the state, entity and/or local level (especially on protection of the rights of national minorities, LGBTI persons, and on combating hate speech/hate crime);
- To enhance the dialogue and co-operation between institutions and civil society organisations in promoting and protecting human rights;
- ▶ To strengthen the awareness of citizens on their rights and mechanisms to defend them;
- Ultimately, to achieve better protection of human rights of the citizens of Bosnia and Herzegovina and build a more diverse, equal and tolerant society.

### About the Horizontal Facility for the Western Balkans and Turkey

The "Horizontal Facility for the Western Balkans and Turkey 2019-2022" is a joint initiative of the European Union and the Council of Europe that enables the Beneficiaries to meet their reform agendas in the fields of human rights, rule of law and democracy and to comply with the European standards, including where relevant within the framework of the EU enlargement process. This three-year programme covers actions in Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, Serbia, Turkey, as well as Kosovo\* and it is implemented by the Council of Europe from May 2019.
