# **TENDER FILE / TERMS OF REFERENCE**(Competitive bidding procedure / One-off contract)

Purchase of design and production of online courses on academic integrity for three private universities in Montenegro in the framework of the Horizontal Facility action "Quality education for all"

The Council of Europe is currently implementing until 23 May 2022 a joint European Union/Council of Europe project on "Quality education for all" a Project. In that context, it is looking for a Provider for the provision of **services of design and production of online courses on academic integrity for three private universities** (See Section A of the Act of Engagement).

# A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a duly registered company under sole proprietorship of a natural person, or equivalent, provided that the signatory of the Act of Engagement is individually liable for all obligations undertaken by the entity, and is the owner of the moral rights in any creations of the entity. If contracted by the Council of Europe, the signatory of the Act of Engagement shall provide the deliverables personally, in accordance with the terms as provided in the present Tender File and Act of Engagement.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: HF24 tender – Web design and production AI online courses. Tenders addressed to another email address will be rejected.

#### B. EXPECTED DELIVERABLES

#### C FFFS

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers <u>subject to VAT</u> shall also send a quote (Pro Forma invoice) on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

## D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at <a href="https://www.sanctionsmap.eu">www.sanctionsmap.eu</a>).

# Eligibility criteria

- Registered company or a natural person specialised in the field of web design and web
  applications development, communications, marketing or public relations with at least 5 years of
  continuous operation in the relevant field;
- Minimum 5 years of proven professional experience in the field of web design and video material production;
- At least 3 successfully implemented similar projects (web application development and video material production);

#### Award criteria

- Quality of the offer (70%), including:
  - Methodology proposed quality of methodologies and multidisciplinary approaches for undertaking the different tasks defined in the description of deliverables.
  - Composition of the teams assigned to the execution of this contract that should ensure a rapid response and timely provision of the expertise required
- Financial offer (30%).

<sup>-</sup> An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three and sixth above listed exclusion criteria are met;

<sup>-</sup> A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

<sup>-</sup> For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

<sup>-</sup> For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

Multiple tendering is not authorised.

## E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

#### F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement<sup>3</sup> (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- Registration documents, for legal persons only Can be submitted in the local language;
- Professional biography of the organisation/company or natural person submitting the offer with the appropriate portfolio outlined;
- Samples of at least 3 successfully implemented previous similar projects as list of links to the videos and animations hosted online;
- CV of a production team or an individual.
- Short methodology outlining:
  - o a conceptual framework, understanding the nature of the assignment;
  - o a description on how the task will be carried out, including:
    - organisation of project implementation;
    - work plan;
- an explanation on how quality will be ensured with attention to the specific beneficiary contexts;

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
