Purchase of consultancy services related to development of materials for parents to develop, foster and enhance the culture of democracy in their children based on the Reference Framework of Competences for Democratic Culture (RFCDC) concept within the framework of the joint Council of Europe/European Union Project "Quality Education for All (Quality ED – Serbia)" in Serbia.

The Council of is currently implementing and until 23 May 2022 will be implementing joint Council of Europe/European Union Horizontal Facility project "Quality Education for All (Quality Ed – Serbia)" in Serbia. In that context, it is looking for a Provider for the provision of consultancy services related to development of materials for parents to develop, foster and enhance the culture of democracy in their children based on the RFCDC concept (See Section A of the Act of Engagement).

A. TENDER RULES

This tender procedure is a competitive bidding procedure. **In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.**

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, or a legal person except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: Consultancy services - materials for parents.** Tenders addressed to another email address **will be rejected.**

The general information and contact details for this procedure are indicated on this page. You are invited to use the CoE Contact details indicated below for any question you may have. **All questions shall be submitted at least 5 (five) working days before the deadline for submission of the tenders and shall be exclusively addressed to the email address indicated below with the following reference in subject: Consultancy services - materials for parents: clarifications.**

B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

C. FEES

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **subject to VAT** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,² you declare on your honour not being in any of the below situations)

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at www.sanctionsmap.eu).

Eligibility criteria

- University degree in education, pedagogy, social sciences, political sciences or any related relevant field;
- At least 10 years professional experience at international level in areas related to human rights education, democratic citizenship, democratic culture in education, anti-discrimination and inclusive education;
- Excellent knowledge and understanding of the concept of Reference Framework of Competences for Democratic Culture (RFCDC);
- Experience in materials development in relation to the RFCDC;
- Work experience in international, multi-cultural environments;
- Experience at a senior expert level for international organisations/CSOs dealing with the themes of education for democracy, human rights education and competences for democratic culture;
- Excellent oral and written knowledge of English (at least level C1 of the CEFR³), proficiency in drafting in that language.

Award criteria

- Quality of the offer (80%), including:
 - Excellent understanding of the modern education concepts, theories, practices and education systems;

- An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met;
- A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;
- For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;
- For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

- Expert knowledge of the Reference Framework of Competences for Democratic Culture;
 - Experience in development of materials for different target groups focused on fostering Human Rights Education and Democratic Citizenship, Education for Democracy, Competences for Democratic Culture;
 - Familiarity with the relevant international standards, in particular the Council of Europe standards in the field of Human Rights Education and Democratic Citizenship (EDC/HRE) and the recommendations of the European Commission against Racism and Intolerance (ECRI);
 - Demonstrated ability to work in international, multicultural environments, and demonstrated analytical, research and reporting skills;
 - Capacity to meet the required deadlines.
- Financial offer (20%).

For Consultancy ONLY: The Council reserves the right to hold interviews with eligible tenderers.

Multiple tendering is not authorised.

E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- **A completed and signed copy of the Act of Engagement⁴ (See attached)**
- For tenderers subject to VAT only: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- **A short (2-3 page) concept note outlining the concept of the materials as per request outlined in the Act of Engagement;**
- A detailed CV, preferably in Europass Format, demonstrating clearly that the tenderer fulfils the eligibility criteria;
- A cover letter in English demonstrating how the tenderer meets the criteria listed above with a list of relevant materials, textbooks and resources developed.

All documents shall be submitted in English failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.
