# TENDER FILE / TERMS OF REFERENCE (Competitive bidding procedure / One-off contract)

Purchase of consultancy services on data collection and analysis on hate crime, within the Action HF45 "Promotion on Diversity and Equality in the Western Balkans".



## Contract N° BH4676/2022/5

The Council of Europe is currently implementing the Action HF45 until December 2022. In that context, it is looking for a Provider to map and collect existing data on cases of hate crime based on SOGI grounds; organize a multistakeholder meeting per beneficiary on the subject; prepare a report on the phenomenon of hate crime affecting LGBTI communities in the region, and recommendations to further address it. (See Section A of the Act of Engagement).

## A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural person, a legal person, or consortia of legal and/or natural persons.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: HF45 – DATA COLLECTION HATE CRIME.** Tenders addressed to another email address **will be rejected.**

#### B. EXPECTED DELIVERABLES

#### C FFFS

Tenderers <u>subject to VAT</u> shall also send a **quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

#### D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement,<sup>2</sup> you declare on your honour not being in any of the below situations) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at <a href="https://www.sanctionsmap.eu">www.sanctionsmap.eu</a>).

## Eligibility criteria

- be registered in one of the 6 beneficiaries of the project (Albania, Bosnia and Herzegovina, Kosovo\*<sup>3</sup>, Montenegro, North Macedonia or Serbia).
- have at least 4 years of experience in reporting and collecting data on hate crime at the regional level, notably on LGBTI grounds.
- have documented track record in producing high quality publications in English.

## Award criteria

- Quality of the offer (70%) including:
  - o 30% quality of the narrative proposal:
  - o 40% samples of reports in the filed of combating hate crimes;
- Financial offer (30%).

Multiple tendering is not authorised.
