Agenda item 1. Opening of the meeting and adoption of the agenda

The Committee adopted the draft agenda as it appears in document IC-CP(2021)OJ11prov rev1.

Agenda item 4. Election of one member of GREVIO

The Committee declared the following candidate for GREVIO membership elected:

- **María Rún BJARNDÓTTIR**

In accordance with paragraph 2 of Article 66 of the Istanbul Convention and Rule 14 of the Committee of Ministers' Resolution CM/Res(2014)43, the Committee decided that this member of GREVIO shall hold the seat for the remainder of her predecessor's term, beginning on 8 December 2021 and ending on 31 May 2023, renewable once.

Agenda item 5. Election of Bureau members

In accordance with Rule 4 of its Rules of Procedure, the Committee declared

- Ms Marie FONTANEL, Ambassador, Permanent Representative of France, elected as Chair;
- Mr Domenik WANGER, Ambassador Extraordinary and Plenipotentiary, Permanent Representative of Liechtenstein, as First Vice-Chair; and
- Mr Andrej SLAPNIČAR, Ambassador Extraordinary and Plenipotentiary, Permanent Representative of Slovenia, elected as Second Vice-Chair;

for a term of office of one year starting on 1 February 2022, renewable once.

Agenda item 7. Recommendations on the implementation of the Istanbul Convention

On the basis of the proposed model recommendation, the Committee adopted recommendations under the first (baseline) evaluation round addressed to the Governments of Poland, San Marino and Slovenia. The recommendations are set out in documents IC-CP/Inf(2021)8, IC-CP/Inf(2021)9 and IC-CP/inf(2021)10

Agenda item 8. Supervising the implementation of recommendations issued by the Committee of the Parties

On the basis of the framework for supervising the implementation of recommendations addressed to states parties as set out in document IC-CP(2021)2 prov, the Committee adopted conclusions on the implementation of recommendations in respect of Albania, Austria, Denmark and Monaco. The conclusions are set out in documents IC-CP/Inf(2021)4, IC-CP/Inf(2021)5, IC-CP/Inf(2021)6 et IC-CP/Inf(2021)7.
