Agenda item 1. Opening of the meeting and adoption of the agenda

1. The Committee of the Parties to the Council of Europe Convention on Preventing and Combating Violence against Women and Domestic Violence (hereinafter referred to respectively as "the Committee" and "the Convention") held its 10th meeting on 13 April 2021 in Strasbourg, by virtual means. It adopted the draft agenda of the meeting as it appears in document IC-CP(2021)OJ10 and which is set out in Appendix I. The list of participants is set out in Appendix II.

Agenda item 2. Administrative and budgetary Information

2. The Executive Secretary informed the Committee about the exceptional measures for monitoring mechanisms authorised by the Committee of Ministers, aiming to reinforce the work of monitoring mechanisms by allocating part of the 2020 unspent appropriations to a special account for the purpose of reducing, in the period 2022-2023, the backlog of monitoring visits caused by the restrictions on travel in place due to the Covid-19 pandemic. As a result, an additional staff member will be recruited to join the Secretariat for a period of 24 months as of 2022.

Agenda item 3. Current affairs

- 3. The Committee discussed the recent decision of the Turkish authorities to withdraw from the Istanbul Convention. The Secretary General of the Council of Europe, Ms Marija Pejčinović Burić, delivered a <u>speech</u> and exchanged on the situation with the Committee members and participants. The Secretary General recalled that it is the first time in the history of the Council of Europe that a member state has withdrawn from a major human rights treaty. She shared her determination to uphold, promote and preserve the Convention as well as to expand the circle of those committed to the treaty and promote the positive and honest narrative around it, including with the help of the Venice Commission Opinion on the constitutional implications of the ratification of the Istanbul Convention by Armenia (CDL(2019)035).
- 4. Several delegations took the floor to thank the Secretary General for her strong support to the Istanbul Convention. They expressed their regrets towards the steps taken by the Turkish President and recalled the importance of the convention. They stated the need to dispel false narratives around the convention as well as to encourage signatory states to ratify it.

Agenda item 4. State of signatures and ratifications of the Istanbul Convention

- a) Action taken by member States of the Council of Europe towards ratification of the Istanbul Convention
- 5. The delegations of Liechtenstein and Ukraine shared information regarding the ratification process under way in their respective countries.
 - b) Declarations and reservations
- 6. The Executive Secretary informed the Committee that Poland communicated its partial renewal of its reservations as well as the reasons therefore. According to Article 79, paragraph 3, of the Istanbul Convention, the explanations of the Polish authorities on the grounds justifying the reservations' continuance will be communicated to GREVIO.

Agenda item 5. Exchange of views with Marceline Naudi, President of GREVIO

7. The Chair recalled that based on the rules of procedure, the Committee regularly meets with the President of GREVIO to hear about the state of the work of GREVIO and progress in preparing its reports and conclusions concerning the measures taken by the Parties to implement the provisions of the Convention, as well as any other issue relating to the functioning of the monitoring mechanism of the Convention.

- 8. On the basis of the 1st and 2nd general activity reports of GREVIO, Marceline Naudi presented trends and challenges in the implementation of the Istanbul Convention which stem from GREVIO's evaluation reports published so far. She addressed the impact of the Covid-19 pandemic on violence against women and victims' access to support services. She informed the Committee of several aspects of GREVIO's work, such as the process of developing its first General Recommendation on the Digital Dimension of Violence against Women, and its support to the Platform of Independent Regional and United Nations monitoring bodies on Women's Rights and Violence against Women (EDVAW Platform). Marceline Naudi thanked states parties for their co-operation and commitment to the evaluation procedure.
- 9. Several delegations took the floor to thank Marceline Naudi for her and GREVIO's work. They shared information on measures taken to further implement the Istanbul Convention and GREVIO's findings. In addition, issues such as the impact of the Covid-19 pandemic, the EDVAW Platform and the co-ordination with other human rights monitoring bodies were addressed. Marceline Naudi expressed her interest in the framework for supervising the implementation of recommendations made by the Committee of the Parties, looking forward to future co-operation between GREVIO and the Committee on that matter.

Agenda item 6. Framework for supervising the implementation of recommendations addressed to states parties

- 10. The Chair recalled that the Committee of the Parties' Rules of Procedure task the Committee of the Parties with the supervision of the implementation of its recommendations addressed to states parties. Following the discussion held at the 9th meeting of the Committee on the possible modalities of such supervision, as well as the decision, at the same meeting, to use a standardised reporting form to report back to the Committee, the Chair presented a revised version of the framework for supervising the implementation of recommendations addressed to states parties.
- 11. Two delegations suggested amendments to the framework. The Committee discussed the arrangements for the publication of the different documents of the procedure as well as the modalities for participation of non-governmental organisations, civil society and national institutions for the protection of human rights.
- 12. With a modification agreed on during the meeting, the Committee adopted the framework for supervising the implementation of recommendations addressed to states parties.

Agenda item 7. Declaration of the Committee of the Parties on the 10th anniversary of the opening for signature of the Istanbul Convention

13. The Chair informed the Committee that the 10th anniversary of the opening for signature of the Istanbul Convention will be celebrated in many ways, including with a virtual conference on 11 May 2021 organised by the Council of Europe together with the German Presidency to

the Council of Europe, as well as a wide range of multi-media material promoting the Istanbul Convention and showcasing the impact and positive change it has created in the past 10 years, and the publication of a horizontal review of all 17 GREVIO evaluation reports issued to date. The Chair recalled the decision, at the 9th meeting of the Committee, to adopt a declaration on the occasion of the 10th anniversary of the opening for signature of the Istanbul Convention. The Committee thus discussed the amendments proposed to the declaration and adopted the text of the declaration with modifications agreed during the meeting. The Committee agreed to give the opportunity to one state party to confirm its agreement to join the declaration in the upcoming days.

Agenda item 8. Opinion of the Committee of the Parties on GREVIO's draft General Recommendation on the digital dimension of violence against women

- 14. The Chair recalled that the Committee was invited to provide its opinion on GREVIO's draft General Recommendation on the digital dimension of violence against women. Following the adoption of the draft General Recommendation at its last meeting in February, GREVIO started a consultation process, asking several Committees within the Council of Europe for their opinion on the draft. Comments submitted will be reviewed by GREVIO, which will decide whether to reflect them or not in the final version of the General Recommendation.
- 15. The Chair thanked all delegations that had sent in comments and proposals for alternative wording for consideration by GREVIO. These comments had been compiled into a consolidated opinion for discussion and adoption by the Committee, which was adopted with the modifications agreed on during the meeting.

Agenda item 9. Date of next meeting

16. The Committee decided to hold its next meeting on 7 December 2021 in Strasbourg.

Agenda item 10. Designation of a Gender Equality Rapporteur

17. The Committee designated Ms Jitske Bosch (Netherlands) as Gender Equality Rapporteur.

Agenda item 11. Other business

18. The Chair informed the Committee of the decision of the Committee of Ministers to communicate the Parliamentary Assembly Recommendation 2196 (2021) on the "Impact of labour migration on left-behind children" to the Committee of the Parties for information and possible comments by 30 April 2021. The Chair highlighted the importance of the topic which might be considered by the Committee in relation to some countries and suggested to take this recommendation under advisement.
