"The impact of the COVID-19 pandemic on human rights and the rule of law"

Background

The Coronavirus disease (COVID-19) pandemic has created extraordinary challenges for the authorities of all Member States of the Council of Europe. They need to respond to this crisis effectively, whilst ensuring that the measures they take do not undermine the Europe's founding values of human rights, democracy and the rule of law. Since its establishment, the Council of Europe has developed a large volume of standards in different areas of its operation that can be applied to large-scale crises like the current one. The European Court of Human Rights in its judgments set clear criteria to be met whenever limitations of rights provided by the European Convention on Human Rights are to be imposed. It is expected that all states act in compliance with the European Convention on Human Rights, and measures taken by Member States during the current crisis remain proportional to the threat posed by the spread of the virus and are limited in time.

The Secretary General issued a <u>toolkit</u> for governments across Europe on respecting human rights, democracy and the rule of law during the COVID-19 crisis. The Council of Europe, through its expertise and facilitation of exchange of good practices, continues to support Member States in addressing multiple issues arising from the need to tackle the spread of the virus.

The **objective** of the on-line round table is to provide a platform for a discussion among the stakeholders of the countries of the Western Balkans and Turkey on the challenges related to the COVID-19 pandemic, and to look at the issues from the human rights and the rule of law perspectives.

Participants: representatives of the Ministries of Justice, Government Agents before the European Court of Human Rights, Supreme Courts, Constitutional Courts, prosecutor general's offices, Ombudspersons, as well representatives of the Council of Europe Secretariat and the Registry of the European Court of Human Rights.

Countries: Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, Serbia and Turkey.
