Children and young persons, taking account of the rights and duties of their parents, have the care, the assistance, the education and the training they need, in particular by providing for the establishment or maintenance of institutions and services sufficient and adequate for this purpose

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO SOCIAL, LEGAL AND ECONOMIC PROTECTION

Protection and special aid from the state for children and young persons temporarily or definitively deprived of their family's support



Children and young persons a free primary and secondary education as well as to encourage regular attendance at schools

## THE RIGHT OF PERSONS WITH DISABILITIES TO INDEPENDENCE, SOCIAL INTEGRATION AND PARTICIPATION IN THE LIFE OF THE COMMUNITY

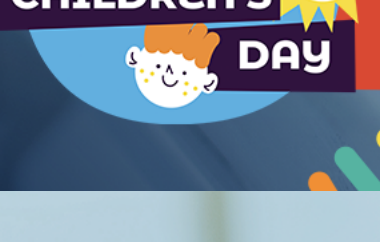
\* Article 15 European social charter



Persons with disabilities shall be provided with guidance, education and vocational training in the framework of general schemes wherever possible or, where this is not possible, through specialised bodies, public or private



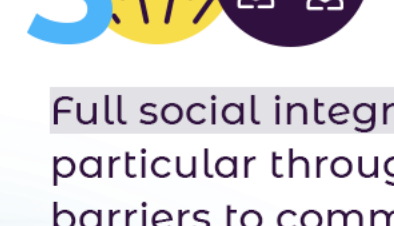
Access to employment through all measures tending to encourage employers to hire and keep in employment persons with disabilities in the ordinary working environment and to adjust the working conditions to the needs of the disabled shall be promoted

## THE RIGHT OF PERSONS WITH DISABILITIES TO INDEPENDENCE, SOCIAL INTEGRATION AND PARTICIPATION IN THE LIFE OF THE COMMUNITY

\* Article 15 European social charter



Full social integration and participation in the life of the community in particular through measures, including technical aids, aiming to overcome barriers to communication and mobility and enabling access to transport, housing, cultural activities and leisure shall be promoted

## THE RIGHT TO PROTECTION AGAINST POVERTY AND SOCIAL EXCLUSION

\* Article 30 European social charter



Measures shall be taken to promote the effective access of persons who live or risk living in a situation of social exclusion or poverty, as well as their families, to, in particular, employment, housing, training, education, culture and social and medical assistance



These measures shall be adapted if necessary

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

to provide that persons under 18 years of age employed in occupations prescribed by national laws or regulations shall be subject to

regular medical control

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

to ensure special protection

against physical and moral dangers to which children and young persons are exposed, and particularly against those resulting directly or indirectly from their work

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

\* Article 7 European Social Charter

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

15 years to provide that the minimum age of admission to employment shall be 15 years subject to exceptions for children employed in prescribed light work without harm to their health, morals or education

18 years to provide that the minimum age of admission to employment shall be 18 years with respect to prescribed occupations regarded as dangerous or unhealthy

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

\* Article 7 European Social Charter

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

SHALL NOT BE

to provide that persons who are still subject to compulsory education shall not be employed in such work as would deprive them of the full benefit of their education

limited working hours

to provide that the working hours of persons under 18 years of age shall be limited, and particularly with their need for vocational training

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

to recognise the right of young workers and apprentices to a fair wage or other appropriate allowances

time to provide that the time spent by young persons in vocational training during the normal working hours with the consent of the employer shall be treated as forming part of the working day

## THE RIGHT OF CHILDREN AND YOUNG PERSONS TO PROTECTION\*

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

to provide that employed persons of under 18 years of age shall be entitled to a minimum of four weeks' annual holiday with pay

With a view to ensuring the effective exercise of the right of children and young persons to protection, the Parties undertake

shall not be to provide that persons under 18 years of age shall not be employed in night work with the exception of certain occupations provided for by national laws or regulations
