The Council of Europe's [Twelve Principles of Good Democratic Governance](#) encapsulate fundamental values defining a common vision of democratic governance in Europe. The European Label of Governance Excellence (ELOGE) is awarded to local authorities who can demonstrate their respect of the 12 Principles measured against the relevant benchmark.

In 2019, the evaluations according to the 12 principles were conducted in France. This Conference, which is organised under the French Presidency of the Committee of Ministers of the Council of Europe, aims at presenting the results of ELOGE in France, share the experience of the French and European municipalities and promote good governance among all member states. The participants will include representatives of the French municipalities, the French National Centre for Local Civil Service (CNFPT) and other ELOGE-accredited organisations; municipalities and governments of about 20 other member states, the European Committee for Democracy and Governance, the Centre of Expertise for Good Governance, and the Parliamentary Assembly of the Council of Europe.
