# Dr. iur. INESE LĪBINA-EGNERE

Minister of Justice of the Republic of Latvia since 14 December 2022, Dr Lībina-Egnere has been elected in several previous convocations of the Parliament (Saeima) since 2011. She represents the "New Unity" Party and has been a Deputy Speaker of the Saeima, Chairperson of the National Security Committee, Member of the Legal Commission, Chairperson of the Judicial Policy Subcommittee of Legal Affairs Committee, and Head of the Latvian Delegation to the Parliamentary Assembly of the Council of Europe. Dr Lībina-Egnere holds a PhD in law and is Assistant Professor at the University of Latvia, Civil Law Department.

He represents the "National Alliance" party and was elected in the current convocation – the 14<sup>th</sup> Saeima, that started its work in 2022. Mr Puntulis holds a master's degree in opera singing and pedagogy from the Latvian Academy of Music. He has been a singer at the Latvian National Opera and "Perkons" rock band.




# Mr Matjaž Gruden

Matiaž Gruden is Director of Democratic Participation at the Council of Europe, and responsible for activities and programmes in the areas of education, including education for democratic citizenship. cooperation, and culture, nature and heritage. His Directorate also includes the Platform for the protection of Journalists, and the Eurimages film fund. Matjaž Gruden previously served as Director of Policy Planning, Deputy Director of the Private Office of the Secretary General, political adviser and speechwriter for the Secretary General and President of the Parliamentary Assembly of the Council of Europe. Prior to his career at the Council of Europe, he was a diplomat at the Slovenian Ministry of Foreign Affairs, posted in Brussels. He holds a law degree from the Law Faculty of the University of Ljubljana, as well as a post-graduate degree in EU law from the College of Europe in Bruges, Belgium.



## Ms Alexandra Xanthaki

Alexandra Xanthaki was appointed UN Special Rapporteur in the field of cultural rights in October 2021. Ms Xanthaki is Greek and lives in the United Kingdom where she works as a Professor of Laws at Brunel University London. # Uldis ZARIŅŠ

Uldis Zariņš has been Undersecretary of State at the Ministry of Culture of the Republic of Latvia since 2018, where he is responsible for development and implementation of cultural policy. He holds a master's degree in library and information science from the University of Latvia. Since 2009 he has worked in a number of different roles at the National Library of Latvia, particularly in the areas of digitisation and strategic development. 
# Ms Ruth GARCÍA ÁLVAREZ

She is Permanent Member of the United for Ukraine (U4U) platform. Since 24 February, 2022, as part of the women's parliamentary delegation, she has participated in a large number of diplomatic visits.



## Ms Kateryna Chuyeva

In September 2021, Ms Kateryna Chuyeva was appointed as Deputy Minister of Culture and Information Policy of Ukraine. Her portfolio as the Deputy Minister includes cultural heritage protection and museums. She graduated from the History Faculty of National Pedagogical Dragomanov University. ## Dr Pavlo PUSHKAR

Pavlo Pushkar is a Head of Division at the Department for the Execution of Judgments of the European Court of Human Rights of the Directorate General of Human Rights and the Rule of Law of the Council of Europe. The Department's mandate covers advice to the Committee of Ministers of the Council of Europe on its tasks of supervision over measures to be taken under the judgments of the European Court as well as advice to member states on measures that they intend to take or have taken to comply with the Strasbourg Court's judgments. His work also covers response to and accountability for gross and serious human rights violations. Dr Pushkar worked at the Registry of the European Court of Human Rights from 2002 to 2016 as a senior lawyer and a non-judicial rapporteur. Before joining the Council of Europe, he worked as an advocate in the areas of international litigation and arbitration and as a public servant at the Supreme Court of Ukraine. Dr Pushkar holds a Ph.D. in criminal justice. He is a graduate of Kyiv Taras Shevchenko University Law Faculty (BA and MA in Laws, with honours); the Nottingham University School of Law (LLM in International Law); Queen Mary College University of London (International Arbitration).



## Mr Isber SABRINE

Dr Isber Sabrine is a Syrian archaeologist, specialising in cultural heritage management during conflicts. Since 2011, he has been involved in projects and studies on the protection of cultural heritage during conflicts. He is currently chair and co-founder of the international NGO Heritage for Peace. Since 2015, he has been involved in cultural initiatives for refugees and immigrants in Europe. He is leading the Abuab Initiative, which is a social project that works on using cultural heritage as a tool for intercultural dialogue with refugees and immigrants from the Middle East and North Africa and Ukraine. He is the Founder and director of The Arab Network of Civil Society Organizations to Safeguard Cultural Heritage (ANSCH).




## Dr Cristina GUISASOLA

Dr Guisasola's main line of research, which began with her doctoral thesis entitled "Crimes against cultural property", published in 2001, has been dedicated to the analysis of criminal protection of cultural property, both in the Spanish legal system and in comparative law systems. Since then, she has not abandoned this line of research, delving deeper into it through R&D projects. Specifically, she has been PI for three research projects, one of them financed by the Ministry of Economy, Industry and Competitiveness under the title "Criminal protection of nature and cultural assets", published in Tirant lo Blanch as a monograph in 2020 under the title "Protection of cultural assets. A cosmopolitan vision from criminal law, criminology and international law".



# Mr Mārcis KALNIŅŠ

Mārcis Kalniņš is an expert-archaeologist at the Department for Circulation of Cultural Goods of the National Heritage Board of Latvia, and a researcher and a PhD candidate at the Faculty of History and Philosophy of the University of Latvia. He has been working in the field of archaeology for more than 20 years and currently is the head of the board of the Latvian Association of Archaeologists and a member of the European Association of Archaeologists and ICOMOS Latvia. Mārcis has led research in different period archaeological sites and has been participating in international and Latvian-wide projects dedicated to the research and preservation of archaeological sites and cultural heritage.



## Mr Maurizio PELLEGRINI

Photojournalist in the 70s/80s, and the only Italian photographer in Iran during the 1979 revolution. Officer of the Ministry of Heritage and Cultural Activities till 2018. For the past 20 years director archaeologist at the Superintendence of Southern Etruria and at the Etruscan Museum of Villa Giulia in Rome, responsible for the "Educational Laboratory and Visual Promotion" and part of the "Seizures and Clandestine Excavations Office". Consultant to the Attorney General of Rome regarding the clandestine market of archaeological finds and Member of the Committee for Issues Relating to the Exercise of Action for the Restitution of Cultural Assets. Professor of forensic archaeology for crimes against cultural heritage. archaeological documentary, audiovisual documentations technique, museology and archaeological communication.



## Ms Daniela RIZZO

Officer of the Ministry of Heritage and Cultural Activities from 1979 to 2017 at the Superintendence of Southern Etruria and at the Etruscan Museum of Villa Giulia in Rome dealing with protection and research within the Etruscan territory. From 1984 onwards, Head of "Seizures and Clandestine Excavations Office" taking care in particular of the circulation of archaeological assets at national and international level. Consultant to the Attorney General of Rome regarding the clandestine market of archaeological finds. Member of the Committee for Issues Relating to the Exercise of Action for the Restitution of Cultural Assets of the Ministry of Heritage and professor and speaker on forensic archaeology for crimes against cultural heritage.



## Dr Marina SOLOMIDOU-IERONYMIDOU

Director of the Department of Antiquities since 2014. Member of the Department of Antiquities since 1986, PhD with honours in Medieval Archaeology from Sorbonne University (Paris I) since 2001. President of the National Committee for the Combating of Looting and the Illicit Trafficking of Cultural Heritage since 2020. Contributed to identifying and repatriating some of the most important cultural objects illegally exported from Cyprus. Member of the Cyprus National Committee for UNESCO and the National Committees of ICOM and

ICOMOS. Member of the board of the ICCM. National Focal Point for the Cypriot World Heritage Sites of UNESCO. Author of more than 40 scientific publications on matters of Cypriot archaeology.



## Dr Arianna TRAVIGLIA

Dr Arianna Traviglia is the Director of the Centre for Cultural Heritage Technology (CCHT), part of the Italian Institute of Technology (IIT). Dr Traviglia's work is the intersection of technology placed at humanities and most of her research focuses on mediating the inclusion of digital practices within the study, protection and management of cultural heritage. At CHTT she supervises research in the areas of Artificial Intelligence Computer (AI), Nanotechnologies, and Robotics applied to numerous aspects of heritage. She also acts as Expert Collaborator for the Committee for Culture, Heritage and Landscape (CDCPP) of the Council of Europe and sits as chair of the Technical-Scientific Committee of the Cassa Depositi e Prestiti (CDP) Foundation set up to contribute to Italy's social, cultural, environmental and economic development.



## Ms Angela BARDENHEWER-RATING

Angela is a Senior Legal Officer at the European Commission, DG JUST - Criminal Justice. International relations of judicial cooperation in criminal matters are her responsibilities (negotiations among International Agreements between third countries and the EU on judicial cooperation with Eurojust). She coordinates EU Security Union, Countering Terrorism and Council of Europe related areas. She also deals with Organised Crime related topics such as the fight against trafficking in cultural goods. She has previous experience at Fusion for Energy (F4E), an EU Joint Undertaking. corporate legal matters. includina compliance and governance, and Data Protection Officer. Before joining F4E in 2007, she already worked for the European Commission: Since 1999, she has advised three different Commissioners as member of their respective cabinets. In 1997, she joined the Commission's Directorate General for Competition as policy advisor, after having served since 1995 as member of the Task Force for institutional questions (Intergovernmental Conference) negotiating the EU Amsterdam Treaty. She started her career in 1992 in the European Commission as member of its Legal Service



and represented the Commission in various cases before the European Court of Justice. By training, she is a German lawyer with the qualification to be a judge.

#### Mr Cameron WALTER

Cameron Walter is the OSCE Program Manager for Combatting Trafficking in Cultural Property and Head of the Heritage Crime Task Force since 2020. He was a member of the initial OSCE Task Force for Combatting Trafficking of Cultural Heritage since 2017, with missions to Cyprus, Montenegro, Italy and Mongolia. Since joining permanently, the Task Force has coordinated operations, intelligence and capacity building with over 40 of the 57 OSCE participating Partners for Cooperation and assisted States. investigations/operations/training with external partners in the Middle East, Sub-saharan Africa and Latin America, related to networks and cases with a clear linkage to the OSCE Area. Cameron began his career with the Government of Canada in 2005, following graduation from the University of Victoria with an Honours Degree in Political Science (International Relations) and History (Decolonization Development). He joined Canada Border Services in 2007 as lead on International Relations for Europe, Africa and Middle East, focused on supply chain security, counter-terrorism, customs intelligence and trade facilitation. He also participated in numerous operations with WCO targeting heritage trafficking networks. Cameron transferred in 2017 to Canadian Deputy Director of International Heritage as Partnerships, where he coordinated efforts to expand Canada's global creative industries trade while also building international partnerships to combat trafficking of cultural property.

She is the author of the Explanatory Report of the 1995 Convention and several articles on the Convention and more generally on illicit trafficking in cultural property and synergies between relevant international instruments.
