#### **CONCEPT NOTE**

#### **Background and Objectives of the International event**

Crimes against cultural property are a global concern that require equally global solutions. The alienation and destruction of heritage objects affect everyone, insofar as cultural assets are not only the legacy of each country, but also of humanity as a whole.

Therefore, it is urgent to address this worrying situation, given the proven links between crimes against cultural property, organised crime and terrorism. Controlling the entire criminal chain, from looting to the illicit flow of cultural heritage across borders, requires a high level of cooperation between all states and actors involved. Consequently, joint efforts must be made to establish mechanisms through which countries can share information, learn from each other's best practices and achieve better coordination of law enforcement to prevent and combat these crimes.

In 2017, the Council of Europe opened for signature the **Convention on Offences relating to Cultural Property**, known as the **Nicosia Convention**, which entered into force on 1 April 2022. To date, six countries have ratified the Convention<sup>1</sup> and seven others have signed it<sup>2</sup>. This criminal law treaty is the only legally binding instrument aimed at preventing and combating such crimes by strengthening criminal justice responses while promoting international cooperation.

Furthermore, the high-level meeting of Heads of State and Government of the Council of Europe, held in 2023 in Reykjavik, included in its <u>Declaration</u> considerations closely related to the Nicosia Convention: **the protection of cultural heritage**, the right of children to enjoy their own culture and the fight against organised crime<sup>3</sup>. Additionally, in 2024 the 70th anniversary of the <u>European Cultural Convention</u> of the Council of Europe is being celebrated, a cultural pillar aimed at safeguarding the common cultural heritage of Europe and promoting dialogue and mutual understanding.

As established by the Nicosia Convention, the exchange of information on the topics covered by the Convention is essential to achieve its objectives. In this context, and as a result of the spirit of mutual collaboration, the Council of Europe is organising an international seminar to be held on 20-21 June 2024 in Zaragoza, Spain, both addressed to all actors, at regional, national and international level, concerned with the Nicosia convention and aimed at gathering the contact points of the Nicosia Convention.

This international meeting will discuss the priority lines of work of the Nicosia Convention that may be developed in the near future to both set the basis of the work of the future Committee

of the Parties and advance in the implementation of the Convention. With this joint work, participants will have the opportunity to strengthen their national and international co-operation networks and thus increase the level of protection of world cultural heritage.

#### Aims of the International seminar

The objective of this event is to advance the fight against crimes related to cultural property by promoting the Nicosia Convention and to showcase the work that countries are carrying out to protect their cultural heritage from crimes covered by the Nicosia Convention. The main objectives are the following:

- Encourage States to sign and ratify the Nicosia Convention.
- ❖ Know the policies and practical actions that are being developed in this matter in the light of the Nicosia Convention.
- \* Raise awareness among criminal law, law-enforcement and cultural actors, NGOs, and professionals working in the field.
- ❖ Consider the added value of the Convention, as well as the challenges posed by its ratification.
- ❖ Highlight the importance of international cooperation to combat emerging challenges in this area.
- Provide a platform for the exchange of experiences and knowledge.
- ❖ Facilitate and strengthen national cooperation and synergies in the protection and preservation of cultural assets.

The target audience of the international seminar includes experts from the justice, law enforcement and the cultural sectors, as well as members of academic institutions and other actors related to the topic of the seminar.
